

1 Introduction

Purpose of the report

Dún Laoghaire-Rathdown County Council has prepared a Draft Climate Action Plan 2024-2029. The Draft Plan sets out mitigation, adaptation and other climate action measures, to create a low carbon and climate resilient County. This is aligned to the Government's overall National Climate Objective, which seeks to pursue and achieve, by no later than the end of 2050, the transition to a climate resilient, biodiversity rich, environmentally sustainable and climate neutral economy.

The Draft Plan includes a range of actions across the six thematic areas of Energy and Buildings, Transport, Flood Resilience, Nature Based Solutions, Circular Economy and Resource Management and Community Engagement.

Pursuant to the Climate Action and Low Carbon Development Act 2015 as amended by Section 16 of the Climate Action and Low Carbon Development (Amendment) Act 2021 (referred to from hereon in as the Act), notice of the preparation of the Dún Laoghaire-Rathdown County Council Draft Climate Action Plan 2024-2029, was given on Wednesday 20th September 2023. Submissions or observations regarding the Draft Plan and Environmental Reports (Strategic Environmental Assessment and Appropriate Assessment) were invited for a period of just over 6 weeks, from Wednesday 20th September 2023 to Friday 3rd November 2023, inclusive.

In accordance with the requirements of the Act, this Chief Executive's Report summarises and details the outcome of the Public Consultation process on the Draft Climate Action Plan, as follows:

- summarises the issues raised by the persons, organisations and bodies in the submissions or observations;
- gives the responses and recommendations of the Chief Executive to the issues raised; and
- outlines any proposed modifications to the Draft Plan on foot of the Public Consultation process.

At the 12 February, 2024, County Council meeting the Elected Members consider this Chief Executive's Report, pursuant to the Climate Action and Low Carbon Development Act 2015 as amended by Section 16 of the Climate Action and Low Carbon Development (Amendment) Act 2021 and decide by resolution, whether to:

- approve, or
- approve, subject to such non-material modifications as they consider appropriate, the local authority climate action plan.

The Minister for the Environment, Climate and Communications formally instructed local authorities on 24th February 2023 to commence work on their Climate Action Plans and have them adopted within 12 months of that instruction. Therefore, the last date for approval of the dlr Climate Action Plan 2024-2029 is 23rd February 2024.

Within thirty (30) days of the approval of the final local authority Climate Action Plan by the Elected Members the Council will publish the final Plan. The Climate Action Plan shall have effect for a period of five years from the date on which it is approved by the Elected Members.

Strategic Environmental Assessment (SEA) and Appropriate Assessment (AA)

An Environmental Report accompanies the Draft Climate Action Plan. The Environmental Report contains a detailed analysis of the Draft Climate Action Plan and how the implementation of the Plan would impact on its receiving environment. The Chief Executive's recommendations as set out in this report (including recommendations on the

Environmental Authorities submissions detailed in Section 6), have been assessed to determine whether they would have any significant impact on the environment. Taking into account the mitigation measures which have already been integrated into the Draft Plan, it is considered that the modifications proposed on foot of recommendations in this Chief Executive's Report will not have any significant adverse effect on the environment.

In accordance with requirements under Article 6 of the EU Habitats Directive (92/43/EEC), the Draft Climate Action Plan and modifications proposed on foot of this Chief Executive's Report have been screened to assess whether they would have a significant effect on one or more Natura 2000 sites. It is considered that the Draft Plan and modifications proposed on foot of the Chief Executive's recommendations, alone and in combination with other plans and projects, will not have any significant effect on any Natura 2000 sites.

The Elected Members shall give approval for the Draft Climate Action Plan only after it been determined that the Draft Plan shall not adversely affect the integrity of a European Site(s) in line with SI 477 (EU Birds and Natural Habitats) Regulations 2011, as amended.

Background to the Draft Climate Action Plan

The Act specifically requires all local authorities in Ireland to prepare and approve a Climate Action Plan, in consideration of wider national climate and energy targets, addressing both mitigation and adaptation measures. This is aligned to the Government's overall National Climate Objective, which seeks to pursue and achieve, by no later than the end of 2050, the transition to a climate resilient, biodiversity rich, environmentally sustainable and climate neutral economy. The Plan must demonstrate a coherent approach to climate action across the administrative and political structure of the local authority.

The Draft Plan sets a clear pathway for Dún Laoghaire-Rathdown County Council to:


- actively translate national climate policy to local circumstances with the prioritisation and acceleration of evidence-based measures;
- assist in the delivery of the climate neutrality objective at local and community levels; and
- identify and deliver a Decarbonising Zone (DZ) within the local authority area to act as a test bed for a range of climate mitigation, adaptation and biodiversity measures in a specifically defined area, through the identification of projects and outcomes that will assist in the delivery of the National Climate Objective.

The Draft Plan has been prepared in accordance with the Local Authority Climate Action Plan Guidelines, developed in response to Section 16 of the Act. The Guidelines aim to support local authorities in both the content and preparation of their Local Authority Climate Action Plans. The Guidelines were issued by the Department of Environment, Climate, and Communications in March 2023.

The Draft Plan sets out how Dún Laoghaire-Rathdown County Council will be responsible for:

- enhancing climate resilience,
- increasing energy efficiency and
- reducing greenhouse gas emissions, across its own assets, services and infrastructure, to which it is fully accountable for, whilst also demonstrating a broader role of influencing, co-ordinating and

broader role of influencing, co-ordinating and facilitating and advocating for other sectors, to meet their own climate targets and ambitions.



This is necessary to ensure that the environmental, social and economic benefits that come with climate action can be fully realised. The Council will also continue its efforts in rolling out ambitious climate action projects, drawing down available sources of funding, pursuing community and stakeholder engagement, all supported by a progressive policy framework.

2 The public consultation process

2.1 Outline of the public consultation process

In accordance with the provisions of Section 16 of the Act, the Draft Climate Action Plan underwent statutory public consultation, from Wednesday September 20th, 2023 to Friday November 3rd, 2023 inclusive.

The Act states, that in making the local authority climate action plan, a local authority shall:

- (a) consult and co-operate with adjoining local authorities;
- (b) consult with the Public Participation Network in the administrative area of the local authority and such other persons as the local authority considers appropriate;
- (c) co-ordinate, where appropriate, with adjoining local authorities in relation to the mitigation measures and adaptation measures to be adopted;
- (d) consider any significant effects the implementation of the local authority climate action plan may have on adjoining local authorities; and
- (e) consider any submissions made to it by an adjoining local authority.

The Act also states that a local authority shall, before making a local authority climate action plan:

- (a) publish, in such manner as the local authority considers appropriate, a draft of the proposed local authority climate action plan,
- (b) publish a notice on the internet and in at least one newspaper circulating in the administrative area of the local authority inviting members of the public and any interested parties to make submissions in writing in relation to the proposed local authority climate action plan within such period (not exceeding two months from the date of the publication of the notice) as may be specified in the notice, and
- (c) have regard to any submissions made pursuant to, and in accordance with, a notice under paragraph (b).

2.2 Key elements of the public consultation process

The Draft Climate Action Plan public consultation process involved the following key elements:

Print Media and Website

On Wednesday, 20th September 2023, a press release was issued by the Communications Office detailing the publication of the Draft Plan.

The publication of the Draft Climate Action Plan 2024-2029 was advertised on Wednesday, 20th September 2023, in the Irish Times and on Thursday, 21st September 2023, in the Dublin Gazette. The notice, published in Irish and English gave all the necessary details of the publication of the Draft Plan and the methods by which members of the public could make submissions or attend consultation events and is provided in Appendix B. This fulfilled the Council's obligations under the Act. In addition, the Dublin Gazette ran an editorial piece on Friday, 29th September, 2023 highlighting the publication of the Draft Plan and the methods and deadlines by which the public could make a submission.

The Autumn edition of the dlr times featured details of the Draft Plan and guidance on how the public could make a submission via the public consultation portal hosted on the dlr website.

Radio

Radio Advertising was co-ordinated across the four Dublin Local Authorities with a total of 588 advertisements played on NewsTalk, FM104, Radio Na Life, Q102 and Spin103 from the October 14th, 2023, to October 28th, 2023, aired 42 times per day. In addition, the dlr Climate Co-ordinator participated in a radio interview on Wednesday, 10th October, 2023,

which was aired on Dublin South FM and gave details of the Draft Plan and information on how and when the public could provide their views on it.

dlr Website

The dlr website hosted the Draft Plan throughout the public consultation process as well as all the associated background information.

Social Media

Throughout the public consultation period dlr published 69 posts promoting the Draft Plan and encouraging the public to submit their views on it. The result of the post created a total of 46,334 impressions, 408 engagements with Engagement Rate (per Impression) of 0.9%. The posts were issued across dlr's social media platforms Facebook, X and Instagram.




Figure 1 Social Media Top Tagged Published Posts




Figure 2 Published Posts Impressions

Public Participation Network

The Public Participation Network (PPN) was notified about the publication of the Draft Plan and provided with details of the associated press release to enable the PPN to publicise it to their mailing list.

Adjoining Local Authority Engagement

All bordering local authorities as well as Fingal County Council were notified about the publication of the Draft Plan.

Prescribed Bodies Engagement

Statutory consultees were notified about the publication of the Draft Plan on Wednesday, 20th September, 2023. These are Environmental Protection Agency (EPA), Department of Environment Climate and Communications (DECC), Department of Agriculture, Food and the Marine and the National Parks and Wildlife Service.

Elected Member Briefings

- Wednesday, July 12th Councillors briefing on the Draft Plan
- Tuesday, July 25th Second Councillors briefing on the Draft Plan
- Monday, September 11th briefing on the Draft Plan at the Council Meeting
- Thursday September 21st briefing to the Environment and Climate Action Strategic Policy Committee
- Wednesday, December 6th briefing to the Environment and Climate Action Strategic Policy Committee

2.3 Public information events

During the public consultation period, Public Information Events took place as follows:

- Tuesday, 3rd October Parish Pastoral Centre, Dundrum
- Tuesday, 10th October Assembly Hall, County Hall, Dun Laoghaire
- Tuesday, 17th October Round Room, Mansion House joint event for four Dublin Local Authorities.

In addition to the above, the Draft Plan was on display at all dlr libraries throughout the consultation period. The Parish Pastoral Centre in Dundrum, prior to hosting the event on 3^{rd} October, advertised the event in the Parish Pastoral Centre's newsletter and announced details of the event at Masses for the two weekends prior to the event.

2.4 Other engagement with stakeholders' groups

Further engagement on the Draft Plan was undertaken through several meetings and presentations to other stakeholders as outlined below.

- Wednesday, 27th September with staff and students in Holy Child Secondary School, Killiney.
- Friday, 29th September Let's Talk Climate Free Event supported by Age Friendly Ireland & CARO (Climate Action Regional Offices) in County Hall.
- Thursday, 19th October with staff and students in the Village Hub on the University College Dublin (UCD) campus.
- Saturday, 21st October dlr libraries' Climate Day (as part of the Mountains to Sea book festival) in dlr Lexicon Library, Dun Laoghaire.
- Monday, 23rd October with staff and students on the Institute of Art, Design and Technology (IADT) campus.
- Thursday, 2nd November with Comhairle na nÓg members in County Hall.

As part of the engagement with IADT and Comhairle na nÓg, the climate team used interactive presentations to capture some of the concerns of the participants the results of which are presented in the figures below.




Figure 4 UCD Word Cloud | Group 1

3 Details of the submissions

3.1 Introduction

A total of 61 valid submissions and observations were received, the breakdown of which is presented in Table 1.

All valid submissions and observations were read, analysed and summarised. An overview of issues raised is provided in Section 3.3. The categorisation and summary of issues raised, and the Chief Executive's (CE) responses and recommendations, are contained in Section 5.

Two invalid submissions were received after the statutory public consultation deadline of Friday, 3rd November, 2023. One of these submissions was received from the Department of Agriculture, Food and the Marine. The general contents of these submissions are noted.

3.2 List of submissions

The privacy statement for the dlr Climate Action Plan public consultation process stated the names of submitters would not be made public either in the Chief Executive's report or on the Council's website. The Appendix 1 provides the list of unique identifier reference codes for those that made an online submission. Submissions made by email are noted as email. All submissions listed below have been examined, considered and discussed in the body of the Chief Executive's report. There were no submissions by post.

3.3 Summary of issues raised in submissions

A total of 192 issues were identified from the 61 submissions and observations received. Summaries of all the issues raised in the submissions and observations are set out in Section 5, together with the responses and recommendations of the Chief Executive. Issues have been summarised under the relevant chapter, subsection or appendix heading in Section 5 of this report.

Table 2 below sets out the number and percentage of issues that were raised according to the relevant chapter, subsection or appendix heading of the Draft Climate Action Plan.

3.4 Chief Executive's responses and recommendations

The Chief Executive has prepared responses and recommendations under the relevant Section/Submission heading of the Draft Climate Action Plan. The listing and format of the categorisation, summary and responses to issues raised follows the document structure of the Draft Climate Action Plan.

This Chief Executive's report examines issues raised in the submissions and observations in the context of their relevance to the purpose and scope of the Draft Climate Action Plan. It seeks to incorporate new/additional provisions where they are relevant to the purpose of the Draft Plan and its implementation and do not have a negative impact on the broader environmental considerations of the county.

In the interests of clarity, issues raised in the submissions and observations that:

- do not sit within the scope of the Draft Climate Action Plan;
- go beyond its scope but lie within the scope of the local authority;
- go beyond the functions of the local authority; and/or
- are not directly related to the provisions of the Draft Plan or climate actions,

will be subject to general commentary where appropriate and may not be considered further to help inform the provisions or actions of the final Climate Action Plan.

Among the issues specifically not addressed, commented on or responded to in this report, include matters relating to planning applications, development sites or specific local

authority projects undertaken, or matters confined by legislation. Such matters are best addressed under the various planning processes including development management, forward planning, etc. Matters that are considered helpful to frame future policy will be considered where such considerations do not undermine the integrity of the functions and processes stated above.

3.5 Structure of Proposed Modifications to the Draft Plan

Amendments to the text of the Draft Climate Action Plan are identified by their location within each chapter of the Draft Plan.

As stated in Section 3.4.2 of the Local Authority Climate Action Plan Guidelines, 'a modification in this instance is an alteration that is considered non-material and does not compromise the integrity of the plan-making process to that point or the SEA and AA processes that have informed the plan' (Government of Ireland, 2023).

Furthermore, given the statutory twelve (12) month duration of the Draft Plan making process, as set out in Section 16 of the Act, a Material Amendment public consultation phase is not provided for under the legislation.

8 Conclusions

Within thirty (30) days of the approval of the final local authority Climate Action Plan by the Elected Members, the Council will publish the final Plan. The Climate Action Plan shall have effect for a period of five years from the date on which it is approved by the Elected Members.

In accordance with the Climate Action and Low Carbon Development Act 2015 and as amended by Section 16 of the Climate Action and Low Carbon Development (Amendment) Act 2021 and having considered the Draft Climate Action Plan 2024-2029 and the Chief Executive's Report on Submissions Received, this Council hereby resolves to APPROVE and ADOPT the Dún Laoghaire-Rathdown County Council Draft Climate Action Plan 2024-2029.

A screening determination for the need for Strategic Environmental Assessment (SEA) has been made by Dún Laoghaire-Rathdown County Council for the Modifications to the Draft Plan, under Directive 2001/42/EC. The screening assessment was carried out using the criteria for determining the likely significance of effects as set out in Schedule 1 of S.I. 435/2004, as amended. Following assessment of the criteria and having regard to the nature of the Modifications to the Draft Plan and the potential for likely significant environmental effects associated with the Modifications, Dún Laoghaire-Rathdown County Council has concluded that the Modifications to the Draft Plan, will not give rise to likely significant effects on the environment.

Article 6(3) of the Habitats Directive, as transposed by S.I. No. 477/2011, as amended, requires that a final determination is made as to whether a plan or project would adversely affect the integrity of a European site. SEA Screening Conclusion and Determination

Modifications to the Draft Local Authority Climate Action Plan 2024 - 2029 for the Dun Laoghaire-Rathdown County Council functional area

Strategic Environmental Assessment Screening Determination under SEA Directive 2001/42/EC as transposed into Irish law under the European Communities (Environmental Assessment of Certain Plans and Programmes) Regulations 2004 (S.I. 435/2004), as amended

Dún Laoghaire-Rathdown County Council has prepared a Draft Local Authority Climate Action Plan (LACAP) for the Dun Laoghaire-Rathdown County Council functional area for the years 2024 - 2029 under Section 16 of the Climate Action and Low Carbon Development (Amendment) Act 2021,

A screening determination for the need for Strategic Environmental Assessment (SEA) has been made by D'un Laoghaire-Rathdown County Council for the Modifications to the Draft LACAP under Directive 2001/42/EC. The screening assessment was carried out using the criteria for determining the likely significance of effects as set out in Schedule 1 of S.I. 435/2004, as amended.

The Modifications to the Draft LACAP have been made following a review of the issues raised during the prescribed public consultation period for the Draft LACAP from Wednesday 22nd September 2023 to Friday 3rd November 2023 and subsequent consideration by Durí Laoghaire-Rathdown County Council.

The Draft LACAP has been informed by a SEA and an SEA Environmental Report has been prepared outlining the likely environmental effects of the Plan in accordance with the SEA Directive 2001/42/EC. Measures have been integrated into the Draft LACAP that provide for and contribute towards environmental protection, environmental management and sustainable development.

Following assessment of the criteria and having regard to the nature of the Modifications to the Draft LACAP and the potential for likely significant environmental effects associated with the Modifications, Dun Laoghaire-Rathdown County Council has concluded that the Modifications to the Draft LACAP will not give rise to likely significant effects on the environment.

This determination has been made following consideration of the information contained in an SEA Screening Report for the Modifications to the Draft LACAP, and the criteria set out in Schedule 1 to S.I. 435/2004, as amended. The principal reasons the Modifications to the Draft LACAP will not give rise to likely significant effects on the environment are as follows:

- The modifications are only intended to provide clarification on existing Climate Actions defined in the Draft LACAP and make the LACAP more operative and focussed.
- The modification are not material and will not result in any additional, likely significant environmental effects not already considered in the SEA Environmental Report for the Draft LACAP.

Taking account of the above, it is determined that full SEA is not required to be undertaken for the Modifications to the Draft LACAP.

An SEA Statement will be prepared following adoption of the LACAP, which will detail the SEA process undertaken for the LACAP.

Dún Laoghaire-Rathdown County Council has prepared a Draft Local Authority Climate Action Plan (LACAP) for the Dún Laoghaire-Rathdown County Council functional area for the years 2024 – 2029 under Section 16 of the Climate Action and Low Carbon Development (Amendment) Act 2021.

A screening determination for the need for Appropriate Assessment (AA) has been made by the Council in respect of the Modifications to the Draft Local Authority Climate Action Plan in accordance with the requirements of Article 6(3) of the Directive 92/43/EEC (Habitats Directives) and Regulation 42(1) of the European Communities (Birds and Natural Habitats) Regulations 2011 (as amended).

The Modifications to the Draft LACAP have been made following a review of the issues raised during the prescribed public consultation period for the Draft LACAP from Wednesday 22nd September 2023 to Friday 3rd November 2023 and subsequent consideration by Dun Laoghaire-Rathdown County Council.

The Draft LACAP has been informed by an AA and a Natura Impact Report has been prepared outlining the likely environmental effects of the Plan on European sites in accordance with the Habitats Directive 92/43/EEC. Measures have been integrated into the Draft Plan that mitigate its potential effects on any European site.

Following assessment and having regard to the nature of the Modifications to the Draft LACAP and the potential for likely significant environmental effects associated with the Modifications, Dún Laoghaire-Rathdown County Council has concluded, in view of best scientific knowledge and in view of conservation objectives, that the Modifications to the Draft LACAP will not give rise to any likely significant effects on designated European sites, alone or in combination with other plans or projects.

This determination has been made following consideration of the information contained in an AA Screening Report for the Modifications to the Draft LACAP. The principal reason the Modifications to the Draft LACAP do will not give rise to any likely significant effects on designated European sites, alone or in combination with other plans or projects, are as follows:

 The modification are not material and will not result in any additional, likely significant environmental effects, including effects on ecological processes or European sites, not already considered in the NIR for the Draft LACAP. Taking account of the above, it is determined that full AA is not required to be undertaken for the modifications to the Draft Local Authority Climate Action Plan 2024 – 2029.

An AA Conclusion Statement will be prepared following adoption of the Plan, which will detail the AA process undertaken for the Plan.
