Welcome and Introductions

Minutes and matters arising

The minutes of the public meeting held on the 24th May 2022 were proposed by Deputy Devlin, seconded by Cllr Grainger and agreed by the committee. Update on DLR Road Safety Plan 2022 - 2030

Gerry Flaherty, Senior Executive Engineer, Traffic and Road Safety Section, gave a brief presentation on the DLR Road Safety Plan 2022 - 2030 noting its background in national road safety strategy and Vision Zero. It was noted that a public consultation was held over the summer. The road safety targets were noted and it was also noted that the road safety working group was well attended by various groups including the Garda and the HSE. It was noted that consultants are looking at a methodology of reducing speed in coordination with the Garda and the RSA.

Following the presentation, a brief discussion took place during which Gerry Flaherty and Therese Langan responded to queries raised, including Councillor representation on the Road Safety group and road safety education for motorists.

DLR Joint Policing Committee Workplan 2022 Updates

Therese Langan gave a presentation on the progress of the workplan under the three goals below.

Following the presentation, a brief discussion took place during which Therese Langan responded to queries.

Update on current Policing Issues

Chief Superintendent Matthew Nyland introduced Superintendent Fergal Harrington, the recently appointed Superintendent for the Dún Laoghaire district. CS Nyland gave a presentation which included the following areas:

Therese Langan gave an update on the Domestic Violence Refuge for DLR. It was noted that the Department of Justice had given approval for ten units in the County. It was agreed that the Domestic Violence Refuge would remain on the Committee agenda as a standing item.
