  - Irish citizens.
  - EU citizens who were registered to vote in Ireland at European elections since 1994.
- 2. There are three parts of this form to be completed:
  - Your details: your local authority needs some personal data (including your name, address, date of birth, PPSN and nationality) to process your application to register as a European elector. Providing your PPSN will allow a basic check to help confirm your identity details and help to protect the integrity of the register.
  - Additional information required by your home Member State: specific information required for your home Member State is set out in the table on pages 5-7 and should be included in part 2 of this application.
  - Statutory declaration: this will need to be completed by you in the presence of one of the witnesses listed at 3.
- 3. The completed form should be returned to the local authority for your area.
- 4. The information contained in this form will be forwarded to your home Member State to guard against double voting at the European elections.
- 5. A person who votes at a European election in Ireland and in another Member State is guilty of an offence and is liable on conviction to a fine not exceeding €3,174.35 or imprisonment for a term not exceeding two years or both.
- 6. A person who knowingly makes a false or misleading statutory declaration is liable on conviction to the penalty set out for such an offence at the time the offence was committed.
