





The Ballyogan Regional Temporary Rest Centre opened its doors to Ukrainian nationals on 28 April.

Significant work has been undertaken by regional agencies, led by Dún Laoghaire-Rathdown County Council, to provide temporary accommodation facilities, managed by a dedicated site supervisor overseeing an extensive facilities team, as well as catering, security and cleaning details, all operating on a 24-hour basis.

The Ballyogan Regional Temporary Rest Centre can accommodate up to 300 displaced Ukrainian nationals for short periods. Thereafter they will be allocated longer term accommodation in other areas of the state.

As part of a comprehensive wrap around service, accommodation services at the Centre are being supported by HSE staff including Environmental Health, Public Health and COVID-19 services. The HSE is providing onsite support to meet the healthcare needs of Ukrainian residents, and residents also have access to an offsite GP service 7 days a week.

Among the facilities available in the temporary rest centre is separate laundry and sanitary facilities, internet access, television spaces, games consoles, games room, chessboards, use of bikes and scooters, libraries of Ukrainian books for children and adults, translation services, as well as online access to Ukrainian newspapers and magazines.

Additionally, orientation and information sessions, basic English language lessons and an arts and music entertainment programme is being developed both onsite and nearby offsite.

Local coordination efforts to develop as safe and as comprehensive support services as possible include Southside Partnership, HSE, An Garda Siochána, Department of Social Protection, dlr Education and Training Board, TUSLA, Community and Family Resource Centres, dlr Volunteers Centre, colleagues in the East Region and a number of other community and voluntary groups.

Bus Connects

The Core Bus Corridors Schemes' (CBCs) statutory applications are now being progressed by the NTA for formal submission to An Bord Pleanala for planning permission. The Blackrock to City Centre Core Bus Corridor Scheme (CBC 15) was the second formal application to ABP and the 8 week statutory public consultation period for this development closed on Tuesday July 12th 2022. All planning documentation is available at: https://belfieldblackrockscheme.ie/ The Traffic Section, with cross departmental input, made a submission to ABP with respect to the proposed CBC.

The NTA have advised that the submission of the Bray to City Centre CBC planning application to ABP is planned for Q4 of this year (2022).

The submission of the CBC planning applications to ABP triggers a formal statutory public consultation process in respect of each of the stand-alone Core Bus Corridor schemes, with submissions made directly to An Bord Pleanála for their consideration. During this process, the finalised Environmental Impact Assessment Reports, inclusive of traffic impact analyses, will be published and available for inspection (including online) and purchase. The public will then have the formal opportunity to have their views heard and considered by An Bord Pleanála as part of the statutory consultation process to inform An Bord Pleanála's assessment of each of the stand-alone Core Bus Corridor schemes.

Dundrum ABTA - Area Based Transport Assessment

Work on this project is progressing and the ABTAs Stages 1 & 2 now completed with work on Stage 3 – Options Assessment & Development, now at an advanced stage.

Bus Interchanges at Dundrum, Dun Laoghaire & Blackrock

Discussions are ongoing with the NTA regarding bus interchange improvements at both Dundrum and Dun Laoghaire. The improvements are needed to cater for the planned service increases under the BusConnects' programme. Meetings/workshops are ongoing to progress this work and a multi-disciplinary group from the Council is in place to assist. In addition, discussions have also commenced with the NTA regarding potential public realm improvements in Blackrock and the impact these may have on the existing bus interchange and bus services.

Old Conna ABTA - Area Based Transport Assessment

Following discussions with the NTA, it has been agreed that the Old Conna ABTA study, commenced in 2019 and on hold since 2020, should not be completed due to outdated policy and context. It is anticipated that a new ABTA study based on updated policy and strategic context will be required.

Racecourse South ABTA - Area Based Transport Assessment

Discussions have commenced with the Land Development Agency, the NTA and TII on the preparation of an Area Based Transport Assessment (ABTA) for the Racecourse South lands at Carrickmines, in accordance with the requirements of SLO 143 in the current County Development Plan.



New Bus Stops to Serve Planned BusConnects Orbital Bus Services

The Traffic Section has been liaising with the NTA on the location and design of new bus stops throughout the county, required to support planned new bus services being introduced by the NTA over the next two years. It is anticipated that bus stop approval notices for the new stops will be issued to the NTA in Q3 of this year.

3. Water & Drainage

Drainage and Flood Alleviation

Engineering and Environmental Consultants were appointed in December 2019 for Flood Risk Management works on the **Deansgrange Stream**. This is a 4-to-5-year project. Activities completed to date include additional survey work, CCTV surveys, a Constraints Study, Hydrological analysis, and hydraulic modelling. Initial Public Consultation is now complete. Optioneering, environmental surveys and engagement with key stakeholders are underway. A Ground Investigation contract is complete, and the report is awaited. Work has begun to review possible sites for environmental impacts. We have received preliminary approval from Irish Rail to tunnel under the rail line and can now progress to public consultation with this as an option.

Engineering and Environmental Consultants have also been appointed for Flood Risk Management Works on the **Carrickmines/Shanganagh Rivers**. This is a 5+ year project. Data gathering is underway. A Flow/Rainfall Survey is complete. Further topographical survey work is being done this month. Early damage/benefits assessments are underway to ensure a cost-beneficial scheme is achievable. An initial public engagement is complete following short briefing sessions with Area Councillors. The Hydrology/Hydraulic Report is now complete and initial options are being developed. A Ground Investigation Contract has gone out for tender however the construction sector is buoyant at present and poor-quality tenders were received. We have tendered again with a few small amendments and we have received the tenders back.

The Monkstown environs flood risk mapping project is underway. The topographical survey is now largely completed. A flow/rainfall survey and CCTV survey is underway.

4. Roads Control Unit

Irish Water Reinstatement IWR Works 2022

Roads Control Unit is continuing to carry out the permanent reinstatement works throughout the administration area of Dún Laoghaire-Rathdown County Council (DLRCC) according to the current service level agreement (SLA) between Irish Water and DLRCC. In 2022, 422 no. locations are received, and 246 no. were fully reinstated.

Cleansing, Beaches & Coastal Protection Updates - July 2022

- Cleansing Outdoor Workforce are still adhering to the standard working hours that existed pre-Covid.
- Coliemore Harbour: A planning application was submitted in April to An Bord Pleanála under Section 177AE. Bord approval final approval may not be until 19th October 2022.
- Quinns Road The beach access repair works have been re-tendered via Etenders and tender returns are expected at the end of August.
- 40 Foot Remedial Repairs Material and fabrication lead times have delayed the project and it is currently expected that the project will be completed in late 2022 or early 2023.
- Redlough Landscapes Ltd are progressing as our weeding contractor and weeding crews have been deployed across the County.



- 1100L wheelie bins have been deployed at six strategic locations at present and are being collected by Panda. Capacity is available to deploy further 1100L Wheelie Bins if required.
- Lifeguards: Sandycove, Seapoint and Killiney beaches are currently opened. We currently have 14 on our roster.
- Power Washing of the footpaths in Dún Laoghaire Town has commenced.
- Gully cleaning and Junction Head cleaning is on-going.
- Town and Village Deep Cleans are progressing.
- Ailesbury have commenced as the Coastal toilet cleaning contractor.

7. Dún Laoghaire Harbour

Cruise Ship Business

We have approximately 70 Cruise Ships booked into the Harbour in 2022. The first ship arrived on 29th March and was a very successful visit. Approximately 35 ships have visited since then, and the Harbour is being well received by ship management, cruise quests and the crew who come ashore.

Projects:

National Watersports Campus

DLRCC in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We have responded to requests for additional information and are now finalising the grant process and agreements with the project partners.

An MOU has been signed with Irish Sailing and Diving Ireland in order to set out and agree the objectives of the project.

Berth 2 Fenders (Carlisle Pier)

A project to replace the Berth 2 fenders has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project. This project was tendered, and Sorensen Construction have been appointed to deliver the project. We are awaiting Foreshore consent to proceed to works on site.

Grant funding has recently been secured for the installation phase of this project from the recent Brexit Local Authority Marine Infrastructure Scheme.

Berth 3 Fenders (Carlisle Pier)

Grant funding has recently been secured for a project to replace the Berth 3 fenders from the recent Brexit Local Authority Marine Infrastructure Scheme. The project has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project as it is a mirror image of the Berth 2 fender project.

East Pier Revetment Repairs

Grant funding has recently been secured for a project to repair the sloping revetment at the back (east side) of the East Pier from the recent Brexit Local Authority Marine Infrastructure Scheme. This revertant provides the primary protection for the East Pier and has suffered some damage over recent years from the larger storms. Punch Consulting Engineers have been appointed to design and manage the project which is likely to be on site during the summer of 2023.

Ferry Terminal

Planning permission was granted for the ferry terminal project on 7th February 2020. A planning appeal was lodged to An Bord Pleanála. An Bord Pleanála have now granted permission for the development.

A business briefing on the ferry terminal proposal was delivered to the elected members by Hilary Haydon on 25th February 2020. An agreement to lease the building (subject to Foreshore and Section 183 consent) was signed in December 2021, and the Foreshore



Lease has been agreed with the Dept.

This matter was brought to the full June Council Meeting and the Section 183 Disposal passed. The Legal Department is now dealing with closing the lease process so the new tenant can begin occupation.

Dublin Array Windfarm

The developers of the Dublin Array Windfarm have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. Early engagement is ongoing with the developer's team to establish the exact requirements.

Community Response Forum

The Community response to the crisis in Ukraine, and the influx of Ukrainian nationals into the county, is being led and coordinated by Dún Laoghaire-Rathdown County Council in collaboration with a wide range of stakeholders in the Community Response Forum, supported by a wide range of community and volunteer groups.

The Community Response Forum has been meeting since 28 March and met twice during July. Support services are being provided to those Ukrainian nationals who are being accommodated in the Ballyogan Rest Centre as well as in hotels and in private accommodation within the County.

Temporary donations drop off points were established in Community Facilities, County Hall and Dundrum offices.

Ballyogan Parish Hall has been established as a Ukrainian Community Hub to provide information sessions, English Classes and other activities for Ukrainian nationals.

A consultant has been engaged to undertake a comprehensive Child Safeguarding Risk Assessment at Ballyogan Temporary Rest Centre. A Child Safeguarding Statement and Policy and Procedure document has been drafted following the onsite meetings and undertaking of the risk assessment.

Local Policing Fora

A meeting of the Ballybrack/Loughlinstown/Shankill Local Policing Forum took place on the 6th July 2022.

LCDC

An LCDC meeting took place on the 13th July. At this meeting, the LCDC approved the recommendation of the SICAP Subgroup to approve the SICAP 2022 Mid-Year Reports.

The Community Activities Fund (CAF) grants scheme Round 2 closed for applications on the 29^{th} of July with 59 applications received for operating costs support. Applications will be assessed with decisions on funding allocation made at the October LCDC meeting.

Age-Friendly Programme & Social Inclusion:

DLRCC High Security Locks Scheme for Homeowners aged 65+ years launched 1st July – accepting applications until Friday 9th September with locks upgrading to take place in October 2022.

dlr Older People's Council met on the 21st July and next meeting is on the 15th September - Small Grants Scheme made available for membership groups to support events taking place as part of Festival of Inclusion, October 2022.

Age-Friendly Programme Manager Meetings with older people's groups in Shankill area.

dlr Festival of Inclusion 2022 - planning underway for events promoting Equality, Diversity & Inclusion in dlr and the festival is taking place from 29th September throughout October 2022.

Community Facilities Network

The Community Facilities Network held their July meeting at the Women's Collective Ireland – Dun Laoghaire/Rathdown (formerly SWAN) offices in Loughlinstown. A presentation on the work of the Women's Collective Ireland was given to attendees. The



Community Facilities Network members then worked on the identification of training needs for the network. Community Section staff will work with the Network in developing a plan for the delivery of training supports.

Lambay Square

A public meeting took place at Lambay Square to discuss the proposed works due to take place. Community Section and Parks staff attended and met with local residents. Residents were shown draft plans for the space and were encouraged to submit any queries or observations to dlr in advance of final plans being prepared.

dlr Comhairle na nÓg

Foróige have been awarded the contract for support and co-ordination of dlr Comhairle na nÓg having sufficiently met all the requirements set out in the Request for Tender document. A new Service Level Agreement, for a period of 12 months, has been signed.

DIr Comhairle and dIr Comhairle Steering Committee met in July followed by a team building event for Comhairle members.

National Play Day

DIr were successful in their application for National Play Day funding. Three child and family community service providers were awarded a grant of €1,000 each. The services used the grants to purchase toys and equipment under the theme of All Play Together.

Summer Projects & Family Fun Days

A large number of Summer Projects, supported by Community Section, took place during the month of July. Summer projects were delivered from a number of Community Facilities, Family Support Agencies and Family Resource Centres across the County.

A Football Blitz & Family Fun Day took place in Ballyogan. 140 children and young people aged 4 to 14 took part in the football blitz with over 600 people in attendance at the Family Fun Day.

Arts

Municipal Gallery Programme

A Collection of Conversations – A Dementia Inclusive Exhibition

This exhibition opened to the public on 16 June and will run through the summer. The artworks included are from the dlr County Collection and the Drogheda Municipal Art Collection, Highlanes Gallery, and the exhibition has been specially selected by artists Claire Halpin, Julie Merriman and Orla Goodwin for visitors living with dementia. Simultaneously an exhibition opened in the Highlanes Gallery, Drogheda; this also features works from both Collections. The exhibitions include a wide range of engaging art works by important modern and contemporary artists featuring artists Gerard Dillon, Evie Hone, Mary Swanzy, Nano Reid, William Leech, Nathaniel Hone, Diana Copper white, Anthony Haughey, and many others.

A series of free dementia inclusive events and tours will take place throughout the exhibition run, inviting those living with dementia and their carers/ families to the galleries.

The Growing Gallery: Multisensory Art Installation for people with Dementia
The 'Growing Gallery' is a multisensory art installation in Gallery 2 concentrating on the



experience of touch, smell, sound, and visuals. This is a specially developed commission opportunity which came through extensive consultations with local services that support people with dementia; the aim is to be as engaging as possible for people with dementia who visit the exhibition. Artist Joanna Hopkins is taking inspiration from John Coyle's painting of the People's Park for this. Throughout July, local residential care settings, people living at home with dementia and local services visited the artwork. Participants were invited to help create a living, growing installation in the gallery space. Taking cuttings from a mint plant growing in the Peoples Park, the plants were propagated in the gallery space over the summer months. As the installation grows with each participant, the audience will be invited back on the last day to take home their plants.

Cruinniú na nÓg 2022 update

Ireland is the first country in the world to have a national day of free creativity for children and young people under 18. Cruinniú na nÓg is a flagship initiative of the Creative Ireland Programme's Creative Youth Plan to enable the creative potential of children and young people. In 2022 to celebrate Cruinniú na nÓg dlr Arts Office in partnership with dlr CYPSC awarded a commission to develop 'Small Wonders' a new child-centered multisensory creative experience for and with children from 0-2 years and their caregivers. Artists Niamh Lawlor, George Higgs, Sarah Fitzgibbon and Orla Kelly collaborated with children from the First Friends Service and were supported by dlr CYPSC and Barnardos. The project took place in the First Friends community-based locations, Loughlinstown, Mounttown, Ballyogan and Shanganagh. Ending in free creative experiences for the general public on Cruinniú na Óg 2022.

In addition, we have also drafted an information leaflet specifically for the Ukrainian Rest Centre in Ballyogan.

We have ordered books for children and adults in Ukrainian and Russian. We have purchased a selection of e-books on our existing online platforms (Overdrive and Borrowbox) and have purchased licences to download and print early readers in Ukrainian for children. We have also ordered some Ukrainian newspapers and magazines for our library branches along with the new Ukrainian Community Hub in Ballyogan.

As with all DLR websites, content on https://libraries.dlrcoco.ie/ can be accessed in multiple languages, including Ukrainian and Russian, by using the Accessibility button at the top of the webpage.

We continue to gift books and book packs to centres in the County as needed and are liaising with language tutors to offer our library spaces for language exchanges/lessons as requested.

Online platforms with Ukrainian and Russian resources include:

Access to all these services is free, but a library card is required to access them. Library cards can be obtained by registering online or by calling into the nearest dlr Library with Photo ID.

Cultural Evening: IFLA 2022 (International Federation of Library Associations)

The IFLA World Library & Information Congress was held at the Convention Centre, Dublin from 26-29 July 2022. Considered by many as the most important Library Conference, this year saw nearly 2,000 Librarians from over 100 countries come to Dublin for the first major in-person conference since 2019. Included as part of the



programme for delegates, were tours of Dalkey, Deansgrange and dlr LexIcon Libraries, with dlr LexIcon also the venue for IFLA Camp for the new Professionals Group.

On Wednesday 27 July, library staff in dlr LexIcon hosted the Cultural Evening for delegates which catered for 1,400 Librarians. The evening consisted of a showcase of Irish cultural events including Irish Myths and legends, Joycean readings and songs, a show featuring Irish traditional song and dance history, plus Gaelic games and harp music from Harp Ireland. Visiting delegates also got to sample a taste of Dún Laoghaire with some Teddy's ice cream!

Events for Adults

Poetry as Commemoration

In July we hosted a Poetry writing workshop over 2 Fridays with poet Catherine Ann Cullen. The first session examined and discussed archival material on the War of Independence & the Civil War, the second session focused on forging creative responses. Poetry as Commemoration aims to encourage a greater understanding of our shared past through creative engagement with archival materials. These include letters, accounts, diaries, manuscripts, photographs and newspapers held in libraries and archives across the island of Ireland. Such documents provide a tangible link with the past and can be emotive and inspiring.

Book Launch

On Thursday 30 June, dlr LexIcon welcomed poet Gerald Dawe for the launch of his poetry anthology *Revenant*.

Summer of Heritage

As in previous years, The Summer of Heritage Irish Authors' tour ended at the Maeve Binchy Garden and mosaic located in Dalkey Library.

Clubs & Groups

A wide variety of clubs and groups continue to use our library spaces to meet.

These include the Language Exchanges and the Scrabble Club in Deansgrange Library, the Knitting Club in Cabinteely Library, the craft circle in Shankill Library, and the Family Lego Club in Blackrock Library.

Each of the 8 branches has their in-person book clubs, including the Audio Book Club in Dundrum Library with some also continuing with their online book clubs, due to ongoing demand. Shankill Library have started a new Junior Book Club, which takes place on the last Thursday of the month.

The very popular online monthly Book Club with Mary Burnham continues to meet over the summer months. The July title for discussion was *Nora* by Nuala O'Connor.

The description of them as 'The Forgotten Ten' did not refer to how they were remembered, but rather that they remained buried behind the high walls of Mountjoy Prison until their re-interment in Glasnevin Cemetery in 2001.
