





The Ballyogan Regional Temporary Rest Centre opened its doors to Ukrainian nationals on 28 April.

Significant work has been undertaken by regional agencies, led by Dún Laoghaire-Rathdown County Council, to provide temporary accommodation facilities, managed by a dedicated site supervisor overseeing an extensive facilities team, as well as catering, security and cleaning details, all operating on a 24-hour basis.

The Ballyogan Regional Temporary Rest Centre can accommodate up to 300 displaced Ukrainian nationals for short periods. Thereafter they will be allocated longer term accommodation in other areas of the state.

As part of a comprehensive wrap around service, accommodation services at the Centre are being supported by HSE staff including Environmental Health, Public Health and COVID-19 services. The HSE is providing onsite support to meet the healthcare needs of Ukrainian residents, and residents also have access to an offsite GP service 7 days a week.

Among the facilities available in the temporary rest centre is separate laundry and sanitary facilities, internet access, television spaces, games consoles, games room, chessboards, use of bikes and scooters, libraries of Ukrainian books for children and adults, translation services, as well as online access to Ukrainian newspapers and magazines.

Additionally, orientation and information sessions, basic English language lessons and an arts and music entertainment programme is being developed both onsite and nearby offsite.

Local coordination efforts to develop as safe and as comprehensive support services as possible include Southside Partnership, HSE, An Garda Siochána, Department of Social Protection, dlr Education and Training Board, TUSLA, Community and Family Resource Centres, dlr Volunteers Centre, colleagues in the East Region and a number of other community and voluntary groups.

Bus Connects

The Core Bus Corridors Schemes' (CBCs) statutory applications are now being progressed by the NTA for formal submission to An Bord Pleanala for planning permission. The Blackrock to City Centre Core Bus Corridor Scheme (CBC 15) was the second formal application to ABP and the 8 week statutory public consultation period for this development closed on Tuesday July 12th 2022. All planning documentation is available at: https://belfieldblackrockscheme.ie/ The Traffic Section, with cross departmental input, made a submission to ABP with respect to the proposed CBC.

The NTA have advised that the submission of the Bray to City Centre CBC planning application to ABP is planned for Q4 of this year (2022).

The submission of the CBC planning applications to ABP triggers a formal statutory public consultation process in respect of each of the stand-alone Core Bus Corridor schemes, with submissions made directly to An Bord Pleanála for their consideration. During this process, the finalised Environmental Impact Assessment Reports, inclusive of traffic impact analyses, will be published and available for inspection (including online) and purchase. The public will then have the formal opportunity to have their views heard and considered by An Bord Pleanála as part of the statutory consultation process to inform An Bord Pleanála's assessment of each of the stand-alone Core Bus Corridor schemes.

Dundrum ABTA - Area Based Transport Assessment

Work on this project is progressing and the ABTAs Stages 1 & 2 now completed with work on Stage 3 – Options Assessment & Development, now at an advanced stage.

Bus Interchanges at Dundrum, Dun Laoghaire & Blackrock

Discussions are ongoing with the NTA regarding bus interchange improvements at both Dundrum and Dun Laoghaire. The improvements are needed to cater for the planned service increases under the BusConnects' programme. Meetings/workshops are ongoing to progress this work and a multi-disciplinary group from the Council is in place to assist. In addition, discussions have also commenced with the NTA regarding potential public realm improvements in Blackrock and the impact these may have on the existing bus interchange and bus services.

Old Conna ABTA - Area Based Transport Assessment

Following discussions with the NTA, it has been agreed that the Old Conna ABTA study, commenced in 2019 and on hold since 2020, should not be completed due to outdated policy and context. It is anticipated that a new ABTA study based on updated policy and



strategic context will be required.

Racecourse South ABTA - Area Based Transport Assessment

Discussions have commenced with the Land Development Agency, the NTA and TII on the preparation of an Area Based Transport Assessment (ABTA) for the Racecourse South lands at Carrickmines, in accordance with the requirements of SLO 143 in the current County Development Plan.

New Bus Stops to Serve Planned BusConnects Orbital Bus Services

The Traffic Section has been liaising with the NTA on the location and design of new bus stops throughout the county, required to support planned new bus services being introduced by the NTA over the next two years. It is anticipated that bus stop approval notices for the new stops will be issued to the NTA in Q3 of this year.

3. Water & Drainage

Drainage and Flood Alleviation

Engineering and Environmental Consultants were appointed in December 2019 for Flood Risk Management works on the **Deansgrange Stream**. This is a 4-to-5-year project. Activities completed to date include additional survey work, CCTV surveys, a Constraints Study, Hydrological analysis, and hydraulic modelling. Initial Public Consultation is now complete. Optioneering, environmental surveys and engagement with key stakeholders are underway. A Ground Investigation Contract is complete, and the report is awaited. Work has begun to review possible sites for environmental impacts. We have received preliminary approval from Irish Rail to tunnel under the rail line and can now progress to public consultation with this as an option.

Engineering and Environmental Consultants have also been appointed for Flood Risk Management Works on the **Carrickmines/Shanganagh Rivers**. This is a 5+ year project. Data gathering is underway. A Flow/Rainfall Survey is complete. Further topographical survey work is being done this month. Early damage/benefits assessments are underway to ensure a cost-beneficial scheme is achievable. An initial public engagement is complete following short briefing sessions with Area Councillors. The Hydrology/Hydraulic report is now complete and initial options are being developed. A Contractor has been appointed for the Site Investigation. This work is due to begin in September.

The Monkstown environs flood risk mapping project is underway. The topographical survey is now largely completed. The flow/rainfall survey is now completed and the CCTV survey is well underway. Draft flood maps have been produced.

4. Roads Control Unit

Irish Water Reinstatement IWR Works 2022

Roads Control Unit is continuing to carry out the permanent reinstatement works throughout the administration area of Dún Laoghaire-Rathdown County Council (DLRCC) according to the current service level agreement (SLA) between Irish Water and DLRCC. In 2022, 467 no. locations are received, and 297 no. were fully reinstated.

Cleansing, Beaches & Coastal Protection Updates

- Cleansing Outdoor Workforce are still adhering to the standard working hours that existed pre-Covid.
- Coliemore Harbour: Final An Bord Pleanála approval is expected by the 19th October. The on-site works may not progress until early 2023 due to weather constraints.
- Quinns Road The beach access repair works have been re-tendered via Etenders and tender returns are expected in September.
- 40 Foot Remedial Repairs Material and fabrication lead times have delayed the project and it is currently expected that the project will be completed in late 2022 or early 2023.
- Redlough Landscapes Ltd are progressing as our weeding contractor and weeding crews have been deployed across the County.
- 1100L wheelie bins have been deployed at six strategic locations at present and are being collected by Panda. Capacity is available to deploy further 1100L Wheelie Bins if required.
- Public Realm cleaning is on-going during the busy summer period.
- Lifeguards: Sandycove, Seapoint and Killiney beaches are currently opened. Our Lifeguard service will revert to weekends only in September and will cease on the 15th of September due to the conclusion of the Bathing Season.
- Power Washing of the footpaths in Dún Laoghaire Town has been on-going and power washing works have commenced in Blackrock.
- Gully cleaning and Junction Head cleaning is on-going.
- Town and Village Deep Cleans are progressing.

7. Dún Laoghaire Harbour

Cruise Ship Business

We have approximately 70 Cruise Ships booked into the Harbour in 2022. The first ship arrived on 29th March and was a very successful visit. Approximately 50 ships have visited since then, and the Harbour is being well received by ship management, cruise guests and the crew who come ashore.

Grant Funding

The Brexit Adjustment: Local Authority Marine Infrastructure Scheme 2022 – 2023 from the Department of Agriculture, Food and the Marine has launched a Second Tranche call for applications. Dun Laoghaire Harbour received over €3 million in grant funding from the first tranche. We are preparing a number of grant applications to submit by the deadline of 30th September 2022.

Projects:

National Watersports Campus

DLRCC in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We have responded to requests for additional information and are now finalising the grant process and agreements with the project partners.



An MOU has been signed with Irish Sailing and Diving Ireland in order to set out and agree the objectives of the project.

DLRCC and Irish Sailing are developing a prospectus for the project to detail the project vision and scope. It is hoped that this initiative will assist in building momentum and support for the project.

Berth 2 Fenders (Carlisle Pier)

A project to replace the Berth 2 fenders has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project. This project was tendered, and Sorensen Construction have been appointed to deliver the project. We are awaiting Foreshore consent to proceed to works on site.

Grant funding has recently been secured for the installation phase of this project from the recent Brexit Local Authority Marine Infrastructure Scheme.

Berth 3 Fenders (Carlisle Pier)

Grant funding has recently been secured for a project to replace the Berth 3 fenders from the recent Brexit Local Authority Marine Infrastructure Scheme. The project has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project as it is a mirror image of the Berth 2 fender project.

East Pier Revetment Repairs

Grant funding has recently been secured for a project to repair the sloping revetment at the back (east side) of the East Pier from the recent Brexit Local Authority Marine Infrastructure Scheme. This revertant provides the primary protection for the East Pier and has suffered some damage over recent years from the larger storms. Punch Consulting Engineers have been appointed to design and manage the project which is likely to be on site during the summer of 2023.

Dive surveys have been carried out mid August on the revetment, with inter-tidal and land surveys to continue during the coming weeks.

Ferry Terminal

Planning permission was granted for the ferry terminal project on 7th February 2020. A planning appeal was lodged to An Bord Pleanála. An Bord Pleanála have now granted permission for the development.

A business briefing on the ferry terminal proposal was delivered to the elected members by Hilary Haydon on 25th February 2020. An agreement to lease the building (subject to Foreshore and Section 183 consent) was signed in December 2021, and the Foreshore Lease has been agreed with the Dept.

This matter was brought to the full June Council Meeting and the Section 183 Disposal passed. The Legal Department is now dealing with closing the lease process so the new tenant can begin occupation.

Dublin Array Windfarm

The developers of the Dublin Array Windfarm have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. Early engagement is ongoing with the developer's team to establish the exact requirements.

As part of the Energy Team's public engagement work, there will be a Home Energy Upgrade event on 16 October. The event aims to inspire and encourage people considering residential extensions and home energy upgrades. Community Response Forum

The Community response to the crisis in Ukraine and the influx of Ukrainian nationals into the county, is being led and coordinated by Dún Laoghaire-Rathdown County Council in collaboration with a wide range of stakeholders in the Community Response Forum, supported by a wide range of community and volunteer groups.

The Community Response Forum has been meeting since 28 March and met once during August. Support services are being provided to those Ukrainian nationals who are being accommodated in the Ballyogan Rest Centre as well as in hotels and in private accommodation within the County.

Temporary donations drop off points were established in Community Facilities, County Hall and Dundrum offices.

Ballyogan Parish Hall has been established as a Ukrainian Community Hub to provide information sessions, English Classes and other activities for Ukrainian nationals.

Ballyogan Parish Hall and the Samuel Beckett Civic Campus continue to be used as a base to provide English Classes and other activities for Ukrainian nationals. Residents of Ballyogan Rest Centre are accessing and using the facilities of dlr Leisure Ballyogan which is being supported by Community Section and Sports Partnership.

Local Policing Fora (LPF)

A meeting of the Sandyford/Stepaside LPF took place on the 16^{th} August and the Central Dun Laoghaire LPF meeting took place on the 17^{th} August.

Age-Friendly Programme & Social Inclusion:

Planning is underway for 'India Fest' to take place on Saturday 17th September, Kilbogget Park organised by Social Space Ireland and the dlr Integration Forum – music, dance, sport, children's activities etc. to celebrate Indian culture and an opportunity for the Indian community in dlr to come together - supported by the Social Inclusion Unit & DLR Sports Partnership.

An updated dlr Age-Friendly Directory of Activities & Services 2022 is being prepared.

Planning of 'Autumn Medley of Creativity' event – a morning of free age-friendly entertainment, dance, drama, music, information stands, workshops, Men's Shed etc. This event is taking place to showcase opportunities to get involved in age-friendly creative activities in dlr, on Thursday 29th September 11 – 2p.m in dlr LexIcon, supported by Creative Ireland, Age-Friendly Ireland & Creative Lives.

University of Limerick & Immigrant Council of Ireland SALAAM Project – *Sustainable Alliances Against Anti-Muslim Hatred* – research with DLRCC staff.

dlr Integration Forum project is seeking new members from the Honey Park & Cualanor area, in conjunction with the Community Gardaí Team.

Period Poverty

Dun Laoghaire Rathdown County Council have been awarded Grant Funding from the Department of Health for the provision of free period products to identified Community Facilities, Community / Voluntary Sector Service Providers, Libraries, County Hall and Dundrum offices (public toilets). The purpose of this Pilot Project is to support the



implementation of period poverty mitigation measures. A total of 18 sites, across the county, have been identified and supplied with period products.

Municipal Gallery Programme

A Collection of Conversations - A Dementia Inclusive Exhibition

This exhibition opened to the public on 16 June and will run through the summer. The artworks included are from the dlr County Collection and the Drogheda Municipal Art Collection, Highlanes Gallery, and the exhibition has been specially selected by artists Claire Halpin, Julie Merriman and Orla Goodwin for visitors living with dementia. Simultaneously an exhibition opened in the Highlanes Gallery, Drogheda; this also features works from both Collections. The exhibitions include a wide range of engaging art works by important modern and contemporary artists featuring artists Gerard Dillon, Evie Hone, Mary Swanzy, Nano Reid, William Leech, Nathaniel Hone, Diana Copper white, Anthony Haughey, and many others.

A series of free dementia inclusive events and tours will take place throughout the exhibition run, inviting those living with dementia and their carers/ families to the galleries.

The Growing Gallery: Multisensory Art Installation for people with Dementia

The 'Growing Gallery' is a multisensory art installation in Gallery 2 concentrating on the experience of touch, smell, sound, and visuals. This is a specially developed commission opportunity which came through extensive consultations with local services that support people with dementia; the aim is to be as engaging as possible for people with dementia who visit the exhibition. Artist Joanna Hopkins is taking inspiration from John Coyle's painting of the People's Park for this. Throughout July and August, local residential care settings, people living at home with dementia and local services visited the artwork. Participants were invited to help create a living, growing installation in the gallery space. Taking cuttings from a mint plant growing in the Peoples Park, the plants were propagated in the gallery space over the summer months. As the installation grows with each participant, the audience will be invited back on the last day to take home their plants.

Pilot of Quiet/Sensory Room in dlr LexIcon

For the month of August, we piloted the use of a designated quiet/sensory space in dlr LexIcon which we made available each Wednesday from 10am-7.30pm for one hour bookings. The room contains a range of sensory items including: dark den, rock and spin seats, mini river stepping stones, fidget toys, timer, weighted and sensory objects, tactile path, seesaw, activity play cube, snuggle seat. Depending on individual need, the room is available as a quiet space to retreat to, relax/read as well as a sensory stimulating place. Usage during the pilot will be analysed to inform us how best to proceed with this space.

Events for Adults

Clubs & Groups

A wide variety of clubs and groups continue to use our library spaces to meet. These include the Language Exchanges and the Scrabble Club in Deansgrange Library, the Knitting Club in Cabinteely Library, and the Family Lego Club in Blackrock Library. 'Handmade,' the crafting circle in Dalkey Library, met and learned about a book-making technique with Sharon Wells from the Muddle.

Each of the 8 branches have their in-person book clubs, including the Audio Book Club in Dundrum Library with some also continuing with their online book clubs, due to ongoing

'The Forgotten Ten' are: Kevin Barry, Patrick Moran (of Moran Park, a special Dún Laoghaire-Rathdown connection), Thomas Whelan, Francis Flood, Bernard Ryan, Thomas Bryan, Patrick Doyle, Thomas Traynor, Patrick Maher and Edmond Foley. Ranging in age from 18 to 40 years old, 'The Forgotten Ten' came from all over Ireland and from all sections of Irish society. Their executions made international news, and some would become household names. The description of them as 'The Forgotten Ten' did not refer to how they were remembered, but rather that they remained buried behind the high walls of Mountjoy Prison until their re-interment in Glasnevin Cemetery in 2001.

Leinster Rugby community department staff are required to work across multiple regions during the summer months to support the running of the BOI camps, school of excellence camps, disability camps or other summer programs within Leinster Rugby.

FAI:

- **Club Visits** –Visits will resume in September.
- **SAFEGUARDING 1 Workshops** Planning workshops for September to December.
- **Primary schools** Planning for September.
- **FFA** Programme with Stillorgan Park House to begin in mid-September.
- **Girls Centre of Excellence** Player ID began in August, coaching programme returns in mid-September.
- **COACH EDUCATION** Met local clubs in late August to plan needed grassroots courses. Seven courses planned so far from September to December.
- **Club Mark**: On-going contact with registered clubs to achieve award. Currently 10 dlr clubs have registered.

Leinster Cricket:

- Contacting schools with session plans and arranging sessions for new term.
- DLR District Cup team won boys u13 District cup competition this year, winning two of three matches. It should be noted that four members of the team won full Leinster Caps at u13 level, going on to play a three match interprovincial series.
- U11 District cup took place during July, with the team playing three matches, winning one. It should be noted that two players went on to win full Leinster u11 caps and played in the three match interprovincial series.
- Met with dlr Sports Partnership and Social Space Ireland to provide assistance and guidance for the India Day Festival taking place in Kilbogget Park on the 17th of September. CL will provide equipment and coaches for the festival.
- We took part in the IWA cricket for all camp, ran by SDCC and DLR. Table cricket and cricket skills were taught.
- Met with DLR and Sandyford cricket club to discuss damage to Marlay Park pitch caused by Longitude Festival and possible solutions to avoid future problems.

Sports Partnership:

- **National Her Outdoors Week** delivered a range of taster/intro sessions for girls and women in outdoor based activities from 8th to 14th August (241 participants across 12 different programmes).
- **Hockey Inclusion Camps** collaboration with with Hockey Ireland to deliver 2 weeks of disability camps in early August for children and adults across two locations.
- **Multi-Sports Autism Camps** linked in with Active Kids Academy to support delivery of a camp for children on the Autism Spectrum in Naomh Olafs.
- **dlr Community 5K 2022** the Steering Group has been reformed and work underway to prepare for this event on 8th October as part of the Festival of Inclusion.
- **Staffing** 3 new staff members due to start soon. Awaiting date to re-advertise the Sports Inclusion Disability Officer position.
- Inclusive Bike Fleet promoting this service for older adults and those with a



- disability to rent bikes for free from The Bike Hub.
- **Ukraine Refugee Supports** funding gym visits to the dlr Leisure Ballyogan centre for adults staying in the Rest Centre next door. Continuing to provide sports equipment to families and raising awareness of opportunities to link in with local clubs and camps.
- **Active Dublin** work continuing on this initiative as well as working with the other Active City LSP's to deliver agreed actions and promote the initiative.
- **ExWell** weekly programme for older adults with chronic illnesses as part of the Active Cities initiative. Based in Sandyford Community Centre.
- **Marathon Kids** working with primary schools to deliver this activity programme from September with medals and site visits (834 pupils across 13 schools).
- **Women In Sport Leadership Programme** starting a new 8-week leadership programme for another 18 females involved in sport in DLR.
