#### PROPOSED ROAD CLOSURES

### Section 75, Roads Act, 1993, Temporary Road Closure of Castle Street, Dalkey

Dún Laoghaire Rathdown County Council has received an application to temporarily close Castle Street from The Church of the Assumption, Castle Street, Dalkey to Allied Irish Bank on Saturday 27<sup>th</sup> August, 2022 and Sunday 28<sup>th</sup> August, 2022 from 11 a.m. to 7.00 p.m. in order to facilitate the Dalkey Lobster Festival. The purpose of the closure is to create a safe and family friendly community atmosphere for the Lobster Festival with Cookery Demonstrations, Street Entertainment Etc.

A Traffic Management Plan with diversion routes will be in operation and local access will be maintained for the full duration of the event.

# Section 75 of the Roads Act, 1993 Temporary Closure of Hillcrest Road, Sandyford

Dún Laoghaire Rathdown County Council proposes to temporarily close Hillcrest Road, Sandyford, from the junction of Kilgobbin Road to the junction with Enniskerry Road / Hillcrest Downs from Sunday 4<sup>th</sup> September 2022, between 7.00 a.m. and 7.00 p.m.

The purpose of the closure is to facilitate essential cleansing works on Hillcrest Road by the dlr Roads Maintenance Section.

A Traffic Management Plan will be in place and the diversion route will be clearly signposted. Access to Sandyford Village/Sandyford Road from Kilgobbin Road will be unaffected. Local access to Hillcrest Road will be maintained.

Diversion of traffic will be via Kilgobbin Road and Enniskerry Road and vice versa.

# SECTION 75 OF THE ROADS ACT. 1993 TEMPORARY CLOSURE OF KNOCKNACREE ROAD, DALKEY

Dún Laoghaire Rathdown County Council has received an application from Wallace Contracting Ltd, Kilree Road, Bagenalstown, Co. Carlow to temporarily close Knocknacree Road, Dalkey.

It is proposed that Knocknacree Road will be closed at House No. 4 from 07:00hrs to 18:00hrs on Sunday 4<sup>th</sup> September 2022. The purpose of the closure is to erect a crane on the road to undertake site works.

A Traffic Management Plan will be in operation. Local access will be maintained at all times.

#### **ROAD CLOSURES**

#### **SECTION 75 OF THE ROADS ACT, 1993**

TEMPORARY CLOSING OF ROADS M50 northbound and southbound between Junction 13 (Sandyford) and Junction 17 (M50/M11 merge)

Dún Laoghaire-Rathdown County Council, on behalf of Transport infrastructure Ireland, has made an order to close the following:

• The M50 northbound and southbound between Junction 13 (Sandyford) and Junction 17 (M50/M11 merge).

The Northbound carriageway will be closed from 15<sup>th</sup> August to 24<sup>th</sup> August 2022, from 10.00pm until 6.00am each night.

The Southbound carriageway will be closed from 22<sup>nd</sup> August to 2<sup>nd</sup> September 2022, from 10.00pm until 6.00am each night.

# As these will be night works, the motorway will reopen to traffic outside of the working hours.

Alternative routes available for vehicular traffic are as follows:

# <u>Diversion for traffic travelling southbound on M50 from Junction 14</u> (Sandyford) to Junction 17 (M50/M11)

- Take southbound exit slip at M50 Junction 14 (Sandyford) and continue to the first roundabout.
- Take 2<sup>nd</sup> exit from roundabout onto the N31 Leopardstown Road and travel south for approx. 650m towards signalised junction of Burton Hall Road and Leopardstown Road.
- Turn right at signalised junction onto R113 Leopardstown Road and continue for approx. 1.2km until junction with N11.
- Turn right at signalised junction and continue straight on N11 for approx. 5.7km until Loughlinstown roundabout.
- Take 2<sup>nd</sup> exit from Loughlinstown roundabout and merge with M11 Southbound.

# <u>Diversion for traffic travelling northbound on M11 at M50 Junction 17</u> (M50/M11) to Junction 14 (Sandyford)

- Take northbound exit slip M50 Junction 17 (M50/M11) and continue to the Loughlinstown roundabout.
- Take 2<sup>nd</sup> exit from the Loughlinstown roundabout and continue straight on N11 for approx. 5.7km.
- At the signalised junction of the N11 with Leopardstown Road (R113) (White's Cross) turn left onto Leopardstown Road (R113) and continue for approx. 1.2km until signalised junction of Leopardstown Road and Burton Hall Road.

- Turn left at signalised junction and continue straight on R113 for approx. 650m until roundabout.
- Take 2<sup>nd</sup> exit from roundabout and merge with M50 Northbound.

# SECTION 75 OF THE ROADS ACT, 1993\*\*\* TEMPORARY CLOSURE OF GLENAMUCK ROAD

Dún Laoghaire-Rathdown County Council has approved an application from Glassford Developments Ltd., Church Street, Carrickmacross, Co. Monaghan to temporarily close Glenamuck Road from Thursday 04<sup>th</sup> August 2022 to Sunday, 21<sup>st</sup> August 2022.

The purpose of the closure is to facilitate the construction of foul and surface water drainage pipes and manholes to serve a new Residential Development.

A traffic management plan will be in operation and local access will also be maintained and diversion routes will be clearly signposted.

# SECTION 75 OF THE ROADS ACT, 1993\*\* TEMPORARY CLOSURE OF BALLYMAN LANE

Dún Laoghaire-Rathdown County Council has approved an application from Ward and Burke Construction to temporarily close Ballyman Lane, Kilternan from Murphy's Lane junction to Ballyman Road junction from Monday, 18<sup>th</sup> July 2022 to Friday, 2<sup>nd</sup> December 2022.

A traffic management plan will be in operation. Local and pedestrian access will be maintained at all times. Diversion routes will be clearly signposted.

The purpose of the closure is to ensure safe access to sites for the construction of reservoir sites as part of the Old Connaught Woodbrook Contract.

### SECTION 75 OF THE ROADS ACT, 1993 \*\*\*

#### **TEMPORARY CLOSURE OF BLACKGLEN ROAD, SANDYFORD, DUBLIN 18**

Dún Laoghaire-Rathdown County Council has made an order to temporarily close Blackglen Road between the two junctions with Ticknock Park and Simonsridge from Monday, 28<sup>th</sup> February 2022 to Monday, 5<sup>th</sup> September 2022.

A number of submissions were received in relation to the proposed road closure. These submissions have been considered and the road closure is approved with amended dates, and mitigation measures in place. The road closure will be in place from Monday, 28<sup>th</sup> March 2022 to Monday, 3<sup>rd</sup> October 2022.

The purpose of the proposed closure is to facilitate road works as part of the Blackglen Road improvement scheme.

Pedestrian access will be maintained at all times.

The proposed diversion route will be via the Loop road and all residents access will be maintained.

A traffic management plan will be in place and the diversion will be clearly signposted.

#### **SPEED LIMIT ORDER**

# Road Works Speed Limit Order, No.1 of 2021 on the M50 Motorway in the County of Dún Laoghaire-Rathdown

Notice is hereby given that Dún Laoghaire-Rathdown County Council, in exercise of the powers under Section 10 of the Road Traffic Act 2004, in the interests of road safety and to facilitate the M50 Traffic Flow Optimisation Construction Project; has made an Order entitled Road Works Speed Limit Order, No.1 of 2021 on the M50 Motorway in the County of Dún Laoghaire-Rathdown to apply a road works speed limit as follows:

M50 Southbound will run from 7<sup>th</sup> February 2022 until 1<sup>st</sup> December 2022 or until the end of the works, whichever is the earlier.

Description of speed limit order 80km/hr:

- Part of the Southbound M50 between a point 120 metres South of the existing R117 overbridge to a point 620 metres South of the R117 overbridge (Total 500m in length).
- Part of the Southbound M50 diverge at Junction 14 from the start of the diverge taper to a point on the diverge ramp 420 metres West of the yield line of the diverge off-ramp at Junction 14 (Total 485m in length).
- Part of the Southbound M50 between a point 620 metres South of the existing R117 Overbridge to a point 120 metres South of the M11 Overbridge (M50 Junction 17/M11 J4) (Total 8,000m in length).
- Part of the Southbound M50 merge at Junction 13 from a point 50 metres East of the start of the merge on-ramp at M50 Junction 13 to the end of the merge taper (Total 1250m in length).
- Part of the Southbound M50 diverge at Junction 15 from the start of the diverge taper to a point on the diverge ramp 40 metres West of the stop line of the diverge off-ramp at Junction 15 (Total 555m in length).
- Part of the Southbound M50 merge at Junction 15 from a point 75 metres South
  of the start of the merge on-ramp at M50 Junction 15 to the end of the merge
  taper
  (Total 480m in length).
- Part of the Southbound M50 diverge at Junction 16 from the start of the diverge taper to a point on the diverge ramp 60 metres West of the stop line of the diverge off-ramp at Junction 16 (Total 525m in length).

Part of the Southbound M50 merge at Junction 16 from a point 65 metres South
of the start of the merge on-ramp at M50 Junction 16 to the end of the merge
taper
(Total 575m in length).

M50 Northbound will run from 3<sup>rd</sup> August 2021 until 1<sup>st</sup> November 2022 or until the end of the works, whichever is the earlier.

Description of speed limit order 80km/hr:

- Part of the Northbound M50 between a point 335 metres South of the existing Crinken Lane overbridge to a point 165 metres North of the Crinken Lane overbridge (Total 500m in length).
- Part of the Northbound M50 between a point 165 metres North of the existing Crinken Lane overbridge to a point 300 metres West of the R113 overbridge (Total 8000m in length).
- Part of the Northbound M50 diverge at Junction 17 (M11 Junction 4) from the start of the diverge taper to a point on the diverge ramp 70 metres North of the Lordello Road overbridge (Total 450m in length).
- Part of the Northbound M50 diverge at Junction 16 from the start of the diverge taper to a point on the diverge ramp 55 metres East of the stop line of the diverge off-ramp at Junction 16 (Total 605m in length).
- Part of the Northbound M50 merge at Junction 16 from a point 80 metres West of the start of the merge on-ramp at M50 Junction 16 to the end of the merge taper (Total 700m in length).
- Part of the Northbound M50 diverge at Junction 15 from the start of the diverge taper to a point on the diverge ramp 130 metres East of the stop line of the diverge off-ramp at Junction 15 (Total 500m in length).
- Part of the Northbound M50 merge at Junction 15 from a point 35 metres North
  of the start of the merge on-ramp at M50 Junction 15 to the end of the merge
  taper
  (Total 590m in length).
- Part of the Northbound M50 diverge at Junction 13 from the start of the diverge taper to a point on the diverge ramp 420 metres East of the stop line of the diverge off-ramp at Junction 13 (Total 480m in length).

The Garda Commissioner has been notified by email of the Council's intention to decrease the speed limit to **80 km/hr** on the M50 Southbound and Northbound, in accordance with Section 10 of the Road Traffic Act, 2004.
