PROPOSED ROAD CLOSURES

SECTION 75 OF THE ROADS ACT. 1993 TEMPORARY CLOSURE OF BALLYMAN ROAD

Dun Laoghaire Rathdown County Council has received an application from Ward and Burke Construction to temporarily close Ballyman Road from Thornhill Road Junction to Monastery road from Monday 10th of October 2022 to 4th of November 2022.

A Traffic Management Plan will be in operation and local and pedestrian access will be maintained at all times. Diversion routes will be clearly signposted.

The Purpose of the closure is to ensure safe access to sites for the construction of reservoir sites as part of the Old Connaught Woodbrook Contract.

SECTION 75 OF THE ROADS ACT. 1993 TEMPORARY CLOSURE OF CHURCHTOWN ROAD LOWER, DUBLIN 14

Dun Laoghaire Rathdown County Council proposes to temporarily close Churchtown Road Lower, Dublin 14, from the junction of Orwell Road to the junction of Churchtown Road Upper from Monday 17th October 2022 to Friday 28th October 2022.

A Traffic Management Plan will be in operation and local access will be maintained at all times. Diversion routes will be clearly signposted.

The purpose of the closure is to facilitate the undertaking of road surfacing works to be carried out by Actavo (Ireland) Limited on behalf of Dún Laoghaire Rathdown County Council Traffic Section.

ROAD CLOSURES

SECTION 75 OF THE ROADS ACT, 1993 TEMPORARY CLOSURE OF ROADWAYS TO FACILITATE THE DUBLIN CITY MARATHON 2022.

Dún Laoghaire-Rathdown County Council has received a request from the Race Director, Dublin City Marathon for the temporary closure of the following roads within the Council's Administrative area:-

- 1. Clonskeagh Road
- 2. Roebuck Road
- 3. Foster's Avenue
- 4. Stillorgan Road (R138 Dual Carriageway), North from junction with Foster's Avenue and via the UCD Flyover to the County Boundary.

The purpose of the closures is to facilitate the running of the Irish Life Dublin City Marathon on Sunday 30th October 2022.

SECTION 75 OF THE ROADS ACT, 1993** TEMPORARY CLOSURE OF BALLYMAN LANE

Dún Laoghaire-Rathdown County Council has approved an application from Ward and Burke Construction to temporarily close Ballyman Lane, Kilternan from Murphy's Lane junction to Ballyman Road junction from Monday, 18th July 2022 to Friday, 2nd December 2022.

A traffic management plan will be in operation. Local and pedestrian access will be maintained at all times. Diversion routes will be clearly signposted.

The purpose of the closure is to ensure safe access to sites for the construction of reservoir sites as part of the Old Connaught Woodbrook Contract.

SECTION 75 OF THE ROADS ACT, 1993 ***

TEMPORARY CLOSURE OF BLACKGLEN ROAD, SANDYFORD, DUBLIN 18

Dún Laoghaire-Rathdown County Council has made an order to temporarily close Blackglen Road between the two junctions with Ticknock Park and Simonsridge from Monday, 28^{th} February 2022 to Monday, 5^{th} September 2022.

A number of submissions were received in relation to the proposed road closure. These submissions have been considered and the road closure is approved with amended dates, and mitigation measures in place. The road closure will be in place from Monday, 28th March 2022 to Monday, 3rd October 2022.

The purpose of the proposed closure is to facilitate road works as part of the Blackglen Road improvement scheme.

Pedestrian access will be maintained at all times.

The proposed diversion route will be via the Loop road and all residents access will be maintained.

A traffic management plan will be in place and the diversion will be clearly signposted.

SPEED LIMIT ORDER

Road Works Speed Limit Order, No.1 of 2021 on the <u>M50 Motorway</u> in the County of Dún Laoghaire-Rathdown

Notice is hereby given that Dún Laoghaire-Rathdown County Council, in exercise of the powers under Section 10 of the Road Traffic Act 2004, in the interests of road safety and to facilitate the M50 Traffic Flow Optimisation Construction Project; has made an Order entitled Road Works Speed Limit Order, No.1 of 2021 on the M50 Motorway in the County of Dún Laoghaire-Rathdown to apply a road works speed limit as follows:

M50 Southbound will run from 7th February 2022 until 1st December 2022 or until the end of the works, whichever is the earlier.

Description of speed limit order 80km/hr:

- Part of the Southbound M50 between a point 120 metres South of the existing R117 overbridge to a point 620 metres South of the R117 overbridge (Total 500m in length).
- Part of the Southbound M50 diverge at Junction 14 from the start of the diverge taper to a point on the diverge ramp 420 metres West of the yield line of the diverge off-ramp at Junction 14 (Total 485m in length).
- Part of the Southbound M50 between a point 620 metres South of the existing R117 Overbridge to a point 120 metres South of the M11 Overbridge (M50 Junction 17/M11 J4) (Total 8,000m in length).
- Part of the Southbound M50 merge at Junction 13 from a point 50 metres East of the start of the merge on-ramp at M50 Junction 13 to the end of the merge taper (Total 1250m in length).
- Part of the Southbound M50 diverge at Junction 15 from the start of the diverge taper to a point on the diverge ramp 40 metres West of the stop line of the diverge off-ramp at Junction 15 (Total 555m in length).
- Part of the Southbound M50 merge at Junction 15 from a point 75 metres South
 of the start of the merge on-ramp at M50 Junction 15 to the end of the merge
 taper
 (Total 480m in length).
- Part of the Southbound M50 diverge at Junction 16 from the start of the diverge taper to a point on the diverge ramp 60 metres West of the stop line of the diverge off-ramp at Junction 16 (Total 525m in length).
- Part of the Southbound M50 merge at Junction 16 from a point 65 metres South
 of the start of the merge on-ramp at M50 Junction 16 to the end of the merge
 taper
 (Total 575m in length).

M50 Northbound will run from 3rd August 2021 until 1st November 2022 or until the end of the works, whichever is the earlier.

Description of speed limit order 80km/hr:

- Part of the Northbound M50 between a point 335 metres South of the existing Crinken Lane overbridge to a point 165 metres North of the Crinken Lane overbridge (Total 500m in length).
- Part of the Northbound M50 between a point 165 metres North of the existing Crinken Lane overbridge to a point 300 metres West of the R113 overbridge (Total 8000m in length).
- Part of the Northbound M50 diverge at Junction 17 (M11 Junction 4) from the start of the diverge taper to a point on the diverge ramp 70 metres North of the Lordello Road overbridge (Total 450m in length).
- Part of the Northbound M50 diverge at Junction 16 from the start of the diverge taper to a point on the diverge ramp 55 metres East of the stop line of the diverge off-ramp at Junction 16 (Total 605m in length).
- Part of the Northbound M50 merge at Junction 16 from a point 80 metres West of the start of the merge on-ramp at M50 Junction 16 to the end of the merge taper (Total 700m in length).
- Part of the Northbound M50 diverge at Junction 15 from the start of the diverge taper to a point on the diverge ramp 130 metres East of the stop line of the diverge off-ramp at Junction 15 (Total 500m in length).
- Part of the Northbound M50 merge at Junction 15 from a point 35 metres North
 of the start of the merge on-ramp at M50 Junction 15 to the end of the merge
 taper
 (Total 590m in length).
- Part of the Northbound M50 diverge at Junction 13 from the start of the diverge taper to a point on the diverge ramp 420 metres East of the stop line of the diverge off-ramp at Junction 13 (Total 480m in length).

The Garda Commissioner has been notified by email of the Council's intention to decrease the speed limit to **80 km/hr** on the M50 Southbound and Northbound, in accordance with Section 10 of the Road Traffic Act, 2004.

ROADWORKS / LANE RESTRICTIONS

» Avondale Road, Arnold Park **

Leder Construction Ltd., on behalf of Frank Murphy Construction, will be making a new connection to the public surface water sewer. This will involve excavating a trench along the road from Nr. 30, Arnold Park, to the junction leading to Avondale Road, and then towards the site at "Arkle", 78, Avondale Road.

From Monday 03rd October to 18th October, between the hours of 08:00 and 18:00.

A Traffic Management Plan will be in place.

» Balally Estate (Balally Drive and Park)*

Footpath repairs will take place at this location. The work will end on Wednesday 5th October 2022 works between 08:00 and 18:00 hrs.

A Stop-Go traffic management plan will be in operation

» Stillorgan Wood (Cul De Sac 30 -34)*

Drainage repair works will take place at this location. The work will start on Wednesday 5th October 2022 for 1 week between 08:00 and 18:00 hrs.

A Stop-Go traffic management plan will be in operation

» Rock Rd / Trimleston Avenue***

Stop/ Go traffic management will operate between 9am and 11pm on Sunday 02nd October at the junction of Rock Road and Trimleston Ave.

This work is necessary to install traffic signal ducting.

» Rock Road, Blackrock**

Cycle Improvement Scheme works will commence at this location from Sunday the 02nd October to Friday the 7th October between the hours of 10:00 and 16:00.

The traffic management plan will include - Stop & Go, Plan for Road Narrows, Plan for inside Lane Closure,

»Slieve Rua, Old Kilgobbin Road **

Resurfacing works will commence at this location from Monday the 03rd October until Friday the 07th October, between the hours of 10:00 and 16:00.

A Traffic Management Plan will be in place.

Ballybrack - Watson Avenue and Churchview Avenue, ***

A GPR Survey and associated works will be undertaken on Watson Avenue and Churchview Avenue to continue until Friday, 07th October 2022 between 08:00 and 18:00 hrs.

A Stop / Go traffic management plan will be in operation.

Bellevue Road, Glenageary **

Road reconstruction works on Bellevue Road, Glenageary will continue between 08:00 and 18:00 hrs. Works will continue until Friday, 07th October 2022.

A traffic management plan will be in operation.

Clarinda Park West, Dun Laoghaire **

Construction of traffic calming measures and pedestrian improvements to continue at this location until Friday 07th October 2022 from 08:00 to 18:00.

A traffic management plan will be in operation.

Frascati, Georges Avenue Blackrock ***

Footpath alterations, changing direction of footpath, soft landscape and removal of redundant stop and directional signage will continue until Friday 07th October 2022 between 08:00 and 18:00 hrs.

A traffic management plan will be in place.

Monkstown Farm and Monkstown Avenue***

MCM Surfacing Ltd on behalf of DLRCC are carrying out bituminous road reinstatement works on Monkstown Farm from the junction with Oliver Plunkett Terrace to the junction of Monkstown Avenue up to Lanesville. Works will continue until Friday 07th October between 10:00 to 16:00 hrs.

A traffic management plan will be in operation.

Monkstown, Honey Park Junction***

Installation of new bollards, road markings and hatched areas will continue from, Monday 03rd October to Friday the 7th October between 10:00 and 16:00.

Stop/ Go traffic management plan will be in place.

Shankill, Ferndale Road **

Ward & Burke will conduct trial holing works will continue at this location from Monday 03^{rd} October until Friday 07^{th} October, between 10:00 and 16:00 hrs.

A manned Stop / Go traffic management plan will be in operation.

Stillorgan, Lwr Kilmacud Rd (Leisureplex) **

GMC Utilities, working on behalf of Irish Water, will continue upgrades to the sewer network until Friday 07th October September 2022 between 10:00 and 16:00 hrs.

A 2-way Stop/Go Traffic Management Plan will be in operation.

Ballinteer Road, Ballinteer ***

Ongoing works on wall at Dundrum Wood have ceased for the moment. However, a new footpath layout has been implemented. This will be maintained until the issues with a dangerous wall are resolved.

A traffic management plan will be in operation.

Ballyogan, Ballyogan Drive/Park **

Installation of ESB electrical duct commencing on public footpath from Ballyogan Park and progressing eastwards on Ballyogan Park road to the eastern verge of Ballyogan Drive and hence progressing southwards on this verge to the entrance to the new Ballyogan Square Residential Development on Ballyogan Drive. From Monday the 26th September to Friday 21st October, between the hours of 08:00 and 16:00.

A Traffic Management plan will be in place.

Blackrock - Junction of Bath Place to Junction of Idrone Terrace *** GMC Utilities, working on behalf of Irish Water, are carrying out mains water upgrade works to the network from Monday 29th August until Sunday 10th October 2022

between 08:00 and 18:00 hrs.

A Road Closure and Diversion route will be in operation.

Churchtown Road Lower ***

- between Junctions with Churchtown Road Upper and Orwell Road

Actavo, on behalf of Dún Laoghaire-Rathdown County Council, commenced the installation of a traffic calming scheme, the works will consist of footpath widening, zebra crossings, uncontrolled crossings and raised tables. Works will take place between 10:00 and 16:00 hrs.

A traffic and pedestrian management plan will be in operation.

Clonskeagh Road Cycle Scheme ***

Provision of footpaths, cycleways, junction buildouts, new kerbing, and all associated works will continue until 30th November 2022 between 10:00 and 16:00 hrs.

Major cleaning works to continue on the N11 until 25^{th} October between 05:00 and 15:00 hrs.

Phase #3 on 24th & 25th UCD to Leopardstown Junction out-bound

Phase #4 Leopardstown Junction to Loughlinstown Roundabout outbound

Wyattville Road Cycle Scheme ***

Provision of footpaths, cycleways, junction buildouts, new kerbing, and all associated works will continue until 30th November 2022. Works will take place between 10:00 and 16:00 hrs. The location for the works is Wyattville Road between Church Road and Churchview Road, including the associated junctions.

A traffic management plan will be in operation.
