NOTES

I. Trade name should be stated as it appears on invoices issued from / signage at the premises to which the application applies

II. If different from the name of the applicant, as indicated in Section 1, the registration will be held in the name of the owner as indicated in Section 3. Otherwise registration will be held in the name of the applicant as owner, as indicated in Section 1

III. The European Union (Waste Electrical and Electronic Equipment) Regulations 2014 may be found under Related Documents

IV. Common examples of types of equipment in each of the categories are as follows:

- 1) Large Household Appliances: Fridge Freezers, Washing Machines, Dishwashers, Electric Stoves
- 2) Small Household Appliances: Vacuum Cleaners, /irons, Toasters, Coffee Machines, Clocks
- 3) IT and Telecommunications Equipment: PCs, Laptops, Printers, Calculators, Telephones
- 4) Consumer Equipment: Televisions, Video Cameras, Musical Instruments, Radios
- 5) Lighting Equipment: Fluorescent Lamps, High Intensity Discharge Lamps
- 6) Electrical and Electronic Tools: Drills, Sewing Machines, Nail Guns, Soldering Irons
- 7) Toys, Leisure and Sports Equipment: Electric Trains, Video Games, Sporting Computers, Coin Slot Machines
- 8) Medical Devices: Radiotherapy Equipment, Pulmonary Ventilators, Dialysis Equipment
- 9) Monitoring and Control Instruments: Smoke Detectors, Heating Regulators, Thermostats
- 10) Automatic Dispensers: Hot Drinks Dispensers, Cold Drink Dispensers, Money Dispensers

V. Whereas the European Union (Waste Electrical and Electronic Equipment) Regulations 2014 exempt retailers from having to possess waste collection permits and waste licences in certain circumstances, it is important to note that registration does not dispense with any statutory requirement to comply with Sections 34 (1) and 39 (1) of the Waste Management Acts 1996-2015 concerning waste collection permits and the requirement to hold a waste licence.
