Arts and Inclusion Exploration Commissions 2021

With the onset of Covid 19, artists and arts organisations working in the Arts and Health and Arts and Disability sectors have been seeking ways to engage with participants and services to continue their practice. These two commissions with a budget of €5,000 each are aimed at supporting an artist/arts organisation who work or intends to work with people in either the field of Arts and Health or Arts and Disability in Dún Laoghaire-Rathdown County.

dlr Arts Office proposes to offer these commissions to allow an artist or an arts organisation the time, space and reflection to continue to find and develop new ways of forging their practice with some of our most vulnerable residents.

These opportunities are funded by the Arts Council and supported by Dún Laoghaire Rathdown County Council.

Brief

Exploration and engagement are at the heart of these commissions. The process of working with people in these sectors through the Winter of 2021 is of the upmost important, and the experience for the artist/arts organisation and the participants is the central focus of these commissions; not a final or finished 'piece'. It is envisaged that any 'outcome/s' from these commissions will come entirely through this process rather than anticipated at the onset. dlr Arts Office is open to the form that these may take.

We are open to all art forms and the artist/arts organisation may wish to work with participants from any age profile - from babies to older people - in the County in the area of Arts and Health or Arts and Disability. The artist/arts organisation may wish to work with a newly formed group of participants or an existing group. These could be linked to a service in either the health or disability sectors in Dún Laoghaire-Rathdown County.

The fee is €5,000 per commission to include all expenses (VAT inclusive). The commissions must be completed by January 2022.

Application Procedure

- Curriculum Vitae/s of artist/arts organisation. Provide a C.V. with full details of prior relevant experience. This should outline experience of working with people and/or services in an Arts and Health or Arts and Disability context.
 - Supplementary materials may be provided.

2. Outline of approach: A statement (max 2 x A4 pages) outlining how the artist/arts organisation intends to further their practice with this commission opportunity. This description must include initial thoughts as to what potential participants may experience; we would like to get a sense of why they might like to get involved in these commissions. If appropriate, a letter of support from the potential participants/service would be welcome and will aid assessment. This statement must clearly demonstrate an understanding of working with in an Arts and Health or Arts and Disability context.

Late applications or applications that do not include all the above requirements will not be accepted.

Selection Criteria:

The following criteria will apply and be weighted accordingly:

- **Demonstrated experience** of working in a collaborative manner in an Arts and Health and/or Arts and Disability context through arts practice (Supporting documentation may be included). **70%**
- Outline of approach to this commission. This will be assessed on the basis of the statement included as per no. 2 above. **30%**

In accordance with national child protection policy, Children First National Guidelines for the Protection and Welfare of Children, awarded recipients working with children must have a child protection policy, proper procedures and a child safeguarding statement in place.

Freedom of Information:

Applicants should state if any of the information supplied by them is confidential or sensitive and should not be disclosed to a request for information under the aforementioned Act.
