Loneliness Among Older People

Mr. Tom Conlon

"As the issue of loneliness among older people is a key aspect of the Age-Friendly Strategy, I would like to receive copies of all research or consultancy reports (together with any assessments of them) carried out by or on behalf of the Council in the last four years into (a)

the extent of loneliness among the older population in the County, (b) the needs of the lonely or (c) possible initiatives to alleviate loneliness".

Reply:

The Council is not aware of any specific recent studies undertaken in relation to loneliness in Dun Laoghaire Rathdown. The issue of loneliness and supporting efforts to alleviate loneliness is taken into account in the development and on-going implementation of the dlr Age-Friendly Strategy. Consultation was undertaken in the development of the dlr Age-Friendly Strategy with people across dlr to assess views on a range of issues and challenges affecting older people's lives. Good progress is being made on delivering the Strategy, and there are a range of Age Friendly activities being delivered to support and promote wellbeing and social engagement throughout the County.

DIr has also recently fed into the Loneliness Taskforce's report A Connected Island – An Ireland Free From Loneliness which aims to address the key issues surrounding Loneliness in Ireland today. We also provide and support many local groups and initiatives such as Befriending Services, Support Co-ordination Service, Safety & Security Events for Older People along with social activities such as coffee mornings and tea dances with the aim of identifying and combating potential loneliness with dlr.

The reply to Question 3 a) was **NOTED.**

Exit 15 Project Overview and Update

Dr. Victoria Durrer, Lecturer in Arts Management and Cultural Policy, Queen's University, Belfast, gave a presentation on the Exit 15 Project, and highlighted the project's support of the development of the arts in Ballyogan area and in exploring the area's sense of community. The presentation outlined the engagement by local groups and projects, and impact of the project as part of a sequence of events in a learning framework.

Following discussion, Dr. Victoria Durrer, Dearbhla Lawson and Maire Davey responded to the Members' questions and Dr. Durrer was thanked by Councillor Lettie McCarthy, and the update was **NOTED**.

Grainstore Programme Update

Ms. Louise Costelloe, Grainstore Manager, gave a presentation update on the Grainstore, dlr's youth arts facility. The key highlights from the last 12 months, the programme and the partnerships. Following a discussion during which Louise Costelloe responded to the Members queries, the report was **NOTED**.

<u>Councillor D. Donnelly - Introduction of walking/running trails in all our parks/green spaces</u>

"To ask this Committee, following the last meetings report on a Healthy County and in the interest of promoting health and fitness amongst all ages, to support the introduction of walking/running trails in all our parks (and where possible green spaces). This could involve marked distances at intervals (as in Clonmore Park), support of Slí na Sláinte initiatives (as in Leopardstown Avenue) and maps (similar to walking routes provided by Belfield) that could be promoted to community groups, schools and other organisations across the County."

Following a discussion during which Ms Dearbhla Lawson, Director of Community and Cultural Development responded to the member's queries. She outlined that the SPC Work Programme included Healthy Ireland Policy updates, and that this item could be referred to Municipal Services Department as it relates to operational issues.
