

## **THE FOLLOWING COMPLAINTS ARE NOT INVESTIGATED BY THE COUNTY COUNCIL:**

### **Aircraft Noise Complaints**

Aircraft noise is exempt from the EPA Act 1992. The Council's EHOs do not deal with complaints about aircraft. You can contact the Dublin Airport Authority on 1800 200 034 to advise them of your complaint.

### **Traffic Noise Complaint**

The Council's EHOs do not deal with complaints about traffic emissions. Public transport emission queries are dealt with by An Gardaí Síochána's Traffic Department, Dublin Castle, Dublin 2, on 01 666 9800.

### **Noise from Roadworks**

All road works must have a permit that is issued by the Traffic Management Section of Dún Laoghaire-Rathdown County Council. The times permitted vary depending on the permit. Contact Traffic Management at [info@dlrcoco.ie](mailto:info@dlrcoco.ie)

### **Dog Barking Complaint**

### **Noise caused by public transport – Irish Rail / LUAS / Dublin Bus**

Complaints about traffic noise are not dealt with by the Council EHOs. Complaints regarding noise from public transport **depots** can be investigated by the Council EHOs.

### **Noise from beer gardens / smoking areas**

Complaints about noise from patrons in beer gardens or outdoor smoking areas are not dealt with by the Council's EHOs. A private action can be taken to the District Court under Section 108 of the EPA Act 1992. See [here](#) for more details.

### **Noise disturbance from individuals on the public thoroughfare / Anti-Social Behaviour**

The Council's EHOs do not deal with noise nuisance caused by individuals behaving in a loud or rowdy manner. When such instances occur on a public thoroughfare, then it may be a public order offence and should be dealt with by An Garda Síochána. [Contact your local Garda station](#)

### **Faulty / Modified vehicle exhausts**
