# **Creative Responses – Marlay House**

The Dún Laoghaire-Rathdown Heritage Office invites arts and crafts practitioners to submit proposals for participation in a pilot initiative. This initiative is funded by the Creative Ireland Programme, and is subject to a very short timeframe due to funding requirements.

# **Commission Details**

The commission will involve creating a new artwork in any medium in dialogue with an artefact within Marlay House, using processes intrinsic to individual creative practices.

The aim of the initiative is to explore new ways to interpret, present and open up discussion about the stories of the house.

## Eligibility

Applications are invited from artists who are living in, working in or originally from Dún Laoghaire-Rathdown or who have studied a relevant discipline in the County.

#### What we offer

- Artist commission of €3,500 we will be selecting two artists for this project
- Guided tour of the house and its artefacts/artwork
- DLR will prepare an online and printed publication to mark the occasion of this pilot initiative

## What is expected of the artist

- To visit Marlay house and choose an object as inspiration for a new artwork in any medium
- To complete the work within the required timeframe (note: working space is not provided as part of this commission)

• To engage with a project videographer/photographer commissioned by Dún Laoghaire Rathdown County Council to document the process

## **Marlay House**

Marlay House was mainly built in the 18<sup>th</sup> century, but includes older parts dating to the 17<sup>th</sup> century. The artefacts within Marlay House relate to the individuals who lived and worked there and constitute an important element of the history of the local area, the development of landed estates in Ireland, the Irish banking system, wealth generation within the broader global social and economic context, and the modern role of public custodianship and curatorship.

Marlay House is a place rich in stories from across centuries, and houses a range of furniture, artworks and interiors spanning from the 17<sup>th</sup> century to the present. The artist Evie Hone formerly worked in the courtyard and a number of her paintings are on display in the house. Marlay House has been in public ownership since the 1970s and the former demesne has been transformed into an extensive and popular park.

# **Selection criteria**

Applications will be adjudicated by the dlr Heritage Office and independent adjudicators with appropriate expertise. The decision of the selection panel is final. Submissions will be evaluated using the following criteria:

- Suitability of outline proposal to the context (40/100)
- Quality of previous work (40/100)
- Experience of delivering projects/commissions within set budgets and timelines (20/100)

Two participants will be invited to participate in the initiative.
