#### Musicians-in-Residence Scheme 2021

## **Guidelines for Applicants**

Closing Date: Wednesday 31st March 2021 at 2.00pm

The Dún Laoghaire-Rathdown County Council Musicians-in-Residence Scheme is jointly funded by Dún Laoghaire-Rathdown County Council and the Arts Council, and is managed by Music Network. Three residencies are offered in 2021: two for established musicians/groups and one for an emerging musician/group. Residencies will take place in May – July, August – September and October – November 2021.

## Aims and objectives:

The aim of the Musicians-in-Residence Scheme is to provide opportunities to develop and showcase new work which may be compositional and/or performance focused i.e. to create new material and/or to develop a new artistic collaboration. The cultural environment of Dún Laoghaire-Rathdown and beyond will be enriched through engagement by the musicians with a broad demographic via presentations of a series of digital updates to illustrate the creative process throughout and a final performance at the end of each residency to showcase new work.

The primary objective is to provide opportunities for musicians to create and develop new work.

Additional objectives are to:

- create opportunities for musicians to showcase new work
- develop musicians' skills in relation to collaborating and presenting online
- support musician career development through advice and/or mentorship
- provide the public with an opportunity to gain insight into the creative process and access high quality music performances.

## Who can apply?

- established and emerging individual musicians and groups
- musicians working in all genres.

**N.B.** <u>applicants (including all members of any group) must demonstrate a strong connection to Dún Laoghaire-Rathdown, i.e. live, work, be originally from or have studied in, Dún Laoghaire-Rathdown.</u>

## What does each residency involve?

The residencies will be part-time in format, taking place over non-consecutive dates within an approximate two month period. Please note that for 2021, Residency 1 will be delivered completely online. Musicians applying for residencies 2 and 3 should prepare and submit a proposal which is adaptable for both online and/or in-person delivery. Depending on Covid-19 restrictions and availability of the dlr Lexicon Studio, where possible, activities will take place in-person in the studio, however all activities proposed for residencies 2 and 3 must also be suitable for online delivery if necessary.

# Each Residency for established musicians/groups includes:

- allocation of 10 development days within a 2-month period to develop new work. (For 2021 there is no guarantee that these will be onsite days in dlr Lexicon Studio)
- engagement with local and wider communities through a series of exciting artistic offerings:
  - 4 digital updates on social media to take place throughout the residency. These activities could include open rehearsals, live chats/interviews, recorded audio plus text or filmed excerpts etc. to provide insight into the creative process. Formats for these events will be flexible and in line with what each musician feels best suits their methods and creative process
  - 1 public concert presented online or in dlr LexIcon Studio (Studio applicable to residencies 2 & 3 only). This performance will take place at the end of the residency.
- advice and support offered by Music Network, to include artistic, career, PR and social media advice, as required
- mentoring sessions beneficial for professional development with external experts (N.B. if proposed, these must be included in the project proposal and budget)
- completion of a short report by the musicians-in-residence at the end of each project.

Maximum available budget: €5,000 (VAT inclusive).

## The Residency for an emerging musician/group includes:

- allocation of 6 development days within a 6-8 week period to develop new work
- engagement with local and wider communities through a series of exciting artistic offerings:
  - 4 digital updates on social media to take place throughout the residency. These activities could include open rehearsals, live chats/interviews, recorded audio plus text or filmed excerpts etc. to provide insight into the creative process. Formats for these events will be flexible and in line with what each musician feels best suits their methods and creative process
  - 1 public concert presented online or in dlr LexIcon Studio (Studio applicable to residencies 2 & 3 only). This performance will take place at the end of the residency.
- advice and support offered by Music Network, to include artistic, career, PR and social media advice, as required
- mentoring sessions beneficial for professional development with external experts (N.B. if proposed, these must be included in the project proposal and budget)
- completion of a short report by the musicians-in-residence at the end of each project.

Maximum available budget: €3,000 (VAT inclusive).

#### **Additional Information:**

For residency 1, there will be no access to the dlr LexIcon Studio.

For residencies 2 & 3, development days and each final concert may take place in dlr LexIcon Studio, depending on Covid-19 restrictions and availability at the time.

N.B.: the Studio has no in-house tech staff - for additional information and tech spec *The Studio-Technical Information Guide* for dlr Lexlcon Studio is available on request. Any person working with the selected musician(s) who will be accessing equipment in the dlr Lexlcon Studio must be suitably qualified. If tech staff, recording equipment or additional PA equipment are required for performances, arrangements must be put in place by the applicant and related costs accounted for within the applicant's budget. Please note that there is limited access to the Studio lighting rig.

Applicants should make provision for Public Liability Insurance within their residency budget (for inperson activities in dlr Lexicon Studio), and if necessary, Employers Liability Insurance, as this is a requirement of funding. (please refer to the section on Insurance in Appendix 1 below)

Applicants should note that the residency budget must include <u>all</u> costs associated with online and/or in-person activities, such as technical equipment, videographer, sound engineer, collaborating musicians etc. All details should be included in the proposal outline and budget supplied. The creation of an online concert video for broadcast is a requirement for all three residencies. In the event that a live performance with audience is possible for residencies 2 & 3, costs associated with filming the performance in the Studio should be included by the musician within their residency budget and dlr Arts Office will make a small additional budget available for the provision of live sound.

## 2021 Residency Calendar:

Residency 1: mid-May – mid-June (online delivery only)

Residency 2: August – September (online/in-person delivery, depending on Covid-19 restrictions)

Residency 3: October – November (online/in-person delivery, depending on Covid-19 restrictions)

Dates for all residency activities within the above periods are flexible and will be discussed and agreed with awardees. Applicants should list, in order of preference, the residency period they would prefer. Proposals for online delivery can be submitted for all three residency periods. Proposals for in-person delivery can only be submitted for residencies 2 and 3 but these proposals must also include a viable proposal for online delivery.

## Programme of work:

The details of each Residency Programme will be agreed in consultation with Music Network, DLR Arts Office and the selected musicians. Music Network will supervise the programme and advise musicians throughout. DLR Arts Office will liaise with the musicians regarding logistical arrangements for in-person delivery of residencies i.e. finalising dates for development work & concert performances and liaising re insurance arrangements.

## Selection criteria:

- artistic quality and track record in music performance/composition (N.B. for emerging musicians, demonstrated potential will also be assessed) (45%)
- quality, coherence of proposal (artistic plan, collaborating musicians, ideas on content of performances and digital updates, audience engagement etc.) (30%)
- feasibility of proposal (including the approach to facilitating collaboration/development work and the presentation of performances both online and in-person) (15%)
- demonstrated ability in project & budget planning and management (10%).

**N.B.** it is important to consider <u>all</u> of the above criteria carefully when preparing your application as this is a competitive process and all four will be taken into account during the assessment process.

# **Application procedure:**

Applicants must submit their application to Music Network by email to operations@musicnetwork.ie. Hard copy applications will not be accepted. Late applications will not be accepted. Closing date for applications: Wednesday 31<sup>st</sup> March 2021 at 2.00 p.m.

## All of the following must be supplied for your application to be eligible:

- 1. an outline of your proposed programme of work including artistic ideas and approaches, the benefits of the residency to you at this stage of your development as a musician, a list of any collaborating musicians and suggested outlines for the performance and 4 digital updates to showcase development during the residency. Include plans for both online and in-person delivery if applying for residencies 2 or 3. (maximum 3 x A4 pages)
- 2. a short statement outlining your connection to Dún Laoghaire-Rathdown (applicable for all musicians involved in the application
- 3. your CV (maximum 2 x A4 pages)
- 4. biographies of any proposed collaborator(s) ( maximum 1 x A4 page per collaborator)
- 5. links to 3 sample audio/video tracks (via dropbox, soundcloud or youtube): while professional standard recordings are not essential, they should reflect the artistic quality of your work, and ideally the artistic concept proposed
- 6. 1 minute video clip (e.g. recorded on a mobile phone) which briefly outlines your goals and what you hope to achieve creatively during your residency
- 7. a detailed budget for your programme including proposed fees (for you and any proposed collaborator(s)/mentors) and other programme expenditure). Include separate breakdowns for both online and in-person delivery for residencies 2 & 3.
- 8. confirmation of your availability for each residency period you are applying for, listed in order of preference.

**N.B.** please note that successful candidates will be required to undergo Garda Vetting (if engaging directly (online or in person) with under 18's or vulnerable persons) and provide proof that appropriate insurance arrangements are in place in order to commence their residency.

Additional supporting documentation may be provided at your discretion, such as publicity photographs and selected press reviews.

#### **Information Webinar:**

Music Network will present an information webinar on March 11th 2021 at 11 a.m. to outline details of the scheme and to answer any specific questions. Musicians wishing to attend this webinar should book a place <u>here</u>.

Advance registration is essential. A recording of the webinar will also be made available on Music Network's website social media channels from 12th March 2021.

## Assessment procedure:

A panel will consider all applications received, and make decisions regarding residency allocations.

## **Notification of decisions:**

Music Network aims to inform applicants about decisions in April 2021. All notifications will be sent by email. Please note that Dún Laoghaire-Rathdown County Council reserves the right not to appoint if none of the applications received are deemed suitable. In this instance Dún Laoghaire-Rathdown County Council reserves the right to pursue a different selection process. Dún Laoghaire-Rathdown County Council also reserves the right to amend the number of residencies and/or the scheduling of residencies in response to submissions received.

#### Feedback:

Feedback is readily available upon request where an application has been unsuccessful, for four weeks following communication of results. # PR, Marketing and Publicity:

Musicians will be required work together with Music Network and DLR Arts Office to promote the performances/digital updates and to provide PR materials, as required, including:

- biographical material
- high resolution colour photographs in digital format
- programme information.

Music Network and DLR Arts Office will promote residency activities through their websites, enewsletters and social media. All publicity materials (hard & soft copy) <u>must</u> carry the below line of acknowledgement and the following logos: DLR Arts Office, The Arts Council and Music Network, which Music Network will provide to awardees.

## Appendix 1: Payments/Insurance/Child Protection/Freedom of Information/GDPR

#### **Payments:**

Payments to each Musician-in-Residence will be made by Music Network through a 2-stage process. Specified requirements must be met before payment is made at each stage. These and the accompanying payment schedule will be outlined at the initial meeting between the musician and Music Network.

## Insurance:

Selected musicians agree to keep Dún Laoghaire-Rathdown County Council fully indemnified against all claims howsoever arising and howsoever caused in respect of any damage, loss or injury of any kind or nature, whether arising directly or indirectly from the provision of the residency. Evidence of Public Liability insurance indemnifying the Council with an upper limit of €6.5 million will be required.

If selected musicians engage others to collaborate with during their residency they must also have Employer's Liability Insurance of €13 million in place which indemnifies Dún Laoghaire-Rathdown County Council. It is also their responsibility to ensure that collaborating musicians engaged by them have Public Liability cover of €6.5 million which indemnifies both Dún Laoghaire-Rathdown County Council and the musicians.

#### **Child Protection:**

The successful candidate will be required to undergo Garda Vetting if engaging with persons that are deemed vulnerable under the National Vetting Bureau (Children and Vulnerable Persons) Act 2013 and provide any additional relevant documentation requested by Dún Laoghaire-Rathdown County Council.

## Freedom of Information:

The provisions of the Freedom of Information Act 1997-2003 apply to Dún Laoghaire-Rathdown County Council. Applicants should state if any of the information supplied by them is confidential or sensitive and should not be disclosed to a request for information under the aforementioned Act. Applicants should also state why they consider the information to be confidential or commercially sensitive.

# GDPR:

All information provided for this application will be held in line with this Local Authorities Protection Policy and Music Network's Protection Policy and will remain in the sole ownership of Dún Laoghaire-Rathdown County Council Arts Office and Music Network. Information supplied in the application will only be used by dlr Arts Office and Music Network for the purposes of administering and managing this particular Scheme. # **Appendix 2: Background Information**

## dlr Lexicon Library, Dún Laoghaire:

In Autumn 2014 dlr Lexicon, the new Central Library & Cultural Centre, opened to the public. This iconic public building is a crucial part of a programme of regeneration in Dún Laoghaire. It includes a major commitment to provide public facilities and represents the single biggest investment by the Council in a civic amenity. dlr Lexicon is a key component in the delivery of the cultural programme in Dún Laoghaire-Rathdown and its environs.
