#### LA 2 Archives of the Dalkey Township

Although Dalkey is recorded as having received a charter of incorporation by a 1358 enrolment of 33 Edward III its had the smallest record representation of any of the five local authorities. It contains no correspondence or legal material and the fifty-nine items in the collection which date from the first meeting of the Township Commissioners on 17 August 1863 consist almost wholly of minutes and rate books. Included is a Register of Interments for the old Dalkey graveyard 1901-1911 (LA 2/58).

#### 1: Town Commissioners and U.D.C.

17 August 1863 - 13 October 1930

Proceedings of monthly, annual and special meetings of the Dalkey Township Commissioners and Urban District Council from its first meeting in the Queen's Hotel, Dalkey, 17 August 1863, convened on the order of the Lord Lieutenant pursuant to the Towns Improvement Act, 1854. Records attendance, resolutions, correspondence, administrative activity, the formation of standing and sub-committees and the presentation of their minutes, appointment and remuneration of officials and the receipt of regular reports from the town surveyor, engineer, sanitary inspector and medical superintendent, the approval of estimates, striking of rates, examination accounts, implementation of lighting, road, drainage and housing improvement schemes, passage of bye-laws and adoption of enabling legislation Vols. 1, 4, 5 and 6 include indexes.
