Procurement Compliant Checks 2022

The Dún Laoghaire Rathdown County Council Procurement Plan 2022-2024 states that the Procurement Unit will report on corporate compliance with procurement policy and legislation. Monthly reports are run by the procurement unit and five suppliers procured by each senior are selected - 2 between 10k and 25k, 2 over €25k and one over the EU threshold (€215,000). Any anomalies between supplier, goods/service procured, or the account element are queried.

Across all departments a total of 201 compliance checks have been carried out in the first 3 quarters of 2022. The results of these checks are shown in the below graph:



Of the 201 checks carried out, there was a 71.64% response rate – the procurement unit is continuing to liaise with departments to get complete responses to these checks.

Of the responses received to date, 91.67% were deemed to be fully compliant with procurement policy, 3.47% were deemed to be complaint with national policy but non-compliant with DLR policy and 4.86% were deemed to be non-complaint with National Procurement Policy.



In all cases of non-compliance, the Procurement Unit reviews the reasons for non-compliance and liaises with the relevant purchasing staff to ensure that they have a full understanding of procurement policy and practices.





Freedom of Information

There was 9 of FOI requests received during the month of November.



The Ballyogan Regional Temporary Rest Centre opened its doors to Ukrainian nationals on 28 April. The Rest Centre continues to accommodate up to 300 displaced Ukrainian nationals for short periods. Over 3,000 people have stayed at the centre for short periods.

As part of a comprehensive wrap around service, accommodation services at the Centre are being supported by HSE staff including Environmental Health, Public Health and COVID-19 services. The HSE is providing onsite support to meet the healthcare needs of Ukrainian residents, and residents also have access to an offsite GP service 7 days a week.

Among the facilities available in the temporary rest centre is separate laundry and sanitary facilities, internet access, television spaces, games consoles, games room, chessboards, use of bikes and scooters, libraries of Ukrainian books for children and adults, translation services, as well as online access to Ukrainian newspapers and magazines.

Additionally, orientation and information sessions, basic English language lessons and an arts and music entertainment programme is being developed both onsite and nearby offsite.

Local coordination efforts continue to provide comprehensive support services from Southside Partnership, HSE, An Garda Siochána, Department of Social Protection, dlr Education and Training Board, TUSLA, Community and Family Resource Centres, dlr Volunteers Centre, colleagues in the East Region and a number of other community and voluntary groups.

Work is now underway to provide extra facilities, including 92 extra beds, a homework club room for children, an adults workspace, and a new improved space for teenagers.

Bus Connects

The Traffic Section, with cross departmental input, made a submission to ABP with respect to the proposed CBC. ABP has advised that the decision due date for this planning application, has been put back to before April 7th,2023. Regarding the Bray to City Centre CBC planning application, the NTA has advised that the submission of this application to ABP is now envisaged in Q1, 2023.

Bus Interchanges at Dundrum, Dun Laoghaire & Blackrock

Discussions are ongoing with the NTA regarding bus interchange improvements at both Dundrum and Dun Laoghaire. The improvements are needed to cater for the planned service increases under the BusConnects' programme. Meetings/workshops are ongoing to progress this work and a multi-disciplinary group from the Council is in place to assist. In addition, discussions are also ongoing with the NTA regarding potential public realm improvements in Blackrock and the impact on the existing bus interchange and bus services.

Area Based Transport Assessments (ABTAs)

Dundrum ABTA - Work on this project is progressing and the ABTAs Stages 1 & 2 now completed with work on Stage 3 – Options Assessment & Development and Stage 4 - Preparation of a draft Local Transport Plan, now at an advanced stage.

Leopardstown Racecourse South ABTA – Discussions have commenced with the Land Development Agency, the NTA and TII on the preparation of an ABTA for the Racecourse South lands at Carrickmines, in accordance with the requirements of SLO 143 in the current County Development Plan.

New Development Areas – Kilternan – Glenamuck, Old Connaught – Rathmichael, – Following discussions with the NTA, it has been agreed that the Old Conna ABTA study, commenced in 2019 and on hold since 2020, should not be completed due to outdated policy and context. It is anticipated that new ABTA studies based on updated policy and strategic context will be required for new development areas in the southeast of the county.

3. Water & Drainage

Drainage and Flood Alleviation

Engineering and Environmental Consultants were appointed in December 2019 for Flood Risk Management works on the **Deansgrange Stream**. This is a 4-to-5-year project. Activities completed to date include additional survey work, CCTV surveys, a Constraints Study, Hydrological analysis, and hydraulic modelling. Optioneering, environmental surveys and engagement with key stakeholders are underway. A Ground Investigation Contract is complete, and the report is awaited. Work has begun to review possible sites



for environmental impacts. We have received preliminary approval from Irish Rail to tunnel under the rail line. Public Consultation on the proposed scheme is taking place in December 2022.

Engineering and Environmental Consultants have also been appointed for Flood Risk Management Works on the **Carrickmines/Shanganagh Rivers**. This is a 5+ year project. Data gathering is underway. A Flow/Rainfall Survey is complete. Further topographical survey work has been done. Early damage/benefits assessments are underway to ensure a cost-beneficial scheme is achievable. An initial public engagement is complete following short briefing sessions with Area Councillors. The Hydrology/Hydraulic report is now complete and initial options are being developed. A Contractor has been appointed for the Site Investigation. Work is well underway on the site investigation.

The Monkstown environs flood risk mapping project is underway. The topographical survey is now largely completed. The flow/rainfall survey is now completed, and the CCTV survey is well underway. Draft flood maps have been produced and reviewed.

4. Roads Control Unit

Irish Water Reinstatement IWR Works 2022

Roads Control Unit is continuing to carry out the permanent reinstatement works throughout the administration area of Dún Laoghaire-Rathdown County Council (DLRCC) according to the current service level agreement (SLA) between Irish Water and DLRCC. In 2022, 594 no. locations have been received and 538 no. fully reinstated.

Cleansing, Beaches & Coastal Protection Updates - November 2022

- Coliemore Harbour: An Bord Pleanála (ABP) granted a Part 10 Planning application for the installation of Rock Anchors on the Southern Pier access route. Due to winter weather restrictions, it is expected that the onsite works will commence in March of 2023 and run for approximately 8 weeks.
- Quinns Road The beach access repair works were tendered and a contractor has been selected. Access and compound conditions are under review and Local Councillor and Resident Group notifications will be commence is due course. It is expected that the on-site works will start in early 2023.
- 40 Foot Remedial Repairs Material and fabrication lead times have delayed the project and it is currently expected that the project will be completed in late 2022 or early 2023.
- Redlough Landscapes Ltd weeding contract came to an end in early November. However, additional minor weeding works are now under consideration.
- Public Realm cleaning is on-going presently with power washing and furniture cleaning.
- DLR Baths maintenance equipment has been ordered for the future handover of this space to the Cleansing team. On site Risk Assessments and adverse weather procedures need to be developed and agreed.
- Gully Cleaning and Road Sweeping overtime has occurred due to the recent wet weather and heavy leaf fall.
- Early morning sweeping and gully cleaning operations have been on-going. Traffic Management licences have been submitted and granted where applicable.
- The Road Sweeping and Cycle Lane Sweeping schedules have been temporarily suspended since the 27th of October due to the leaf fall season. The sweeping schedules will be reinstated in early 2023.
- Blue Flag submissions are being prepared for Seapoint and Killiney Beaches.

We had approximately 72 Cruise Ships booked into the Harbour in 2022. 3 ships cancelled due to weather. Overall, the Harbour was being well received by ship management, cruise guests and the crew who come ashore. We are now doing a full review of the 2022 season with our various stakeholders and beginning to plan for a busier 2023 season with 90+ ships booked at present.

Grant Funding

The Brexit Adjustment: Local Authority Marine Infrastructure Scheme 2022 – 2023 from the Department of Agriculture, Food and the Marine has launched a Second Tranche call for applications. Dun Laoghaire Harbour received over €3 million in grant funding from the first tranche. We have submitted 5 grant applications to this scheme by the deadline of 30th September 2022. We await the outcome of the grant process.

Projects:

National Watersports Campus

DLRCC in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We have responded to requests for additional information and are now finalising the grant process and agreements with the project partners. An MOU has been signed with Irish Sailing and Diving Ireland in order to set out and agree the objectives of the project.

DLRCC and Irish Sailing are developing a brochure/prospectus for the project to detail the project vision and scope. It is hoped that this initiative will assist in building momentum and support for the project. This document will be presented to councilors in January 2023.

Berth 2 Fenders (Carlisle Pier)

A project to replace the Berth 2 fenders has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project. This project was tendered, and Sorensen Construction have been appointed to deliver the project. We are awaiting Foreshore consent to proceed to works on site.

Grant funding has recently been secured for the installation phase of this project from the recent Brexit Local Authority Marine Infrastructure Scheme.

Berth 3 Fenders (Carlisle Pier)

Grant funding has recently been secured for a project to replace the Berth 3 fenders from the recent Brexit Local Authority Marine Infrastructure Scheme. The project has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project as it is a mirror image of the Berth 2 fender project.

East Pier Revetment Repairs

Grant funding has recently been secured for a project to repair the sloping revetment at the back (east side) of the East Pier from the recent Brexit Local Authority Marine Infrastructure Scheme. This revertant provides the primary protection for the East Pier and has suffered some damage over recent years from the larger storms. Punch Consulting Engineers have been appointed to design and manage the project which is likely to be on site during the summer of 2023. Surveys are now complete, and we await the final survey reports. Thereafter design work will commence on the repair project.

Ferry Terminal

Planning permission was granted for the ferry terminal project on 7th February 2020. A planning appeal was lodged to An Bord Pleanála. An Bord Pleanála have now granted permission for the development.

A business briefing on the ferry terminal proposal was delivered to the elected members by Hilary Haydon on 25th February 2020. An agreement to lease the building (subject to



Foreshore and Section 183 consent) was signed in December 2021, and the Foreshore Lease has been agreed with the Dept.

This matter was brought to the full June Council Meeting and the Section 183 Disposal passed. The Legal Department is now dealing with closing the lease process so the new tenant can begin occupation.

Dublin Array Windfarm

The developers of the Dublin Array Windfarm have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. Early engagement is ongoing with the developer's team to establish the exact requirements.

Coastival Festival 2023

The Biennial Dun Laoghaire Regatta is due to take place in July 2023. We are working with several DLRCC departments to expand this into a week-long festival names "Coastival" for the Dun Laoghaire Town and Harbour areas. This is planned to run from $1^{\rm st}-9^{\rm th}$ July and many DLRCC departments are involved in putting together a schedule of events.

Academy of Urbanism Awards

The Architects' Department was delighted to be part of the cross departmental team associated with the 'Great Town' Award received by Dún Laoghaire in London on 23 November 2022. The LA's investment in high quality capital projects and the urban framework plans which have guided incremental development in the town over a number of years impressed the judges and demonstrate the benefit of a plan-led approach.

Energy

The cross-departmental 'Reduce Your Use' dlr working group held its first meeting at the beginning of November. The SEAI and OPW 'Reduce Your Use' campaign material is adapted for weekly dlr social media posts as part of an energy awareness campaign for staff and the general public. It also featured in an episode of the dlr Insights Podcast. In addition, the dlr campaign was mentioned in the Irish Times and will feature in the winter edition of the dlr Times. The working group has also designed informative energy awareness notices which will be displayed alongside Christmas lighting displays illuminated at the end of the month around the county.

- Coliemore Harbour: An Bord Pleanála (ABP) granted a Part 10 Planning application for the installation of Rock Anchors on the Southern Pier access route. Due to winter weather restrictions, it is expected that the onsite works will commence in March of 2023 and run for approximately 8 weeks.
- Quinns Road The beach access repair works were tendered and a contractor has been selected. Access and compound conditions are under review and Local Councillor and Resident Group notifications will be commence is due course. It is expected that the on-site works will start in early 2023.
- 40 Foot Remedial Repairs Material and fabrication lead times have delayed the project and it is currently expected that the project will be completed in late 2022 or early 2023.
 - Redlough Landscapes Ltd weeding contract came to an end in early November. However, additional minor weeding works are now under consideration.
- Public Realm cleaning is on-going presently with power washing and furniture cleaning.
- DLR Baths maintenance equipment has been ordered for the future handover of this space to the Cleansing team. On site Risk Assessments and adverse weather procedures need to be developed and agreed.
- Gully Cleaning and Road Sweeping overtime has occurred due to the recent wet weather and heavy leaf fall. €126,400. The €4.5m HSF 2023 funding will operate nationally and DLRCC is permitted to submit up to a maximum of 5 projects to the Department for consideration.
- Early morning sweeping and gully cleaning operations have been on-going. Traffic Management licences have been submitted and granted where applicable. https://www.dlrcoco.ie/en/conservation/conservation-grants-2023
- The Road Sweeping and Cycle Lane Sweeping schedules have been temporarily suspended since the 27th of October due to the leaf fall season. The sweeping schedules will be reinstated in early 2023.
- Blue Flag submissions are being prepared for Seapoint and Killiney Beaches.
- Oil Spill ground crew response training was undertaken for circa 20 Outdoor Staff.

Community Response Forum

The Community response to the crisis in Ukraine and the influx of Ukrainian nationals into the county is being led and coordinated by Dún Laoghaire-Rathdown County Council in collaboration with a wide range of stakeholders in the Community Response Forum, supported by a wide range of community and volunteer groups.

The Community Response Forum has been meeting since 28 March and met three times during November. Support services are being provided to those Ukrainian nationals who are being accommodated in the Ballyogan Rest Centre and Larch Hill Scout Centre as well as in hotels and in private accommodation within the County.

English classes and other activities continue to be provided in Ballyogan, Sandyford, Dundrum, Loughlinstown and Glasthule.

Joint Policing Committee (JPC)/Local Policing Fora (LPF)

A meeting of the Joint Policing Committee took place on the 17th November. Central Dún Laoghaire LPF met on the 8th November and the Ballybrack Loughlinstown Shankill LPF met on the 15th November.

LCDC

A meeting of the LCDC taking place on 30th November 2022.

Community Support Fund was announced by Department of Rural and Community Development with €311,589 in funding provided to DLR LCDC to support grants for capital and operating costs for community groups in the County.

Age-Friendly Programme & Social Inclusion:

The **dlr Festival of Inclusion 2022** ended the weekend of the 5th November, with a celebration of Diwali organised by Social Space Ireland in St Brigid's Hall in Stillorgan. The dlr Festival of Inclusion saw dozens of organisations and community groups across the county hosting open days, coffee mornings, exhibitions, music, creative and cultural performances and workshops, information sessions, talks, radio programming, as well as free training provided online to DLRCC staff, elected members and the public during the festival.

The overall theme of the festival this year was promoting and raising awareness of Equality, Diversity and Inclusion as well as highlighting the supports available locally and the wonderful work of volunteers and over 2,000 people took part in the dlr Festival of Inclusion this year.

The dlr Age-Friendly Programme supported a **community Age-Friendly event in the Nutgrove Shopping Centre** on the evening of Sunday 6th November

Installation of locks as part of the **High Security Locks Scheme** continued during November 2022.

The **dir Older People's Council (OPC)** continue to meet on a monthly basis and training took place on Thursday 17th November, delivered by Louise Edmonds, Regional Manager with Age-Friendly Ireland as part of the national roll-out of training being provided to OPC's across the country by Age-Friendly Ireland.

The **dlr Age-Friendly Strategy 2022 – 2026** was Noted at the November Council meeting by dlr County Councillors and will be launched in early 2023.



Community Section Staff assessed a total of 207 applications for Community Grants. A total of 161 applications (78%) were recommended for awarding of a grant. 73 (45%) of the applications recommended were for Financial Assistance towards annual running costs.

Community Facilities Network

Members of the Community Facilities Network completed *Introduction to Health & Safety Training*. This training was held over four workshops and covered areas such as Hazards, Risk Assessments, First Aid & Fire and use of the BeSmart Safety Management and Risk Assessment Tool.

Period Poverty Pilot Project

The supply of Period products across identified Community Facilities, Community / Voluntary Sector Service Providers, Libraries, County Hall and Dundrum offices (public toilets) continued during November.

Comhairle na nÓg

The Comhairle na nÓg AGM was held on the 16th November in the Talbot Hotel in Stillorgan. 70 Young People attended, representing 17 secondary schools and Youth Services run by Southside Travellers Action Group & Crosscare. The theme for the AGM was Mental Health and the Comhairle plan to progress the making of a podcast on this theme, including the new work topic, during 2023. The new work topic decided on by the Young People at the AGM was substance abuse. All attendees have been invited to join dlr Comhairle to work on the topic and theme in 2023. The new Comhairle will be formed in December 2022.

Rochestown Residents Engagement

The dlr Age-Friendly Programme and Community Section Staff supported a Festive Wreath Making Workshop with residents from the Rochestown Complex on Thursday 24th November. The residents are now planning a Christmas event in December and a day trip in January as well as longer term events and projects. Dlr Community Section staff will continue to support residents along with other age-friendly organisations.

Arts

Municipal Gallery Programme

Altered Ground by Dianne Whyte continued in the Municipal Gallery. Altered Ground is a new body of photographic work exploring landscapes undergoing extensive development within the local areas of Cherrywood, Lehaunstown, Carrickmines and Sandyford. Dianne Whyte is the 2022 recipient of the dlr Visual Art Commission funded by The Arts Council of Ireland and managed by Dún Laoghaire-Rathdown County Council.

Creative Communities Economic Action Fund

Dún Laoghaire-Rathdown County Council and IADT were awarded funding under this Fund by Creative Ireland. The project, Towards a Creative Dún Laoghaire, combined expertise from dlr Arts Office and Economic Development Unit, along with the Public Design Lab, IADT. The partners researched and explored ways of forging closer cooperation and embedding a presence for IADT in Dún Laoghaire Town. They worked closely with a range of key local stakeholders to examine ways to enable IADT graduates and other creatives to stay working within the Dún Laoghaire Town, and the wider County. Stakeholder engagement activities included a filmed panel discussion in IADT, a coffee morning in dlr LexIcon and a week-long design thinking charette in IADT and Dún Laoghaire involving students. A detailed research findings report is being finalised.

As part of this programme a multisensory arts project is taking place in St. Joseph's, Shankill and Dalkey Community Unit for Older People, aimed at engaging older people with dementia that are unable to come to the dementia inclusive activities that are programmed in dlr LexIcon.

Local Live Performance

Funded by the Dept of Tourism, Culture, Arts, Gaeltacht, Sport and Media, dlr Arts Office ran a Local Live Performance Scheme (LLPS) since June 2021 as a covid response to support those working in the live performing arts industry. The scheme has now come to an end. During the last 17 months LLPS has created 3,388 days of employment supporting performers, tech crews, venues and audiences throughout the County.

Arts and Inclusion Commissions 2022

Commissions aimed at artists, arts groups or arts organisations working in the area of arts and inclusion have been awarded. These Commissions funded by the Arts Council, align with the focus of the Arts Council's 'Equality, Human Rights and Diversity Policy and Strategy'. The selected artists are; Cathy White, the focus of her commission is collaborating with local people from the Traveller Community. Ruairí O'Shea, who will hone and develop his skills as a musician working with older people in care settings. Romina Cruanás will be working with a multicultural focus locally.

Public Art

Street artist Decoy was commissioned in October 2022 to create an exciting large-scale colourful mural for the Handball Court at Rockfield Park in Blackrock. Funded under the Per Cent for Art Scheme and managed by dlr Arts Office in collaboration with dlr Parks Department. The park is open daily for visitors to enjoy this incredible work of art. The artist was selected through open call. The Selection Panel included the Arts Officer (on behalf of Public Art Steering Group), a Parks representative (Landscape Architect) and an external Professional Practicing Artist.

These resources include information on library services, including free Wi-Fi, free internet pc access, photocopy, print and scanning services. We have also translated one of our existing flyers into Ukrainian and Russian, outlining our services. In addition, we have also drafted an information leaflet specifically for the Ukrainian Rest Centre in Ballyogan.

We have ordered books for children and adults in Ukrainian and Russian. We have purchased a selection of e-books on our existing online platforms (Overdrive and Borrowbox) and have purchased licences to download and print early readers in Ukrainian for children. We have also ordered some Ukrainian newspapers and magazines for our library branches along with the Ukrainian Community Hub in Ballyogan.

As with all DLR websites, content on https://libraries.dlrcoco.ie/ can be accessed in multiple languages, including Ukrainian and Russian, by using the Accessibility button at the top of the webpage.
