The Ballyogan Regional Temporary Rest Centre opened its doors to Ukrainian nationals on 28 April. The Rest Centre continues to accommodate up to 300 displaced Ukrainian nationals for short periods. Over 2,100 people have stayed at the centre for short periods.

As part of a comprehensive wrap around service, accommodation services at the Centre are being supported by HSE staff including Environmental Health, Public Health and COVID-19 services. The HSE is providing onsite support to meet the healthcare needs of Ukrainian residents, and residents also have access to an offsite GP service 7 days a week.

Among the facilities available in the temporary rest centre is separate laundry and sanitary facilities, internet access, television spaces, games consoles, games room, chessboards, use of bikes and scooters, libraries of Ukrainian books for children and adults, translation services, as well as online access to Ukrainian newspapers and magazines.

Additionally, orientation and information sessions, basic English language lessons and an arts and music entertainment programme is being developed both onsite and nearby offsite.

Local coordination efforts continue to provide comprehensive support services from Southside Partnership, HSE, An Garda Siochána, Department of Social Protection, dlr Education and Training Board, TUSLA, Community and Family Resource Centres, dlr Volunteers Centre, colleagues in the East Region and a number of other community and voluntary groups.

Work is now underway to provide extra facilities, including a homework club room for children, and adults workspace, and a new improved space for teenagers.

Road Safety, Cycling and Sustainable Travel

The Road Safety Plan 2022 to 2030 was adopted at the County Council meeting on September 12th, 2022 and also presented to the Transportation and Marine SPC and the Joint Policing Committee the same week.

A temporary licence and the suspension of the licence fee and permit fees for Bleeperbike, Moby Bikes and Zipp Mobility has been issued up to the end of December 2022

Speed Limit Review

A Consultant has been appointed for carrying out a countywide speed limit review and briefing sessions were held for Councillors in the six Electoral areas in October. A Draft set of Byelaws is currently being prepared.

A number of staff members attended the Road Safety Authority Annual Conference in Croke Park on October 26th. This focussed mainly on 'Tackling Speeding'.

Deputations

Traffic staff met with Roebuck Residents, Woodlawn Residents and Ailesbury Residents on the 12th October 2022



Traffic Advisory Group (TAG)

A TAG meeting took place in Area 1 (Dun Laoghaire) on 25^{th} of October and 26 items were dealt with.

Bus Connects

The Core Bus Corridors Schemes' (CBCs) statutory applications are now being progressed by the NTA for formal submission to An Bord Pleanala for planning permission. The Blackrock to City Centre Core Bus Corridor Scheme (CBC 15) was the second application to ABP and the 8-week statutory public consultation period for this development closed on Tuesday July 12^{th,} 2022. All planning documentation is available at: https://belfieldblackrockscheme.ie/ The Traffic Section, with cross departmental input, made a submission to ABP with respect to the proposed CBC. The NTA have advised that the submission of the Bray to City Centre CBC planning application to ABP is planned for Q4 of this year (2022).

Bus Interchanges at Dundrum, Dun Laoghaire & Blackrock

Discussions are ongoing with the NTA regarding bus interchange improvements at both Dundrum and Dun Laoghaire. The improvements are needed to cater for the planned service increases under the BusConnects' programme. Meetings/workshops are ongoing to progress this work and a multi-disciplinary group from the Council is in place to assist. In addition, discussions are also ongoing with the NTA regarding potential public realm improvements in Blackrock and the impact on the existing bus interchange and bus services.

Area Based Transport Assessments (ABTAs)

Dundrum ABTA - Work on this project is progressing and the ABTAs Stages 1 & 2 now completed with work on Stage 3 – Options Assessment & Development and Stage 4 – Preparation of a draft Local Transport Plan, now at an advanced stage.

Racecourse South ABTA – Discussions have commenced with the Land Development Agency, the NTA and TII on the preparation of an ABTA for the Racecourse South lands at Carrickmines, in accordance with the requirements of SLO 143 in the current County Development Plan.

New Development Areas – Kilternan – Glenamuck, Old Connaught – Rathmichael, – Following discussions with the NTA, it has been agreed that the Old Conna ABTA study, commenced in 2019 and on hold since 2020, should not be completed due to outdated policy and context. It is anticipated that new ABTA studies based on updated policy and strategic context will be required for new development areas in the southeast of the county.

3. Water & Drainage

Drainage and Flood Alleviation

Engineering and Environmental Consultants were appointed in December 2019 for Flood Risk Management works on the **Deansgrange Stream**. This is a 4-to-5-year project. Activities completed to date include additional survey work, CCTV surveys, a Constraints Study, Hydrological analysis, and hydraulic modelling. Initial Public Consultation is now complete. Optioneering, environmental surveys and engagement with key stakeholders are underway. A Ground Investigation Contract is complete, and the report is awaited. Work has begun to review possible sites for environmental impacts. We have received preliminary approval from Irish Rail to tunnel under the rail line and can now progress to



public consultation for the scheme.

Engineering and Environmental Consultants have also been appointed for Flood Risk Management Works on the **Carrickmines/Shanganagh Rivers**. This is a 5+ year project. Data gathering is underway. A Flow/Rainfall Survey is complete. Further topographical survey work has been done. Early damage/benefits assessments are underway to ensure a cost-beneficial scheme is achievable. An initial public engagement is complete following short briefing sessions with Area Councillors. The Hydrology/Hydraulic report is now complete and initial options are being developed. A Contractor has been appointed for the Site Investigation. This work is due to begin next week.

The Monkstown environs flood risk mapping project is underway. The topographical survey is now largely completed. The flow/rainfall survey is now completed, and the CCTV survey is well underway. Draft flood maps have been produced and reviewed.

4. Roads Control Unit

Irish Water Reinstatement IWR Works 2022

Roads Control Unit is continuing to carry out the permanent reinstatement works throughout the administration area of Dún Laoghaire-Rathdown County Council (DLRCC) according to the current service level agreement (SLA) between Irish Water and DLRCC. In 2022, 564 no. locations have been received and 509 no. fully reinstated.

Cleansing, Beaches & Coastal Protection Updates – October 2022

- Coliemore Harbour: An Bord Pleanála (ABP) Part 10 Planning approval was expected by the 19th October, however a decision has not been issued as of yet by ABP. The on-site works may not progress until early 2023 due to weather constraints and this pending ABP planning decision.
- Quinns Road The beach access repair works were tendered and a contractor has been selected. A prestart meeting has been held with the contractor and access and programme items are being addressed presently. It is expected that the on-site works will start in January 2023.
- 40 Foot Remedial Repairs Material and fabrication lead times have delayed the project and it is currently expected that the project will be completed in late 2022 or early 2023.
- Redlough Landscapes Ltd are progressing as our weeding contractor, however, the contract is to come to an end on the 4th of November.
- Public Realm cleaning is on-going presently with power washing and furniture cleaning.
- DLR Baths maintenance equipment has been ordered for the future handover of this space to the Cleansing team. On site Risk Assessments and adverse weather procedures need to be developed and agreed.
- Gully Cleaning and Road Sweeping overtime has occurred due to the recent wet weather.
- The Road Sweeping and Cycle Lane Sweeping schedules have been temporarily suspended since the 27th of October due to the leaf fall season. The sweeping schedules will be reinstated in early 2023.
- 8 No. Recycling Bins have been scheduled to be installed before the end of October.

7. Dún Laoghaire Harbour

Cruise Ship Business

We had approximately 72 Cruise Ships booked into the Harbour in 2022. 3 ships cancelled due to weather. Overall, the Harbour was being well received by ship management, cruise guests and the crew who come ashore. We are now doing a full review of the 2022 season with our various stakeholders and beginning to plan for a busier 2023 season with 90+ ships booked at present.

Grant Funding

The Brexit Adjustment: Local Authority Marine Infrastructure Scheme 2022 – 2023 from



the Department of Agriculture, Food and the Marine has launched a Second Tranche call for applications. Dun Laoghaire Harbour received over \in 3 million in grant funding from the first tranche. We have submitted 5 grant applications to this scheme by the deadline of 30th September 2022. We await the outcome of the grant process.

Projects:

National Watersports Campus

DLRCC in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We have responded to requests for additional information and are now finalising the grant process and agreements with the project partners. An MOU has been signed with Irish Sailing and Diving Ireland in order to set out and agree the objectives of the project.

DLRCC and Irish Sailing are developing a brochure/prospectus for the project to detail the project vision and scope. It is hoped that this initiative will assist in building momentum and support for the project.

Berth 2 Fenders (Carlisle Pier)

A project to replace the Berth 2 fenders has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project. This project was tendered, and Sorensen Construction have been appointed to deliver the project. We are awaiting Foreshore consent to proceed to works on site.

Grant funding has recently been secured for the installation phase of this project from the recent Brexit Local Authority Marine Infrastructure Scheme.

Berth 3 Fenders (Carlisle Pier)

Grant funding has recently been secured for a project to replace the Berth 3 fenders from the recent Brexit Local Authority Marine Infrastructure Scheme. The project has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project as it is a mirror image of the Berth 2 fender project.

East Pier Revetment Repairs

Grant funding has recently been secured for a project to repair the sloping revetment at the back (east side) of the East Pier from the recent Brexit Local Authority Marine Infrastructure Scheme. This revertant provides the primary protection for the East Pier and has suffered some damage over recent years from the larger storms. Punch Consulting Engineers have been appointed to design and manage the project which is likely to be on site during the summer of 2023. Initial surveys are now complete, and we await the final survey reports. Thereafter design work will commence on the repair project.

Ferry Terminal

Planning permission was granted for the ferry terminal project on 7th February 2020. A planning appeal was lodged to An Bord Pleanála. An Bord Pleanála have now granted permission for the development.

A business briefing on the ferry terminal proposal was delivered to the elected members by Hilary Haydon on 25th February 2020. An agreement to lease the building (subject to Foreshore and Section 183 consent) was signed in December 2021, and the Foreshore Lease has been agreed with the Dept.



This matter was brought to the full June Council Meeting and the Section 183 Disposal passed. The Legal Department is now dealing with closing the lease process so the new tenant can begin occupation.

Dublin Array Windfarm

The developers of the Dublin Array Windfarm have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. Early engagement is ongoing with the developer's team to establish the exact requirements.

Regatta Festival 2023

The Biennial Dun Laoghaire Regatta is due to take place in July 2023. We are working with several DLRCC departments to expand this into a week-long festival for the Dun Laoghaire Town and Harbour areas.

Community Response Forum

The Community response to the crisis in Ukraine and the influx of Ukrainian nationals into the county, is being led and coordinated by Dún Laoghaire-Rathdown County Council in collaboration with a wide range of stakeholders in the Community Response Forum, supported by a wide range of community and volunteer groups.

The Community Response Forum has been meeting since 28 March and met three times during October. Support services are being provided to those Ukrainian nationals who are being accommodated in the Ballyogan Rest Centre and Larch Hill Scout Centre as well as in hotels and in private accommodation within the County.

Temporary donations drop off points were established in Community Facilities, County Hall and Dundrum offices.

Ballyogan Parish Hall and the Samuel Beckett Civic Campus continue to be used as a base to provide English Classes and other activities for Ukrainian nationals. Residents of Ballyogan Rest Centre are accessing and using the facilities of dlr Leisure Ballyogan which is being supported by Community Section and Sports Partnership.

Local Policing Fora (LPF)

A meeting of the Sandyford/Stepaside LPF took place on 18th October. A public meeting of the Sandyford/Stepaside LPF took place on the 25th October.

LCDC

An LCDC meeting took place on the 5th of October. At this meeting Therese Langan was elected as the new chairperson of the LCDC and the LCDC approved operating costs (Round 2) grants under the Community Activities Fund to a total of \in 70,709.95

Age-Friendly Programme & Social Inclusion:

The Festival of Inclusion launched on 29 September with the "Autumn Medley of Creativity" in dlr LexIcon. It will close on 5 November with a celebration of Diwali in St Brigid's in Stillorgan.

The overall theme of this year's Festival is promoting equality, diversity and inclusion in the County. There were in excess of 50 events organised by the Council and community/voluntary groups throughout the County.

The High Security Lock Scheme 2022 closed for applications on 9 September. 220 applications were received by the deadline. Installation of the locks commenced in early October.

At the National Age Friendly Achievement Awards in Co Clare on 27 October, Rochestown House older persons housing development won the top prize in the Age Friendly Housing Award category.

Period Poverty Pilot Project

The supply of Period products across identified Community Facilities, Community / Voluntary Sector Service Providers, Libraries, County Hall and Dundrum offices (public toilets) continued during October.

Comhairle na nÓg

The Comhairle have been meeting bi-monthly since September to make arrangements for the Annual AGM on the 16th November.



European Youth Parliament, Ireland (EYPI)

The EYPI held the Dublin Regional Conference during October 21st – 23rd in Holy Child Killiney School. The Community Section sponsored funding for student delegates from DEIS schools in our area to attend the conference. The conference was officially opened by An Cathaoirleach, Cllr Mary Hanafin.

Rochestown House Residents Engagement

Staff from Community Development and Social Inclusion section held a public meeting with the residents of the Rochestown House Complex in October with a view to supporting the residents to identify how they want to use the communal space available in the complex. Following the meeting a questionnaire was sent to each unit in the complex and a follow up public meeting was held. From this a list of activities has been identified and work will be ongoing to support the implementation of them.

Estate Management

Recycle (skip) and WEEE collection days were organized in October across the county at Sandyford Bearna Park, Goatstown Close, Moreen Blackthorn, Kilcross, Hillview, Meadowlands Fitzgerald Park, Shanganagh-Rathsallagh-Clifton Estates, and Cois Cairn. These Recycle days, organised by local estate management committees in collaboration with the Community Section, were also attended by litter wardens and community Gardaí, where possible. Approx 88% of materials collected is diverted from landfill. A tonnage report will be available shortly.

Arts

Municipal Gallery Programme

Altered Ground by Dianne Whyte continued in the Municipal Gallery. Altered Ground is a new body of photographic work exploring landscapes undergoing extensive development within the local areas of Cherrywood, Lehaunstown, Carrickmines and Sandyford. Dianne Whyte is the 2022 recipient of the dlr Visual Art Commission funded by The Arts Council of Ireland and managed by Dún Laoghaire-Rathdown County Council.

Arts Grants

The dlr Arts Grant Scheme for 2023 opened for applications on Thursday 22nd of September. Grants are available to provide financial assistance to individual artists, arts groups and arts organisations engaged in arts projects or events at local or county level and to support the professional development and arts practice of individual artists, arts groups and organisations. There are also Arts Access Grants available for older persons and Community Arts Grants for small scale community arts events. The closing date was Tuesday 25th October at 5pm and 102 applications were received.

Grant clinics (both online and in person) were held and attended by over 30 people giving an opportunity to meet some of the Arts team, who answered questions and assisted with the application process.

Dementia Inclusive Autumn Programme for Carers

This is an interactive and engaging creative programme specifically designed with carers in mind. It is also devised to be open and welcoming to people living with dementia that may like to attend with their loved ones. A range of events will take place in various libraries, programmed by the Arts Office and Library Service. This programme is funded by Creative Ireland's Creativity in Older Age Programme 2022.

dlr First Frames Scheme

Following an open call process and interviews for short-listed projects, two awards will be made under dlr First Frames 2022/23. Previous films made under the Scheme have been selected for short film festivals around the world, with several winning awards; this includes one short winning Best Female Filmmaker at the San Diego Short Fest, and "Discovery Award" + "Special Mention Award" at the Dublin International Film Festival, and another recently receiving Best Short at the Louth Film Festival October 2022. dlr First Frames is fully funded by the Arts Office and Economic Development Unit and managed by IADT. The County Council works closely with the Institute of Art, Design & Technology's (IADT) National Film School (NFS) on this programme, with the NFS providing additional support in the form of mentoring and equipment loans to the successful projects.

Film Start Your Own Business Course

Dún Laoghaire-Rathdown County Council and Wicklow County Council are partnering to deliver a Start Your Own Business Programme specifically designed for those working in Film, Television and Animation. This is being delivered by the Entrepreneurs Academy and is aimed at people considering starting their own business within the screen or content creation industry. It will assist with understanding the essential elements required to start up and run a business in this area and is being delivered throughout the autumn/winter. The Arts Office is working with the Local Enterprise Office on this.

dlr Primary Arts Programme 2022-23

The Primary Arts Programme in partnership with Blackrock Education Centre is back up and running in schools for the 2022-23 term. 5 schools and 5 creative practitioners have been selected and matched for this programme that will run until Maty 2023. The central purpose of the programme is to facilitate a professional Creative Practitioner to collaborate with a primary school class and teacher to explore creativity in the classroom setting through various artforms. A Creative Practitioner is a professional facilitator with an artform background, for example; a Dancer, a Visual Artist, a Writer or a Musician. The following schools are participating for the 2022-23 programme: St. Columbanus N.S., Sallynoggin-Killiney Educate Together N.S., Gaelscoil na Fuinseoige, Glenageary Killiney N.S and Carysfort N.S.

Multisensory Arts Project in Residential Care Settings

'Framing the Senses' builds on ten years of experience of creative programming for and with people living with dementia and local service providers. Funded by Creative Ireland's Creativity in Older Age Programme it benefits people living with dementia, and their carers, and creates an awareness among the general population about the benefits and positive impacts of creativity for people living with dementia. As part of this programme a multisensory arts project is taking place in St. Joseph's, Shankill and Dalkey Community Unit for Older People, aimed at engaging older people with dementia that are unable to come to the dementia inclusive activities that are programmed in dlr LexIcon.

Using Dormant Accounts Funding received, a series of events have been programmed in October and November in conjunction with our colleagues in the Community Dept. Events include: Yoga workshops, Art classes, Puppetmaking workshops, Craft sessions, English classes and Early Years workshops.

Creative and Social Programme for Carers of People Living with Dementia

Supported by funding from Creative Ireland's Creativity in Older Age Programme, dlr Libraries and dlr Arts office present a series of events for carers, taking place across 4 of our libraries from the end of September and throughout October. Events include dance workshops, music, and art workshops. The interactive and engaging programme is specifically designed with carers in mind. It is also welcoming to people living with dementia that may like to attend with their loved ones.

ADHD Talks

As part of ADHD (attention deficit hyperactivity disorder) Awareness Month in October, we're hosting a number of information talks, both online and in-person, on Tuesday evenings. The talks cover a wide range of topics including: Neurodiversity and ADHD in the workplace, Executive Function and ADHD in Women and Girls. Suitable for parents/guardians of children with ADHD or Adults with ADHD themselves.

Events for Adults

Clubs & Groups

A wide variety of clubs and groups continue to use our library spaces to meet.

These include the Language Exchanges and the Scrabble Club in Deansgrange Library, the Knitting Club in Cabinteely Library, and the Family Lego Club in Blackrock Library. Staff in Blackrock have also started a monthly Film Club for adults, consisting of a screening plus discussion. The Ciorcal Comhrá, the informal Irish conversation group, has returned to the LexIcon Café every Tuesday morning.

Each of the 8 branches have in-person book clubs, including the Audio Book Club in Dundrum Library with some also continuing with their online book clubs, due to ongoing demand. The very popular online monthly Book Club with Mary Burnham continues to meet online. The October title for discussion is *Lessons in Chemistry* by Bonnie Garmus.

In this its centenary publication year, a new *Ulysses* book Club for adults has begun in Dundrum Library. For those who've always wanted to read this literary masterpiece, members will meet monthly to discuss two chapters at a time in order to finish the tome by Bloomsday 16 June 2023.
