Public Sector Equality and Human Rights Duty – DLR County Council

All public bodies in Ireland have responsibility to promote equality, prevent discrimination and protect the human rights of their employees, customers, services users and everyone affected by their policies and plans. The Dún Laoghaire-Rathdown County Council Corporate Plan 2020 – 2024 sets a corporate goal to promote equality and human rights by implementing Public Sector Equality and Human Rights Duty. The steps identified by dlr County Council to achieve this goal are as follows:

- Eliminate discrimination, protect human rights and promote equality of opportunity through implementation of this Duty.
- Develop a cross departmental group to oversee the implementation of the Duty.
- Implement Stage one: Assess the key equality and human rights issues for the people we provide services to and our staff. Review structures and initiatives already in place to support human rights and equality and identify the priority issues for action.
- Stage two: Address equality and human rights issues identified for action.
- Stage three: Report on development and achievements arising from the implementation of the Duty.
- Strengthen and build understanding and capacity to meet Public Sector Duty obligations in local government, community and voluntary organisations.
- Provide Council Services and information in an affordable and accessible manner for all.
- Ensure social inclusion, equality and accessibility is at the core of our services, activities and events to support our vibrant economy and strong community, for people of all ages.
- Provide access to Council decision-making through accessible and meaningful public consultation.

Implementation Progress to Date

- A cross departmental working group was set up to oversee the implementation of the Duty. This group held regular meetings and commissioned an assessment, validation and implementation report from Value Labs, with regard to Equality and Human Rights Issues at dlr County Council.
- DIr County Council identified five equality and human rights values motivating its ambitions for the Duty; Dignity; Accessibility; Social Justice; Participation; and Empowerment. These five values are used as a framework to set out the assessment of the equality and human rights issues that are relevant to the functions of dlr County Council.
- The Value Labs assessment reviewed dlr strategies, such as The dlr Strategic Plan for Housing people with a disability 2021 – 2026; The dlr Age Friendly strategy 2016 – 2020 and the dlr Local Economic and community Plan 2016 - 2021. They also took into consideration National Policy Strategies such as the National Disability Inclusion Strategy 2017 -2022; The Comprehensive Employment Strategy for People with Disabilities 2015 – 2024; The National Positive Ageing Strategy; the National Traveller and Roma Inclusion Strategy 2017 – 2021; The National LGBTI Inclusion Strategy 2019 – 2021; the LGBTI National Youth Strategy 2018 – 2020; and The Arts Council: Equality, Human Rights and Diversity Policy and Strategy 2019.
- To enable the implementation of the Duty, Value Labs recommended the following: Leadership at all levels in dlr County Council to ensure implementation of this plan; Corporate Services to hold overall responsibility for ensuring and enabling implementation of the Duty; internal staff training to enable understanding of the Duty; Communications to develop messages on the Duty; Partnership Committee to provide creative input and pursue communication initiatives; Senior Management



Team to identify, mark and celebrate DLRCC achievements; and monitoring progress.

- An Equality Review and Action Plan was carried out by the Irish Human Rights and Equality Commission was carried out to assess social housing services and non-Irish nationals.
- This led to the creation of dlr County Council's Equality Action Plan, which includes actions on the following: Website accessibility; staff training; equality awareness; engage with PPN; customer surveys; improved form and design layout; translation services; and many more actions.

Achievements to Date

There have been many initiatives implemented to date, below are some of these:


- Notably, two of these initiatives have recently been shortlisted in the annual Clambers Ireland Excellence in Local Government Awards, 2022:
 - **dlr Digital Inclusion Acorn Project** in Age Friendly Initiative
 - Embedding a culture of plain English communications in a Housing Department in Communications
- DIr Festival of Inclusion, every autumn, which highlights and celebrates social inclusion initiatives and to support and encourage all to actively participate in the community. Some of the events included are: disability in the workplace seminar; age-friendly entertainment; the Travellers Theatre; multicultural women's breakfast; men's shed; autism awareness; Know your Neighbour; free on-line public training for diversity & inclusion, cultural awareness and LGBTI + awareness and ally training. Commencing Thursday 29th September this year.
- Arts Office and Libraries have many initiatives running, including: dementia inclusive gallery tours; ADHD awareness talks; services for those with additional needs; reader pens for schools; and laptops for lending, to name a few.
- Sports Partnership and the Royal St. George's Yacht Club, Inclusive Water Sports Summer Camp.
- Website upgrade now includes Accessibility icon to allow translation of website into different languages and font sizes.
- Communications, public survey currently running, 'How we communicate?'.
- The Partnership Office and Disability and Consultation Group, involvement with Make Way Day 30th September 2022.

Conclusion

Dir County Council continues to work towards eliminating discrimination, protecting human rights and promoting equality, throughout our organisation and in the community. We plan to roll out Human Rights and Equality training for all dir staff. There is also a business case prepared to appoint, subject to departmental sanction and available budget, a full time Equality Officer, who will lead out on enabling and ensuring implementation of the Duty and be responsible for co-ordinating and implementing these and other initiatives to create a more diverse workplace and creating opportunities for all members of the community.





The Ballyogan Regional Temporary Rest Centre opened its doors to Ukrainian nationals on 28 April.

Significant work has been undertaken by regional agencies, led by Dún Laoghaire-Rathdown County Council, to provide temporary accommodation facilities, managed by a dedicated site supervisor overseeing an extensive facilities team, as well as catering, security and cleaning details, all operating on a 24-hour basis.

The Ballyogan Regional Temporary Rest Centre can accommodate up to 300 displaced Ukrainian nationals for short periods. Thereafter they will be allocated longer term accommodation in other areas of the state.

As part of a comprehensive wrap around service, accommodation services at the Centre are being supported by HSE staff including Environmental Health, Public Health and COVID-19 services. The HSE is providing onsite support to meet the healthcare needs of Ukrainian residents, and residents also have access to an offsite GP service 7 days a week.

Among the facilities available in the temporary rest centre is separate laundry and sanitary facilities, internet access, television spaces, games consoles, games room, chessboards, use of bikes and scooters, libraries of Ukrainian books for children and adults, translation services, as well as online access to Ukrainian newspapers and magazines.

Additionally, orientation and information sessions, basic English language lessons and an arts and music entertainment programme is being developed both onsite and nearby offsite.

Local coordination efforts to develop as safe and as comprehensive support services as possible include Southside Partnership, HSE, An Garda Siochána, Department of Social Protection, dlr Education and Training Board, TUSLA, Community and Family Resource Centres, dlr Volunteers Centre, colleagues in the East Region and a number of other community and voluntary groups.

Traffic Advisory Group (TAG)

A TAG meeting took place in Area 2 (Dundrum) on 14th of September and 31 items were dealt with.

Bus Connects

The Core Bus Corridors Schemes' (CBCs) statutory applications are now being progressed by the NTA for formal submission to An Bord Pleanala for planning permission. The Blackrock to City Centre Core Bus Corridor Scheme (CBC 15) was the second formal application to ABP and the 8-week statutory public consultation period for this development closed on Tuesday July 12th 2022. All planning documentation is available at: <u>https://belfieldblackrockscheme.ie/</u> The Traffic Section, with cross departmental input, made a submission to ABP with respect to the proposed CBC.

The NTA have advised that the submission of the Bray to City Centre CBC planning application to ABP is planned for Q4 of this year (2022).

The submission of the CBC planning applications to ABP triggers a formal statutory public consultation process in respect of each of the stand-alone Core Bus Corridor schemes, with submissions made directly to An Bord Pleanála for their consideration. During this process, the finalised Environmental Impact Assessment Reports, inclusive of traffic impact analyses, will be published and available for inspection (including online) and purchase. The public will then have the formal opportunity to have their views heard and considered by An Bord Pleanála as part of the statutory consultation process to inform An Bord Pleanála's assessment of each of the stand-alone Core Bus Corridor schemes.

Dundrum ABTA - Area Based Transport Assessment

Work on this project is progressing and the ABTAs Stages 1 & 2 now completed with work on Stage 3 – Options Assessment & Development, now at an advanced stage.

Bus Interchanges at Dundrum, Dun Laoghaire & Blackrock

Discussions are ongoing with the NTA regarding bus interchange improvements at both Dundrum and Dun Laoghaire. The improvements are needed to cater for the planned service increases under the BusConnects' programme. Meetings/workshops are ongoing to progress this work and a multi-disciplinary group from the Council is in place to assist. In addition, discussions have also commenced with the NTA regarding potential public realm improvements in Blackrock and the impact these may have on the existing bus interchange and bus services.

Old Conna ABTA - Area Based Transport Assessment

Following discussions with the NTA, it has been agreed that the Old Conna ABTA study, commenced in 2019 and on hold since 2020, should not be completed due to outdated policy and context. It is anticipated that a new ABTA study based on updated policy and strategic context will be required.

Racecourse South ABTA – Area Based Transport Assessment

Discussions have commenced with the Land Development Agency, the NTA and TII on the preparation of an Area Based Transport Assessment (ABTA) for the Racecourse South lands at Carrickmines, in accordance with the requirements of SLO 143 in the current County Development Plan.

New Bus Stops to Serve Planned BusConnects Orbital Bus Services

The Traffic Section has been liaising with the NTA on the location and design of new bus stops throughout the county, required to support planned new bus services being introduced by the NTA over the next two years. It is anticipated that bus stop approval notices for the new stops will be issued to the NTA in Q3 of this year.



3. Water & Drainage

Drainage and Flood Alleviation

Engineering and Environmental Consultants were appointed in December 2019 for Flood Risk Management works on the **Deansgrange Stream**. This is a 4-to-5-year project. Activities completed to date include additional survey work, CCTV surveys, a Constraints Study, Hydrological analysis, and hydraulic modelling. Initial Public Consultation is now complete. Optioneering, environmental surveys and engagement with key stakeholders are underway. A Ground Investigation Contract is complete, and the report is awaited. Work has begun to review possible sites for environmental impacts. We have received preliminary approval from Irish Rail to tunnel under the rail line and can now progress to public consultation for the scheme.

Engineering and Environmental Consultants have also been appointed for Flood Risk Management Works on the **Carrickmines/Shanganagh Rivers**. This is a 5+ year project. Data gathering is underway. A Flow/Rainfall Survey is complete. Further topographical survey work has been done. Early damage/benefits assessments are underway to ensure a cost-beneficial scheme is achievable. An initial public engagement is complete following short briefing sessions with Area Councillors. The Hydrology/Hydraulic report is now complete and initial options are being developed. A Contractor has been appointed for the Site Investigation. This work is due to begin next week.

The Monkstown environs flood risk mapping project is underway. The topographical survey is now largely completed. The flow/rainfall survey is now completed and the CCTV survey is well underway. Draft flood maps have been produced and reviewed.

4.Roads Control Unit

Irish Water Reinstatement IWR Works 2022

Roads Control Unit is continuing to carry out the permanent reinstatement works throughout the administration area of Dún Laoghaire-Rathdown County Council (DLRCC) according to the current service level agreement (SLA) between Irish Water and DLRCC. In 2022, 467 no. locations are received, and 297 no. were fully reinstated.

Cleansing, Beaches & Coastal Protection Updates – September 2022

- Coliemore Harbour: An Bord Pleanála Part 10 Planning approval is expected by the 19th October. The on-site works may not progress until early 2023 due to weather constraints.
- Quinns Road The beach access repair works were retendered via eTenders and all submissions are being reviewed currently.
- 40 Foot Remedial Repairs Material and fabrication lead times have delayed the project and it is currently expected that the project will be completed in late 2022 or early 2023.
- Redlough Landscapes Ltd are progressing as our weeding contractor and weeding crews have been deployed across the County.



- 1100L wheelie bins that were deployed during the busy summer period have been removed from service.
- Public Realm cleaning is on-going presently with power washing and furniture cleaning.
- Lifeguards: Sandycove, Seapoint and Killiney beaches Lifeguard service finished on the 15th of September in line with the end of the Bathing Season.
- Bathing Prohibition notices were erected at Seapoint, Killiney, Corbawn Lane, Blackrock and Coliemore Harbour during September. All notices have now been removed.
- N11 Deep Clean weekend operations commenced and will be completed by the end of September.
- Gully cleaning and Junction Head cleaning is on-going.
- Town and Village Deep Cleans are progressing.

7. Dún Laoghaire Harbour

Cruise Ship Business

We have approximately 70 Cruise Ships booked into the Harbour in 2022. The first ship arrived on 29th March and was a very successful visit. Approximately 65 ships have visited since then, and the Harbour is being well received by ship management, cruise guests and the crew who come ashore.

Grant Funding

The Brexit Adjustment: Local Authority Marine Infrastructure Scheme 2022 – 2023 from the Department of Agriculture, Food and the Marine has launched a Second Tranche call for applications. Dun Laoghaire Harbour received over \in 3 million in grant funding from the first tranche. We have submitted 5 grant applications to this scheme by the deadline of 30th September 2022.

Projects:

National Watersports Campus

DLRCC in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We have responded to requests for additional information and are now finalising the grant process and agreements with the project partners. An MOU has been signed with Irish Sailing and Diving Ireland in order to set out and agree the objectives of the project.

DLRCC and Irish Sailing are developing a brochure/prospectus for the project to detail the project vision and scope. It is hoped that this initiative will assist in building momentum and support for the project.

Berth 2 Fenders (Carlisle Pier)

A project to replace the Berth 2 fenders has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project. This project was tendered, and Sorensen Construction have been appointed to deliver the project. We are awaiting Foreshore consent to proceed to works on site.

Grant funding has recently been secured for the installation phase of this project from the recent Brexit Local Authority Marine Infrastructure Scheme.

Berth 3 Fenders (Carlisle Pier)

Grant funding has recently been secured for a project to replace the Berth 3 fenders from the recent Brexit Local Authority Marine Infrastructure Scheme. The project has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project as it is a mirror image of the Berth 2 fender project.



East Pier Revetment Repairs

Grant funding has recently been secured for a project to repair the sloping revetment at the back (east side) of the East Pier from the recent Brexit Local Authority Marine Infrastructure Scheme. This revertant provides the primary protection for the East Pier and has suffered some damage over recent years from the larger storms. Punch Consulting Engineers have been appointed to design and manage the project which is likely to be on site during the summer of 2023. Initial surveys are now complete and we await the survey reports.

Ferry Terminal

Planning permission was granted for the ferry terminal project on 7th February 2020. A planning appeal was lodged to An Bord Pleanála. An Bord Pleanála have now granted permission for the development.

A business briefing on the ferry terminal proposal was delivered to the elected members by Hilary Haydon on 25th February 2020. An agreement to lease the building (subject to Foreshore and Section 183 consent) was signed in December 2021, and the Foreshore Lease has been agreed with the Dept.

This matter was brought to the full June Council Meeting and the Section 183 Disposal passed. The Legal Department is now dealing with closing the lease process so the new tenant can begin occupation.

Dublin Array Windfarm

The developers of the Dublin Array Windfarm have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. Early engagement is ongoing with the developer's team to establish the exact requirements.

Regatta Festival 2023

The Biennial Dun Laoghaire Regatta is due to take place in July 2023. We are working with several DLRCC departments to expand this into a week-long festival for the Dun Laoghaire Town and Harbour areas.

Community Response Forum

The Community response to the crisis in Ukraine and the influx of Ukrainian nationals into the county, is being led and coordinated by Dún Laoghaire-Rathdown County Council in collaboration with a wide range of stakeholders in the Community Response Forum, supported by a wide range of community and volunteer groups.

The Community Response Forum has been meeting since 28 March and met once during September. Support services are being provided to those Ukrainian nationals who are being accommodated in the Ballyogan Rest Centre as well as in hotels and in private accommodation within the County.

Temporary donations drop off points were established in Community Facilities, County Hall and Dundrum offices.

Ballyogan Parish Hall and the Samuel Beckett Civic Campus continue to be used as a base to provide English Classes and other activities for Ukrainian nationals. Residents of Ballyogan Rest Centre are accessing and using the facilities of dlr Leisure Ballyogan which is being supported by Community Section and Sports Partnership.

Local Policing Fora (LPF) / Joint Policing Committee (JPC)

A meeting of the Ballybrack/Loughlinstown/Shankill LPF took place on 13th September. A meeting of the Dundrum/Stillorgan LPF took place on the 27th September. The Joint Policing Committee met on the 14th September.

Age-Friendly Programme & Social Inclusion:

The Age Friendly Alliance met on 13 September.

'India Fest' took place on Saturday 17th September in Kilbogget Park organised by Social Space Ireland and the dlr Integration Forum. Approximately 3,000 people attended, with music, dance, sport, children's activities etc. to celebrate Indian culture, supported by the Social Inclusion Unit & DLR Sports Partnership.

'Autumn Medley of Creativity' event took place on 29 September in dlr LexIcon –to showcase opportunities to get involved in age-friendly creative activities in dlr with free age-friendly entertainment, dance, drama, music, information stands, workshops, Men's Shed etc. Supported by Creative Ireland, Age-Friendly Ireland & Creative Lives. This was part of the Festival of Inclusion which launched on 29 September.

Period Poverty Pilot Project

The supply of Period products across identified Community Facilities, Community / Voluntary Sector Service Providers, Libraries, County Hall and Dundrum offices (public toilets) continued during September.

Dlr Comhairle na nÓg meetings have resumed following summer break.

Estate Management

A Networking & Training session with the Estate Management County Fora took place on 17th September. The Estate Management County Fora presented their work in revising the Estate Management User Manual, Service Plan and Financial Reporting Templates. dlr have provided funding to the Estate Management County Fora for the operation of a laptop loan scheme where each Estate Management Forum will be given access to use of a laptop to assist with the operation of the Estate Management Forum.



Arts

Municipal Gallery Programme

Altered Ground by Dianne Whyte launched on September 8th. Altered Ground is a new body of photographic work exploring landscapes undergoing extensive development within the local areas of Cherrywood, Lehaunstown, Carrickmines and Sandyford.

Dianne Whyte is the 2022 recipient of the dlr Visual Art Commission funded by The Arts Council of Ireland and managed by Dún Laoghaire-Rathdown County Council.

Musicians in Residence Programme 2022

The 2022 Musicians in Residence scheme which featured emerging musician harpist Rosie Murphy, Peruvian guitarist Rodrigo Almonte Zegarra and local cellist Lioba Petrie, culminated on Culture Night with a series of concerts in the dlr LexIcon Studio.

The dlr Musicians in Residence Programme is funded by the Arts Council and managed by Music Network.

The Poetry Weekender

The Poetry Weekender was a two-day celebration of poetry which took place at dlr LexIcon and Pavilion Theatre on the 17th and 18th September 2022. It featured a wealth of Irish and international poets and was headlined by Margaret Atwood in a sold-out event at the Pavilion Theatre.

The Poetry Weekender was programmed by dlr Poet in Residence Jessica Traynor and Poetry Ireland and funded by Creative Ireland.

Culture Night

Culture Night in dlr LexIcon took place on September 23rd and featured 18 events including music, workshops, storytelling and street theatre. Almost 1,000 visitors attended over the course of the evening. All the events were free.

Culture Night was supported by the Local Live Performance Scheme funded by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media.

Arts Grants

The dlr Arts Grant Scheme for 2023 opened for applications on Thursday 22nd of September. Grants are available to provide financial assistance to individual artists, arts groups and arts organisations engaged in arts projects or events at local or county level and to support the professional development and arts practice of individual artists, arts groups and organisations. There are also Arts Access Grants available for older persons and Community Arts Grants for small scale community arts events. The closing date is Tuesday 25th October at 5pm.

Grant clinic (both online and in person) giving an opportunity to meet some of the Arts team, who can answer questions and assist with the application process will be held in October.

Dementia Inclusive Autumn Programme for Carers

This is an interactive and engaging creative programme specifically designed with carers in mind. It is also devised to be open and welcoming to people living with dementia that may like to attend with their loved ones. A range of events will take place in various libraries, programmed by the Arts Office and Library Service; the first is a dementia inclusive dance session on 28 September. This programme is funded by Creative Ireland's Creativity in Older Age Programme 2022.



Towards a Creative Dún Laoghaire

The Arts Office and the Economic Development Unit are working in collaboration with the Public Design Lab in IADT on this exploratory project. The aim is to research, ideate, and propose actionable ideas to facilitate the development of the local creative economy in the Dún Laoghaire area, and to discover ways to enable IADT graduates and other creatives to stay working within the area; additionally, looking at ways to deepen the relationship between IADT and DLR. As part of the process, 2 groups of IADT students spent the week of 26 September participating in a Design Charrette focusing on Creative Dún Laoghaire, working in County Hall, dlr LexIcon and IADT. This was an intensive, hands-on workshop bringing people from different disciplines and backgrounds together to explore ideas and potential approaches. This project is funded under the Creative Ireland Creative Communities Economic Action Fund.

Successful facilitators will form part of the ongoing collaborative arts and culture programme, Cuairt agus Cultúr, with day care centres being included along with residential care settings in the County. This programme will be supported by the <u>dlr Age-Friendly Programme</u>.

Event Programming for Ukrainian Guests

Using Dormant Accounts Funding received, a programme of events for October and November is being planned in conjunction with our colleagues in the Community Dept. Events include: Yoga workshops, Art classes, Puppetmaking workshops, Craft sessions, English classes and Early Years workshops.

Autumn Medley of Age-Friendly Creative Activities: Thursday 29 September

dlr LexIcon hosted this day of free age-friendly creative events from 11am-2pm, which included music & drama performances, dance, entertainment, painting, crafts, dementia-inclusive Gallery events and information stands, to give a taste of the many creative opportunities available for older people in Dún Laoghaire-Rathdown. An array of representatives including the Dún Laoghaire Men's Shed, dlr Libraries & Arts Office, Living Well with Dementia, Migrant Women 4 Women programme & IADT were available with information and advice on services and programmes, and on how to engage in creative activities in the community.

Creative and Social Programme for Carers of People Living with Dementia

Supported by funding from Creative Ireland's Creativity in Older Age Programme, dlr Libraries and <u>dlr Arts office</u> present a series of events for carers, taking place across 4 of our libraries from the end of September and throughout October. Events include dance workshops, music, and art workshops. The interactive and engaging programme is specifically designed with carers in mind. It is also welcoming to people living with dementia that may like to attend with their loved ones.

ADHD Talks

Ahead of ADHD (attention deficit hyperactivity disorder) Awareness Month in October, we began a series of information talks, both online and in-person, on Tuesday evenings in September. The talks cover a wide range of topics including: Neurodiversity and ADHD in the workplace, Executive Function and ADHD in Women and Girls. Suitable for parents/guardians of children with ADHD or Adults with ADHD themselves.



My Open Library – Dalkey Library

In September, Dalkey became the second library in DLR to offer the My Open Library (MOL) service. This means extended opening hours to library members on a self-service basis outside of normal opening hours, 7 days a week, 365 days a year, from 8.00am to 10.00pm. Library members must be 16 or over to avail of the service and, in the case of those under 18, have signed parental consent.

Events for Adults

Clubs & Groups

A wide variety of clubs and groups continue to use our library spaces to meet.

These include the Language Exchanges and the Scrabble Club in Deansgrange Library, the Knitting Club in Cabinteely Library, and the Family Lego Club in Blackrock Library. Staff in Blackrock have also started a monthly Film Club for adults, consisting of a screening plus discussion. The Ciorcal Comhrá, the informal Irish conversation group, has returned to the LexIcon Café every Tuesday morning.

Each of the 8 branches have in-person book clubs, including the Audio Book Club in Dundrum Library with some also continuing with their online book clubs, due to ongoing demand. The very popular online monthly Book Club with Mary Burnham continues to meet over the summer months. The September title for discussion was *Grey Bees* by Andrey Kurkov.

In this its centenary publication year, a new *Ulysses* book Club for adults has begun in Dundrum Library. For those who've always wanted to read this literary masterpiece, members will meet monthly to discuss two chapters at a time in order to finish the tome by Bloomsday 16 June 2023.

Ranging in age from 18 to 40 years old, 'The Forgotten Ten' came from all over Ireland and from all sections of Irish society. Their executions made international news and some would become household names. The description of them as 'The Forgotten Ten' did not refer to how they were remembered, but rather that they remained buried behind the high walls of Mountjoy Prison until their re-interment in Glasnevin Cemetery in 2001.
