

# **Unmanned Aerial Vehicles (UAVs or 'Drones') Privacy Notice**

### **Purpose**

The use of unmanned aerial vehicle or drone imagery will be assessed on a trial basis by Dún Laoghaire-Rathdown County Council (DLRCC) in order to undertake research and explore options for assessing compliance with social distancing in the Council's outdoor, publicly-accessible amenity facilities, including piers, beaches, bathing areas and parks, and to assist the Council in making decisions on additional measures to help the public and amenity facilities users to comply with social distancing guidelines. This research exercise is in support Government's current Covid-19 response initiative (Health (Preservation and Protection and Other Measures in the Public Interest) Act 2020 ).

The trial will be operated in the Dun Laoghaire Harbour area or other outdoor, publicly accessible amenity facilities in the Council's area, as required, commencing in or around 30<sup>th</sup> April 2020, and continuing for a period of approximately one month after that. Notices will be placed at locations, where practicable, of the research test exercise on the day(s) that operations take place.

#### **Entities Involved**

The capture of drone imagery is being undertaken by Maynooth University and Compass Informatics Limited at the request of Dún Laoghaire-Rathdown County Council, and with the consent of the Council as it relates to the Council's functional area.

### What Personal Information is collected?

Images using normal colour and thermal imagery will be captured, as part of a research trial, in order to assess the usefulness of aerial imagery for assessing compliance with safe social distancing in outdoor publicly accessible, amenity facilities, in response to the current Covid-19 crisis. The drone sensors and imaging parameters will be set to record solely the presence or absence of a person. Therefore, images will be blurred and will not contain any personally identifiable information. Individuals cannot be identified based on the data that the drones will collect.

Data will be processed to produce density plots and inter-person distances. Access to the data will be restricted to Dún Laoghaire-Rathdown County Council, and Maynooth University and Compass Informatics Limited, with the Council's consent, which will be stored on secure servers. It is planned to delete all original raw imagery within 4 weeks of the data acquisition date. A risk assessment has been carried out in connection with capture, recording, processing, accessing, storing, analysing and ultimate disposal of this data.

## **Source of Personal Information**

It is not envisaged that any personal data will be captured or recorded as the result of this research trial.

# **Sharing of Data**



This data will only be processed by the Council, and Maynooth University and Compass Informatics Limited, with the Council's consent, for the purposes outlined above.

### **Retention Period**

The raw imagery will be processed, ideally, in the week following the trial surveys. Any original raw imagery will be deleted within 4 weeks of the data acquisition date.
