Introduction

Annual reviews related to the street bin service are conducted by the Cleansing Section of Dún Laoghaire-Rathdown County Council, the last one being in March of 2022. Each review looks at the distribution of bins across the county, the frequency of individual bin collections, the misuse of bins at some locations and the requests for removal or installation of bins since the previous review.

The bin service is a critical service within in the county and requires constant vigilance and staffing to ensure that bins are emptied and maintained in a timely fashion. Areas of heavy footfall due to the likes of social events or indeed day to day events can add pressures to the bin service and the demands can therefore be dynamic at times. DLRs Corporate Goals 1 & 5 of the Corporate Plan 2020-2024 are important to abide by as they highlight the significance of a quality community service whilst maintaining environmental spaces for recreational, sporting and cultural areas and as such, the bin service plays a key part in achieving litter free spaces for all to enjoy. This document is a non-exhaustive synopsis on the 'bin service' which outlines the findings of the 'March 2023 Street Bin Review'.

Seasonal Demands

As highlighted in recent Bin Reviews over the last 3 years, one of the consequences following the emergence of Covid-19 restrictions was a sudden shift in consumer habits. A dynamic shift in eating habits led to a significant rise in take-out meals and a subsequent surge in waste generation in the public realm and the consequences of these changes in habits are still seen and more apparent during the holidays and also during spells of good weather.

More outdoor eating areas have been generated since the onset of Covid-19 and this has left a lasting legacy on consumer habits in so far as it is now more common for groups and social gatherings to congregate outdoors and drink coffees or have a takeaway meal. The knock-on effect on the bin service is still as before, i.e. a requirement for more frequent collections on our bins.

Seasonal demands on the bin service require additional staffing resources at critical times in order to keep up with the dynamic pressures on the bins. Therefore, staffing operations are altered to cater for such demands with increased bin collections or litter picking duties in high priority areas.

In 2022, DLR deployed a series of temporary 1100L bins and barrel bins in strategic locations from Easter through to the end of the summer period. These additional temporary bins eased the pressure on the permanent Big Belly bin service and resulted in less littering problems than may have otherwise emerged.

Outdoor eating continues to be a popular activity with the knock-on effect that Big Belly bin hoppers can become blocked with pizza boxes thus rendering partially empty bins unusable. In 2021, DLR installed a series of pizza bins at strategic locations across the County in order to tackle the high number of Big Belly bins that were becoming blocked on a regular basis. The installation of the pizza bins has helped greatly, and DLR have maintained pizza bins at the locations listed below throughout 2022:

The Cleansing Section take great pride in the maintaining a high level of cleanliness across the county and in 2021, Dún Laoghaire town placed 6th out of 40 towns/cities that were surveyed during the 2021 survey that was commissioned by An Taisce and conducted by Irish Business Against Litter (IBAL). An interim IBAL report during 2022 designated Dún Laoghaire's town and seafront as being 'Clean to European Norms'. Furthermore, Dún Laoghaire received an award through the Academy of Urbanism for 'Great Town 2022' which is a reflection on many facets including the cleanliness of the area and the hard work put in by the Cleansing team as well as the local Tidy Towns and various community and business groups.

The street bin service budget for 2023 has reverted to normal pre-covid levels and will therefore mean a limited stock of new bins will be available for adding to the bin service as part of the bin review.

A summary of the key initiatives undertaken in 2022 to combat the increased demand on the Bin Service are listed below:

- Weekday and weekend bin collection operations were maintained in line with 2021 requirements.
- Temporary barrel bins and 1100L wheelie bins were deployed at busy locations during the summer months.
- Additional General Operatives were deployed in Towns and Villages, weekend hours were extended.
- An extra daily coastal collection route was maintained.
- Bins were relocated from low usage sites to high usage locations.
- Recycling Bins were installed at strategic locations within the County on a trial basis.
- Pizza Bins were also installed to decrease the high number of hopper blockages.
- Bin collections were heavily monitored with staffing adjusted as required.
- Regular monitoring and trend analysis were undertaken of the Big Belly Clean application statistics to inform the dynamic changes to service demand.



Anti-Litter & Dog Fouling Campaigns

As per the Litter Management Plan 2021 - 2023, DLR adopted a multi-faceted approach to the problems associated with litter pollution. The main initiatives of this plan include waste minimisation, dog fouling controls, recycling, road sweeping, litter enforcement, anti-litter and environmental awareness and other such litter related matters. A strong focus is placed on promoting a campaign of education and awareness regarding the problems associated with littering and dog fouling. Some key elements and actions from this campaign included:

- Cross departmental campaigns to promote better education regarding anti-littering. An external advertising agency was appointed to relay this message via DLRs bin adverts and other social media channels. Some such cross departmental campaigns included:
 - o Dublin Climate Action Week Dublin Community Clean-up
 - o Gum Litter Taskforce Education Campaign
 - o Picker Pals Primary School Programme
 - o Love Your Place, Leave No Trace
 - o Plastic Free July 2022
- Continued workshops on litter awareness.
- Promotion of the annual Tidy Districts awards for Resident Associations, Estate Management Groups and Tidy Town Groups.
- Continued support for the Tidy Districts with some 41 groups in operation during 2022.
- The Green-Schools Programme, known as Eco-Schools, is an environmental education programme run by An Taisce and Local Authorities. Approximately 100 schools are registered with Dún Laoghaire and An Taisce.
- Environmental Awareness introduced an anti-litter/dog fouling poster competition for Primary Schools within dlr.
- Acclimatize campaign in conjunction with UCD and other Local Authorities within the Dublin region. The campaign highlights the significant public health and safety issues associated with dog fouling and the impact on Dublin Bay bathing water.



Previous Smart Bin Review: March 2022

The outcomes of the March 2022 Street Bin review included:

- 1. 119No. requests for additional bins were received in 2021.
- 2. 5No. bins were removed from service since the last review due to excessive damage or vandalism.
- 3. In order to implement the required installations as per the 2022 report, it was proposed to install 25No. new bins within the County.
- 4. 17No. Big Belly recycling bins were installed on a trial basis throughout the County. The continued operation of these bins will be subject to funding constraints.
- 5. 119No. new requests for bin installation were received, 57No. requests were approved leading to the installation of bins at 25No. new locations and 62No. requests out of the 119No. new requests were denied.
- 6. Cleansing will continue to monitor bin performance and remained reactive to the dynamic changes that arose throughout 2022.

Street Bin Service

At the time of writing this report, the Cleansing Section maintains the following street bins;




Figure 2: Locations of 472 Smart Bins on DLR Streets - March 2023.

- A stock of 472No. Smart Bins, as shown in Figure 2. This has been increased from a stock of 439No. in March 2022. The original figure in 2015 was 400No. bins. Future considerations need to be more in line with waste reduction measures and upgrading/replacing existing bins within the County as opposed to continuing to increase the stock of bins.
- 16No. old style metal bins are located at beaches and areas where there's a risk of vandalism or in areas which are difficult to reach.
- 13No. dog waste bins are in service along coastal locations where it is not feasible to place a Smart Bin.
- During the summer period of 2022, we put into service 16No. barrel bins, 4No. standard metal dust bins and 6No. 1100L bins across the County to alleviate the pressure on the Big Belly service.

- At present, 24No. Recycling Bins have been installed at specific locations within the County as part of a pilot trial. Any further bin purchases or trials will require funding.
- 12No. bins have been removed from service because of damage, all of which were burnt out and reported to the Gardaí.
- All new bins are fitted with sensors which provide real-time feedback via a GSM telemetry system that monitors the waste levels within the bins. Alerts are triggered when a bin is near or at capacity thus increasing bin collection efficiency.

Recycling Bins

A Recycling Bin trial commenced in 2021 and dlr deployed 17No. Recycling Bins at strategic areas within the county to give a balanced representation across the County. During 2022, DLR Cleansing Section were able to add another 7No. bins to the trial thus giving us 24No. Recycling Bins in operation presently, please refer to Table 2(a) for specific locations.

Two distinct waste types were selected as part of the trial, these were plastic bottles and cans. Other waste streams such as paper and other general forms of plastic were considered but such materials can often become too highly soiled to be considered as a viable recycling waste material. Big Belly Recycling bins were paired with existing Big Belly general waste bins to provide the public with a recycling option for their plastic bottles and cans.




Figure 3b: Graphic Representation of 24No. Recycling Bin Locations

Recycling waste streams and collections of plastic bottles and cans have continued in a similar fashion as reported in the last years report. During the last 12 months, a total of 294,227 litres of waste was collected from the Recycling Bins.

Challenges still exist with liquids and other such contaminants being deposited in the Recycling Bins. Continuous education and awareness campaigns are needed to further inform the public on better usage of the Recycling Bins. Locations of the current stock of Recycling Bins are under review presently with a view to moving some of these bins to other more strategic locations so that more widespread information can be gathered.

Damaged Smart Bins

Twelve smart bins were damaged in the period March 2022 to February 2023, these are listed in Table 3 below. All of these bins were seriously damaged and have been taken out of service. All but one was fire damaged and all were reported to the An Gardaí Síochána. Only two units were suitable for repairs.

Collection Frequency January 2022 - December 2022

Collection and maintenance of street bins in Dún Laoghaire-Rathdown was traditionally carried out by two Cleansing Crews Monday to Sunday however, since the onset of Covid 19 this has increased to as many as 3 crews. The collection frequency shown below does not truly represent the full increase in effort or work done as the figures only reflect waste collections from within the bin and not contagious to the bin.

Monthly collection data from the 1st of January up until the 31st of December 2022 is presented below in Figure 5 and in Table 4.




Figure 6: Bin Collections 2015- 2022.

As shown in Figure 5b, the Easter and summer periods generally lead to higher bin collection numbers due to an increase in the number of people that now tend to congregate outdoors for social and recreational reasons. Figure 6 shows that the overall number of bin collections for 2022 is on a par with the number of collections for 2021 which reflects the significant increase in bin collections over the last 2 years. The bin service has grown by 153% since its inception in 2015 and it of huge importance to DLR.

Individual Bin Efficiency

The 'Clean Big Belly Bin' online application gives access to information regarding each individual bin. Using this system, bins with abnormal collection frequency can be identified and examined. These bins then become the focus of attention and thereafter they are examined to ascertain why the collections frequencies are abnormal. In some instances, the extenuating factors causing the abnormal collection rates cannot be mitigated and actions such as removal or relocation may need to be considered.

The following images display the frequency of collections of each bin as an average number of days between collections.




Figure 7: Bins Requiring Emptying Every Single Day.

Figure 7 shows the locations of bins requiring emptying every single day with 42No. bins collected every day in 2022. This has decreased from 72No. bins collected at this same frequency in the preceding year, 2021, thus forming a 58% decrease. In the previous 2 years the single day collection numbers have always increased. This decrease for 2022 is most likely a reflection on the increased

number of bins within the county over the previous years and therefore somewhat easing the pressure on daily bin collections in some locations.




Figure 8: Bins Requiring Emptying Once Every Two Days.

Figure 8 shows locations of bins requiring emptying every two days. 120No. bins were collected every 2 days in 2022 which has decreased from 138No. bins collected in 2021 thus forming a 13% decrease in collection frequency.




Figure 9: Bins Requiring Collection with a Frequency of Between 3 and 7 Days.

Figure 9 shows locations of bins requiring emptying every 3 to 7 days. The data shows that 231No. collections were required on bins every 3 to 7 days which is an increase from 187No. collections during 2021, a 19% increase.




Figure 10: Bins Requiring Emptying Every 8 Days or More.

Figure 10 shows bins requiring collection every 8 days or more. The data shows that 37No. bins required collection every 8 days or more which is very similar to the 2021 data which showed that 34No. bins required collection during the same frequency. This is due in part to better strategic placement of bins at areas of increased demand however, the reader should note that a reduction in this metric equates to units slipping into one of the other frequency bands above.

Figures 7, 8, 9 & 10 highlight that the demand for emptying bins has remained in line with the public's requirements and that the number of bins requiring collection every day or two days has decreased when compared to 2021 figures and this may be a reflection on a somewhat satisfactory quantity of bins within the County.

Operational Issues

As in the previous reports, DLR operatives have continued to observe increases in the collection weights related to bin waste. It has been assessed that this is due mainly to domestic and/or commercial waste disposal being illegally deposited in street bins. Increased activities and social interactions within the local communities has also led to increases in the weights of bins that are collected, i.e. outdoor eating and drinking habits have resulted in heavier bin collections.

On-going investigations and feedback from staff into the disposal of domestic waste in street bins has shown that the level of domestic waste in street bins still accounts for approximately half of all waste disposed of. Measures have been taken to reduce the ingress of domestic waste and some successes have been observed but they are generally short lived.

Manual Handling Issues

Difficulties related to manual handling and excessive bin weights continue. It is well established that excessive weights in street bins are a direct consequence of the illegal disposal of both domestic and commercial waste.

The level of rubbish from the illegal disposal of domestic waste has increased the weights of bins to over 50kg per bin in some locations. Current collection-vehicle configurations consisting of tail-lifts (and sliding mesh-side access panels) are awkward to utilise. A second-hand bin truck was purchased in 2021 and has been a great addition to the fleet as it allows for more efficiency when collecting bins throughout the County. The mechanical element of the bin truck allows for the operatives to dispose of heavy bins whilst doing so in a fast and efficient manner. Two new bin trucks were expected to be added to the fleet during 2022 however the supplier has encountered numerous delays due supply and manufacturing constraints and it is now expected that the bin truck will arrive in late 2023. The purchase of these trucks has been made possible through Local Authority budget allocation in 2021 and grant funding from central government.

Bin and waste collections during the busy summer periods has always been a challenge and we have added a Utility Terrain Vehicle (UTV) to our fleet to enable for ease of access around the county and particularly to our beach locations.

Requests for New Bins

Requests are received regularly from members of the public, elected members and residential associations for the installation of additional bins.

If initially approved, a request must still meet with the criteria for suitable installation sites (see appendix A), only then can the installation of a new Smart Bin in the most appropriate place be fully approved. Whilst every effort is made to ensure that the approved locations are suitable sites for the installation of a bin, there is always a possibility that site conditions will force departure from the planned installations.

Proposed Installation of New Smart Bins in Response to Requests

The 2022 review period was another busy year with requests submissions for new bins, 108No. requests were logged over the period from February 2022 up to end of February 2023. Every request received an initial response stating that the outcome of their request would only be made known upon publication of the bin review. Non-specific requests i.e. 'multiple bins over large areas' can't be fully detailed in this report. If one location, in a non-specific request is granted then the outcome as measured against the full request is deemed as a single approval. Requesting bodies and their agents should strive to make each request as specific as possible. Following extensive research and consideration of each request, 42No. requests were granted out of the 109No. requests.

New bin installations must take account of criteria shown in appendix A. New installations or replacements need to be considered against the number of bins available for relocation, the purchase cost of additional bins, and the need to prioritise new bins for deployment in the urban streetscape. Following our review, it is proposed to place 11No. new Smart Bins in the locations listed below in Table 4. These 11No. installations will satisfy the 42No. approved requests. 67No. requests have been denied one of which has been held as open for further consideration. ** (No 2023199)

Summary of the March 2023 DLR Street Bin Review

- 1. 109No. requests for additional bins were received since the last review. See Appendix C.
- 2. 12No. bins were removed from service since the last review due to excessive damage or vandalism. It is proposed to replace some of these bins. See Appendix H for a list of damaged units.
- 3. In order to implement the required installations as per this report, it is proposed to install 11No. new Big Belly solar bins within the county as listed in Table 4 along with 4No. metal bins at coastal reaches. Once these bins are installed, DLR will have very limited stock to account for replacing bins within the County due to fires or other reasons. Furthermore, with limited budget provision for new bin purchases in 2023, DLR will have a significantly smaller allocation of new bins to consider as part of next years Bin Review.
- 4. 17No. Big Belly recycling bins were originally installed on a trial basis throughout the County. This has since been increased to 24No.
- 5. Of the 109No. new requests for bin installation received, 42No. requests have been approved leading to the proposed installation of bins at 12No. locations. 67No. requests out of the 109No. new requests have been denied. 67No. requests have been denied, one of which is

held open for further consideration.

- 6. Cleansing will continue to monitor bin performance and remain reactive to the dynamic changes that may arise throughout 2023.
- 7. It should be noted that circa 300No. of the existing fleet of Big Belly Bins were installed in 2015 and as such they are aged and reaching the end of their service life. Replacement of these bins will be an important element to consider in the near future rather than expansion of the existing stock of bins on the streetscape.

Requests for New Bins / Amendments

Members of the public or elected members can submit requests in relation to street bins. Requests can range from the removal of street bins to the installation of new bins. All requests should be concise and specific in relation to the proposed individual locations and be logged through the councils Civic Hub email address: info@dlrcoco.ie. The cut off point for receiving new requests is the 21st of February thus allowing such requests to be reviewed and included in the annual Bin Review. Subsequent requests will be considered as part of a next annual bin review.



Appendix A: Criteria for the Placement of Street Bins

The Cleansing Section receives requests for new bins regularly. These requests are considered at each street bin review with consideration given to the following factors:

- Whether some bins are under-used and could be more efficiently placed.
- Whether additional bins are required in areas considered to be litter black spots.
- Accessibility and mobility considerations, such as footpath width.
- Safe system of work whether there is a safe place for council vehicle to pull in to safely empty the bin.
- Locations close to schools, shops and shopping areas are generally prioritised.
- The risk of vandalism at certain locations.
- Whether there is a high risk of disposal of domestic waste in particular locations such as in residential area.

It is generally found that a large proportion of requests for new bins are proposed in locations within or around housing estates, areas where there is a high risk of vandalism or in locations where it is not safe from a traffic management perspective regarding maintenance of bins.



Appendix B: Bin Service in Parks

Across the County, departmental jurisdictions dictate that specific areas of control fall under the remit of different individual sections. As such, the cleansing-section are responsible for the provision and maintenance of bins within all public areas, other than parks, with some minor exceptions. Both Cleansing and Parks have strict criteria which are used to assess the suitability of individual bin placements.

It is identifiable that cleansing maintain a large portion of their current bin stock at locations that are placed near to parks and park entrances. Such bin-placements are only considered viable if they satisfy cleansing's strict installation-criteria. The cleansing section maintain smart bins within the streetscape along with some 14 metal coastal bins and several dog waste bins.

Bins are generally only provided within parks which maintain a complement of staff. Bins within Marlay Park, Cabinteely Park and other flagship parks throughout the county are maintained by the Parks Department staff. Reports in relation to these bins within parks should be addressed to the Parks Department. It should be noted that the Parks Department do not provide bins in local amenity neighborhood parks. (note *)
