This notice should be read by all Masters, Owners, Operators and Agents of all Vessels arriving to Dun Laoghaire Harbour who are directed to comply with the **Department of Transport Tourism and Sport Marine Notice No. 02 of 2022 - AS AMENDED (10/06/2022)**

QUOTE:

The Department of Transport has been informed that, following a review of current circumstances locally and internationally by the Health Services Executive (HSE) and Health Protection Surveillance Centre (HPSC), it has been decided to stand down the requirements set out in Marine Notice No. 06 of 2020 – “Covid-19 (2019-nCoV) – Maritime Declarations of Health”.

Therefore, from Monday 10 January 2022, there is no longer a requirement for every vessel arriving in Ireland from outside the island of Ireland to issue a Maritime Declaration of Health (MDOH).

In line with the requirements of the *Infectious Diseases (Shipping) Regulations 2008* ([S.I. No.4 of 2008](#)), a vessel need only submit a MDOH when:

- 1) There is a case, or a suspected case, of an infectious disease on board and this has resulted in illness or death, or
- 2) upon a request to do so as part of a local arrangement with local Port Health Authorities.

MDOH if required, should be submitted to SafeSeasIreland as part of the vessel's pre-arrival notification
