Architects Directorate

Centre for Creative lifelong Learning

The Part 8 was approved for the Centre for Creative Lifelong Learning at George's Place/Wash House at the Council meeting on 14 April and the THRIVE Strand 2 application was submitted by the deadline on 15 April.

Bringing Back Homes

In April, dlr Architects hosted an event that explored the potential of using underutilised or vacant buildings to help address some of the challenges of the housing shortage and climate action. Bringing Back Homes – Revitalising Old Buildings in Dún Laoghaire showcased three examples of DL buildings that have been transformed into new homes. Dr. Kathleen Stokes from Dublin City University presented findings from the 2024 research report 'Opportunities and challenges of vacant above the shop units for residential use in Ireland'. The presentations were followed by site visits to dlr and private apartments.

Energy

Work is progressing to meet the 16 May deadline for monitoring and reporting data to SEAI. Collection of data for dlr fleet fuel and vehicle register has recently been completed. There is steady progression to get smart meters into all venues, where applicable. Shankill library is the latest venue to receive two smart meters. This will benefit dlr as it will eliminate estimates in billing and allow for accurate energy data. It is only possible to fit buildings with single phase meters at present, but efforts are being made to eventually have 3 phase smart meters installed for buildings with commercial appliance installations/applications.

dlr's Energy Tune up Clinic, part of Dublin Climate Action Week is on 14 May at Dundrum Methodist Church. It will help attendees learn how to reduce energy use, understand energy bills, and explore available energy grants for carbon savings.

Planning & Economic Development Directorate

Pre-Draft Public Consultation for the Rathmichael Local Area Plan

We are now commencing the process of preparing a Local Area Plan for the Rathmichael area. Submissions are invited from anyone with an interest in the future development of the Rathmichael area. Submissions can be made within the consultation period, which runs from 4 April to 9 May 2025. Two information sessions were held in April/May.

National Watersports Campus

dlr in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We hope to appoint a design team in the coming weeks to commence design and permitting for this project.

Dún Laoghaire Harbour Masterplan

A project to create a Masterplan to guide the future development of the Harbour has been approved. Tenders for a design team were issued to a consortium led by a Danish firm, Arrow Architects was the successful tenderer. The design team are now progressing to a draft masterplan design. Full consultation will follow once the report is at draft stage.

Blue House Site Ballinteer

St Michaels House are the owners of the lands known as the "Blue House" site, and have approached the Council Executive to engage in preliminary discussions about a possible collaborative development of site, particularly to include a "Community Facility" in the area. High level discussions are continuing between the parties including making the necessary arrangements for Feasibility studies to be carried out on the site. This is with a view to reaching an agreement in relation to their requirements for the proposed development of the site subject to all the necessary consents and approvals.



Cruise Ship Business

Dun Laoghaire Harbour are expecting approximately 79 Cruise ships in 2025, with approximately 125,000 passengers and 50,000 crew.

Navy at Dún Laoghaire Harbour

The Executive have held a number of meetings with Navy Management in relation to the potential use of the Carlisle pier in Dún Laoghaire Harbour. Initial discussions had seen the Navy seek exclusive access to the Carlisle pier, which would have resulted in the loss of the pier for many opportunities and this was not agreeable to the executive. The executive have since advised that a section of the pier could be dedicated to the Navy (at a cost) but would maintain access to the remainder of the pier for the use of commercial opportunities that arise. The proposal and associated valuation for lease of the required section for the pier is currently being reviewed by the Navy.

Events: Regatta in July, Youth Laser World Championships in August and World Sailing Conference in November.



Property Management: Commercial Lease, Park House, Dún Laoghaire

Applications are now open until 22 May for interested businesses to apply for the lease of a commercial premises at Park House, 66 Georges St. Upper, Dún Laoghaire, Co. Dublin. This prime retail location is situated on bustling Georges Street Upper, right next to the People's Park, making it the gateway to Dún Laoghaire town.



Dublin Array Windfarm

The developers of the Dublin Array Windfarm (RWE) have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. RWE have lodged a planning application for the windfarm, to include the cable route, substation and Operations and Maintenance base in QI 2025. We are now working towards a lease agreement with RWE for the areas concerned.

Economic Development & Tourism

Economic Development now have appointed a full time Film Officer to collaborate with all departments and will provide centralised point of contact to engage with film industry stakeholders to grow the film, animation, game show and related industries in Dún Laoghaire-Rathdown.

Round 2 of the Business Area Promotion Grants were completed in April and recipients informed.

The Tourism department hosted a biannual tourism providers network with strong representation from over 60 providers in the county which was followed up with a familiarisation excursion for hospitality operators to experience existing visitor attractions in Dún Laoghaire-Rathdown.



Community, Cultural Services and Parks Directorate

BoxUp Brings Shared Sports Equipment to Ballyogan

The Samuel Beckett Civic Campus is the latest location to have BoxUp installed in Dún Laoghaire-Rathdown. BoxUp is an outdoor locker system that allows members of the public to borrow sports/leisure equipment for up to three hours of use. The unit has 6 different types of equipment to choose from to suit all needs and abilities including hurling, basketball, football, spikeball, frisbee, and skipping ropes. Users gain access to the equipment through a dedicated app where they can set up an account for free, all that is required is a form of identification.

New Playspace at Finsbury Park, Dundrum

This month, the newly upgraded play space at Finsbury Park, Dundrum, was officially opened and features a variety of inclusive and accessible play elements designed to foster adventure, creativity, and social connection for the whole community. The play space, which was developed in consultation with local community members and youth groups, has several innovative features. These include a play train with a slide, an ability trampoline, a hammock swing, a scooter track, a kickout area for soccer practice, and a social hub with seating and bike/scooter parking.



New refurbished Hyde Park Playground

This month the new refurbished Hyde Park Playground opened making it a vibrant and exciting new play space for the community to enjoy. Through an online consultation process with the community, valuable feedback was gathered and incorporated into the design brief for the renovation. The renovated playground now features 18 play elements, a significant increase from the previous seven elements, catering to toddlers, children, and teenagers. The new design includes picnic tables, seating areas, trees, climbing structures, and a variety of play items to meet the wishes of the children and parents in the community.





Stillorgan Library Information Sessions

Construction work continues on the new Stillorgan Library, which will open in 2026. As part of the preparation for the new library space, dlr Libraries fitted-out a kiosk in the Stillorgan Village Centre. As part of that, for three days, library staff were on hand to talk to the public about the new library and to answer any questions about the services and resources that will be on offer in the new library. Over 170 people attended the information sessions and the feedback on the proposed new library service was very positive.

DLR Comhairle na nÓg National Showcase

12 members of DLR Comhairle na nÓg, supported by staff from our Community and Cultural Development Department, attended the 2025 National Showcase event in Dublin Castle. This event was a celebration of all the work done by Comhairle na nÓg members from all 31 local authorities across Ireland. DLR Comhairle na nÓg members had the opportunity to highlight the work they have done over the past two years attempting to combat school stress through several initiatives. They received a certificate of achievement for their work and one DLR Comhairle na nÓg member was chosen to Chair a panel discussion between young people and decision makers.

Local Policing Fora (LPF)

The Meeting of the Central Dún Laoghaire LPF took place on 8/4/24 and the meeting of the Loughlinstown/Ballybrack/Shankill LPF took place on 15/04.25



Corporate Affairs Directorate

An Cathaoirleach's Office

April was a busy month for An Cathaoirleach with participation in various events and photocalls, including the launch of the Arts exhibition by Vanessa Donoso Lopez, the launch of the Guglielmo Marconi exhibition in dlr Lexlcon, the James Joyce Royal Canal Odyssey and an Easter Event in Myrtle Square. April also marked 10 years of dlr Lexlcon and saw the official opening of Hyde Park Playground.



Electoral Register

An Coimisiún Toghcháin published its first Oversight Report. Over the past number of years, we have been working to deliver on reforms outlined in the Electoral Reform Act 2022. This includes facilitating rolling voter registration and enabling online applications. DLR is in the top ten local authorities for two of the four accuracy indicators. Cherrywood SDZ

Nestled between the strategic road corridors of the M50 and the N11, Cherrywood SDZ is the largest of the 11 SDZ projects in Ireland. DLR in its role as the appointed Development Agency continues to proactively engage with the various stakeholders to bring forward proposals for development and in its role as a project team in the assessment of planning applications.

To date approx. 5,079 homes have secured grants of planning, with approx. 1,600 homes occupied with new families and in the region of 1,000 further homes currently under construction. Social infrastructure including schools, parks, playgrounds etc. is being delivered in tandem with these emerging communities.

Cherrywood Planning Scheme Amendments

Proposed Amendment No. 10 Non-Residential Car Parking was submitted to An Bord Pleanála on 29/11/24. The purpose of this is to update the approved Planning Scheme to align with National, Regional and Local policy, promote sustainable public and active travel modes and address Climate Change mitigation measures. The Board have recently advised of their intention to determine this matter in advance of 18/08/25

Proposed Amendment No. 11: Cherrywood Town Centre and Environs Review was submitted to An Bord Pleanála on 20/12/24 under Section 170a of the Planning and Development Act 2000, as amended. DLR now awaits their determination on the matter.

In the meantime, a briefing was facilitated to the Elected Members on the 13/02/25. Meetings were facilitated with all the Party Groups during April 2025 by the FPI Department. Cherrywood Local Infrastructure Housing Activation Fund (LIHAF)

The project comprises the new Druid's Glen Road, Druid's Glen Bridge, the new junction Q on the NII and a significant feature bridge spanning the Druid's Glen valley. This project comprising 3 distinct phases, is key to unlocking approx. 3,000 homes throughout the SDZ, and is a key transport link, particularly noting the new junction off the NII. A brief overview of the status of the project is as follows:



Phase I of this project comprising Junction Q (a new signalised junction on the NII) and part of the Druid's Glen Road (130m in length) is complete. Phase 2 comprising of circa 315m of road and a 40m short bridge spanning the Cabinteely Stream is at Practical Completion stage.

Phase 3, which is the final section of the road comprises c. 60m of road and a 120m significant bridge feature. DLR has appointed a multidisciplinary team of consultants to bring the final Phase of the Druid's Glen Road infrastructure project from concept design through to completion. Concept and Options Development is currently underway, which will help identify an emerging preferred vertical alignment and concept design for the bridge and sections of road in advance of stakeholder engagement and Preliminary Design.

Urban Regeneration Development Fund (URDF) Infrastructure

2018 - Call 1 - Cherrywood Parks, Greenways and Attenuation Project - Pond 5a

This regional attenuation and treatment pond for the Druid's Glen area of Cherrywood is nearing completion. DLR appointed Clonmel Enterprises Limited to construct this in the latter part of 2024 and when completed in early Q2 2025, it will support the Beckett Road delivery (see URDF Call 2) along with approx.600 homes as well as a significant amount of employment uses for surface water management.

2020 - Call 2 - Cherrywood Public Access, Permeability and Amenity - Beckett Link (& Barrington Rd Connection)

This project is significant and will be delivered in 2 phases to support in the region of 2,200 homes, providing improved access and permeability through the development of pedestrian, cycle and vehicle links from the Kilternan Link to the Cherrywood Town Centre.

This will serve to protect the dense neighbourhoods at the heart of the SDZ and also protect the M50 from local movement. The project in full entails the construction of c. 2.3 kms of new 2-way single carriageway urban road, 4 signalised junctions, 2 toucan crossings and the construction of an underpass under the Wyattville Link Road.

Planning permission for Phase 1 of this project was secured in November 2022 and DLR has engaged a consultant to progress Phase 1 through detailed design, tender, construction, and handover and final close out. Tender documents issued in December 2024 and closed in March 2025 and are currently under evaluation. Phase 1 is currently on target to commence on site in Q3 2025. This contract includes for c. 1.6kms of new urban roadway and will involve a significant temporary diversion of the existing Wyattville Link Road.





Sandyford District – Re-imagining and Maximising its Potential

Leveraging on the success of the multi-disciplinary, one-stop shop and whole organisation approach applied to Cherrywood SDZ, DLR is now applying this 'development agency' style approach as it embarks on undertaking a re-fresh and re-imaging of the Sandyford Business District to realise its full potential as a strategic employment hub of national and international significance, and also as a place of thriving neighbourhoods and communities.

This review is at the early stages, but the key aims will be to ensure efficient use of scarce urban land and public investment in infrastructure, to support a world class vibrant mixed use and sustainable place for people to live, work and play within thriving communities. We are committed to collaborating with all stakeholders to realise the full potential of Sandyford. In this regard, it is intended to facilitate a non-statutory 'Have Your Say' consultation with the suite of stakeholders and interested parties before end of Q2 or the upcoming summer. This consultation will seek to capture the insights and views of the interest groups, to gather the challenges to be addressed and to identify the opportunities. The output of the consultation will further inform the vision and optioneering exercises for the review and in the preparation ahead of an elevated plan-led strategy for the district.



Housing Directorate

Affordable Homes, Woodbrook, Shankill

We received 640 applications for 30 3-bed homes at Woodbrook, Shankill. The portal was open from 8-29 April.

15 Part V units handed over in Dundrum

Director of Housing Catherine Keenan, and local councillors were joined by Leas Cathaoirleach Kazi Ahmed and the Minister for Housing James Browne to officially hand over the keys to 15 apartments in Dundrum which will provide much needed homes for persons on the social housing list.

Leopardstown Road

Public Consultation for Part 8 Leopardstown Road (80 homes) closed 8 April.

Woodpark, Traveller Accommodation

Three homes onsite

Proposal for Housing Development, Mount St. Mary's, Dundrum Road.

Submissions opened in March for a new housing development proposal at Mount St. Mary's, Dundrum Road, Dublin 14. The proposal is for 129 no. units apartments in 3 no. blocks.

The proposed development includes: residential communal open space areas, public open space, ancillary structures and car/cycle parking including 12 EV charging spaces and 3 accessible spaces. Consultation closes on 1 May.

Blackglen Road

Public consultation for Part 8 commenced on 28th March for Blackglen, Sandyford (129 homes) Consultation closing 14 May.



Infrastructure & Climate Change Directorate

Love our Laneways, Sallynoggin

Our Active Travel section recently launched the "Love Our Laneways" initiative in Sallynoggin. The project, a collaboration between dlr, NTA, and A Playful City aimed to bring the local community in Sallynoggin together to reimagine an underutilised laneway as a beautiful and meaningful space for all those who live, work, and play there. The project has redeveloped the laneway, incorporating new areas for people to spend time, play areas for children, age friendly seating, traffic calming, accessible crossings, new pollinator friendly planting, new artwork and more.

dlr Central project on site: Works progressing well at Bakers corner and continuing down Kill Avenue

Phase 1 construction contract awarded for works associated with the initial traffic calming measures on the perimeter of the scheme. Start on site imminent.

Living Streets Blackrock: Construction tender to issue in 3 weeks.

Hillcrest Rd: Progressing towards Part 8 release on May 7

Blackrock DART to Park Active Travel Scheme: Undergoing consultant appointment for detailed design to completion

Glenamuck District Roads Scheme: Works on site on Glenamuck District Distributor Road and progressing well

M50 Junction 14: Undergoing review of construction tender submission.



Roads Programme

Road Maintenance Facility Expansion – Construction tender issued April 7. Currently reviewing EPA licensed boundary requirements to accommodate scheme.

The annual street bin review was brought before the April Area Committee's for noting.

Churchtown Road Upper: In April, works were completed on the Churchtown Road Upper scheme which consisted of approximately 300m of surface course replacement.

Glenamuck Road: Around 4,000m2 of road patching works was completed on the old Glenamuck Rd within the last month in order to address poor road conditions in the area.

Gully Maintenance Programme: Works are about 90% complete on this contract which is addressing approximately 100 legacy flooding locations around the County



Traffic and Parking

Speed Limit Signs: New signage installation complete. Still some redundant sign removal ongoing.

Parking Tender: Stage 2 of tender issued with a view to appointment in July

Parking Bye Laws: Bye laws review has commenced with a view to adoption later this year in advance of annual budget



Environment & Climate

A clothes swap shop event held in UCD in April where students had the opportunity to bring five items of clothing and swap for five other items that caught their eye.

In April, we sponsored the DLR Rubbish Film Festival. This is our second time to sponsor the event which was run the Lexicon Studio. We had over 50 TY students in attendance from six schools [eight schools presented films]

SPOTLIGHT ON Ferry Terminal


Quarterdeck have secured BCAR certification for the first phase of Ground Floor section of the Co-Working Office space at the former Ferry Terminal. This milestone paves the way for the first phase of office occupation to progress and preparation of the internal office space for formal leasing is now underway.

The next milestone will be securing BCAR certification of the 1st floor section of Co-Working offices, the process of which is well underway and is expected to be completed imminently and the plan is to have the Ground and 1st floor Co-Working office spaces in operation for May 2025.

Works on the facade of the building have progressed over the past few weeks and with Quarterdeck Logo and external branding becoming visible to the public in the coming week. The new Website and Office Space Leasing Portal is being finalised with a view to launching the new Quarterdeck dedicated marketing and promotion website in the coming weeks, to coincide with the certification and availability of leasable office space.

Works have also commenced on the next phases of the demolition and refurbishment of the Departures & Arrivals Areas of the Ferry Terminal over the past few weeks, which will include the start of an initial 8 week programme of demolition and removal of old ferry terminal equipment.

A number of tenants have already been secured for the initial Ground floor and 1st floor phases and will take up occupancy as soon as agreements are finalised.






