PROPOSED ROAD CLOSURES

SECTION 75 OF THE ROADS ACT, 1993 TEMPORARY CLOSURE OF MAIN STREET, DUNDRUM

Dún Laoghaire-Rathdown County Council is proposing to temporarily close Main Street, Dundrum between its junction with Kilmacud Road Upper to just south of the entrance to the Village Centre Carpark. The closure is to take place from 13:00 hours to 18:00 hours on **Sunday, 29th June 2025**.

The purpose of the proposed closure is to facilitate the Dundrum Arts & Cultural Festival.

A Traffic Management Plan will be in place and all diversions will be signposted.

Pedestrian and local access will be maintained at all times.

SECTION 75 OF THE ROADS ACT, 1993 TEMPORARY ROAD CLOSURE OF CASTLE STREET, DALKEY

Dún Laoghaire-Rathdown County Council has approved an application from Discover Dalkey Promotions Ltd. to temporarily close Castle Street, Dalkey from Church of the Assumption car park / The Queen's Bar to the former Allied Irish Bank / Maxwell's Pharmacy on **Monday, 2nd June 2025** from 11:00 hours to 19:00 hours.

The purpose of the closure is to facilitate safe parking and display of vintage cars as part of the Dalkey Vintage Festival.

SECTION 75 OF THE ROADS ACT, 1993 TEMPORARY CLOSURE OF M50 SOUTHBOUND BETWEEN JUNCTION 12 (FIRHOUSE) AND JUNCTION 13 (DUNDRUM)

Dún Laoghaire-Rathdown County Council has approved an application from M50 Concession Limited for the temporary closure of M50 Southbound Lane between Junction 12 (Firhouse) and Junction 13 (Dundrum). The closure is to run from **Monday, 26th May 2025** to **Saturday, 31st May 2025** between 22:00 hours and 06:00 hours each night. **(Night Works)**

A Traffic Management Plan will be in operation. Diversion routes will be clearly signposted.

The purpose of the closure is to resurface the road.

SECTION 75 OF THE ROADS ACT, 1993 TEMPORARY CLOSURE OF GLENAMUCK ROAD, CARRICKMINES

Dún Laoghaire-Rathdown County Council has approved an application from BAM Civil Limited for the temporary closure of Glenamuck Road, Carrickmines from its junction with Brambledown housing estate to its junction with Enniskerry Road (Golden Ball T-Junction) from **Friday, 30th May 2025**.

A Traffic Management Plan will be in operation and pedestrian and local access will be maintained at all times. Diversion routes will be clearly signposted.

A bus gate will be in place following completion of the road closure, in compliance with granted planning under Section 51 of the Roads Act 1993, which will prohibit through vehicular traffic other than buses.

Baker's Corner, Kill Avenue, Ashgrove

Intermittent Stop/Go traffic management will be in place between 10am and 4pm. The entrance to Ashgrove will remain closed all week.
