# **Corporate Affairs Directorate**

### An Cathaoirleach's Office

May was a busy month for An Cathaoirleach with participation in various events and photocalls, including the launches of Scéal Trail, dlr's Sports & Physical Activity Plan, Dublin Climate Action Week, the raising of the Blue Flag at Seapoint Beach and the unveiling of commemorative plaques for Michael A Walker and Sean McGarry. May also saw An Cathaoirleach representing dlr in Vincennes for the 80<sup>th</sup> Anniversary of the end of World War 2.

# Solar PV at Ballyogan Operations Centre wins All-Ireland Award

The Ballyogan Operations Centre Solar PV project has won the All-Ireland Business Award at the All-Ireland Entrepreneurs Summit. The project is part of the DLR Retrofitting Programme under the Climate Action Plan, and received 50% funding through the SEAI Pathfinder Programme. The system has already shown significant impact, providing 10,000 kWh of renewable electricity to the grid in just one month. In addition to the Solar PV project, the heating system at Ballyogan Operations Centre has been replaced. A cascade of four air-towater and one water-to-water heat pump system was commissioned in September, 2024,decarbonised the plantroom, resulting in a 98% reduction in natural gas usage.

### DLR Women's Committee Sets Out Vision for Empowering Women in Local Government

The DLR Women's Committee was established as a formal Committee of the Council in May. The vision of the Committee is to empower elected women in local government by enhancing visibility, leadership, and participation through networking, training, advocacy, and community engagement. Committed to gender equality, it fosters a supportive environment and drives meaningful change for lasting impact. Cllr Lorraine Hall was elected as Chair and Cllr Anne Colgan as Vice Chair.



# Planning & Economic Development Directorate

# Pre-Draft Public Consultation for the Rathmichael Local Area Plan

Submissions closed in May for the pre-draft consultation for the Rathmichael Local Area Plan. Two information sessions were held in April/May.

### **Naval Service**

We have been advised that the Department of Defence have been instructed to commence discussions with us with a view to securing berthage for the two new inshore patrol vessels procured by the Naval Service in 2022. Berthing trails have been completed and dialogue is ongoing with the Dept. with a view to agreeing a license in the coming weeks.

# Design and Planning to start on National Watersports Campus, Dún Laoghaire

This month, Frank Curran, Chief Executive, signed the design and planning contract for the new National Watersports Campus planned for Dún Laoghaire Harbour with Ready Architecture + Urbanism Ltd. This marks a significant step forward in the development of a world-class facility that will serve as the hub for watersports in Ireland. The multi-disciplinary team, which includes Arrow Architects Ltd, Blackwood Associates Architects Ltd., O'Connor, Sutton Cronin Ltd., Brook McClure Ltd, Atkins Realis Ltd, Michael Slattery Associates Ltd, and M-CO Ltd, will be responsible for designing, securing planning, and foreshore consent for the project.



# **Property Management**

## Commercial Unit, Park House, 66 Georges Street Upper, Dún Laoghaire, Co. Dublin

Closing date for Expressions of Interest in the ground floor commercial unit was 22 May. leven expressions were received by deadline. An Evaluation Board is currently being formed to assess proposals.

# Residential Zoned Property Tax (RZLT):

The Residential Zone Land Tax was introduced in the Finance Act 2021 and is contained in Part 22A of the Taxes Consolidation Act 1997. The tax operates on a self-assessment basis and is an annual selfassessed tax of land that falls within the scope of lands deemed to be a 'relevant site'.

Each Local Authority is required to first register for RZLT and then make an annual return to Revenue, the tax is calculated at 3% of the market value of land. Our final list captured 11 'relevant land' plots, of which, 4 plots were removed. Three Sites are currently under construction and one site fell within the curtilage of a Protected Structure and Monument. The remaining sites have Total Market Valuations of €26.6m and can be found in the appendix.

Deferrals have been submitted by Housing Department to Finance Department of 6 land banks, of which Part X process has commenced, awaiting approval from the Department for funding, in Tender Stage or awaiting ABP decision.

The Finance Department have responsibility for registering the sites with Revenue within the strict allotted timeframe and file the returns, ensuring deferrals have been logged appropriately. Returns delivered on time.

Solas Marine, Dún Laoghaire Harbour proposed 4 year 11 month Lease renewal noted at Dún Laoghaire (ICC) Area Committee on 26 May Solas Marine has been in situ at Dún Laoghaire Harbour since 2018 and are approved by the Department of the Marine for marine safety supplies. The proposed Lease will now proceed to July, 2025 Council Meeting for approval.

Urban Regeneration and Development Fund (URDF) Round 3

Distinct from previous URDF funding calls, the third round of funding support is specifically designed to address long term vacancy and dereliction across our URDF cities and towns and the acceleration of the provision of residential accommodation. This approach ensures the projects supported by the URDF align with the current objectives of other government policies such as Housing for All and Town Centre First. These objectives reflect the identified necessity to bring existing long term vacant and derelict buildings and sites into use for residential and other purposes. Providing this strategic support within URDF towns and cities will complement current and future URDF projects that involve a mix of public realm improvements, sustainable transport infrastructure, recreation and sporting amenities and site infrastructure works.

We are pursuing the acquisition of 2 properties with the assistance of this funding as follows :-

- No. 109 Lower Georges Street, Dun Laoghaire Purchase price and terms and conditions agreed with Valuers. Progressing to Contract stage.
- "Larabeag", Tivoli Terrace North, Dun Laoghaire Procedure to acquire compulsorily in accordance with the provisions of Section 14 of the Derelict Sites Act, 1990 commenced.

# Community, Cultural Services and Parks Directorate

### Launch of dlr Local Sport and Physical Activity Plan

This month, we unveiled our Local Sports & Physical Activity Plan 2025–2029 which signifies a significant advancement in dlr's ongoing dedication to promoting sport and physical activity throughout the county.

The new Plan builds on our strong history of supporting sport and activity at every level. With approximately 300 sports clubs covering 48 different types of sport, and over 120 sports facilities—in addition to facilities in 79 primary and 38 secondary schools—the county continues to be a hub for active living. The core objective of Local Sports & Physical Activity Plan is to get more people, more active more often.

## dlr celebrates 30 years of the Primary Arts Programme

Since 1994 our Arts Office has run a project to support artists to collaborate with primary school children and their teachers across the County. It is one of the oldest artists in schools' programmes in the Country. Since it began, the project has helped develop the creativity of thousands of school children.

To celebrate over 30 years of this service An Cathaoirleach, Cllr Jim O Leary paid a special visit to Scoil Mhuire to introduce a newly created worksheet for children by celebrated illustrator Chris Judge which has been sent to all the Primary Schools in the County, highlighting the many ways of being creative. Chris will hold a special workshop in a local school, and his original designs for this wonderful project will be featured on local big belly bins.



#### Nature and Place - Applications Open

The Arts Office is calling for applications from professional artists for a temporary project which explores some of the challenges of the climate crisis and focuses on the public forests in Dún Laoghaire-Rathdown County (DLR). Nature and Place 2025 takes place between September and November 2025 and offers the selected project a budget of €10,000 (including VAT). This project is funded by Creative Ireland, Dún Laoghaire-Rathdown County Council (DLR) and the Dublin Mountains Partnership. It is managed by DLR Arts Office and supported by Coillte. We are inviting an artist to explore these impacts and to engage in conversations with forest visitors and stakeholders as to how we might manage our interactions with our natural environment in a sustainable way.



#### **Arts and Health Programme May**

The HSE/dlr Arts and Health Programme supported Mental Health Ireland's 'Hello How are You?" Campaign with Council Colleagues this May. We also supported the Women4Women Multicultural Breakfast by hosting in dlr LexIcon Studio. This event also marked the end of the Watercolour Painting Project with Women4Women with a launch in the Project Room as part of the event. Participants from the Memory Harbour attended taster Brain Health Gallery Tours and taster session with library colleagues of the services available. Over 80 people attended these events supported through our Arts and Health Programme, learning more about the services of the Arts Office.



Comhairle na nÓg Meetings with An Cathaoirleach & Councillors

At the May County Council Meeting, two DLR Comhairle na nÓg members were invited into the Council Chamber to present to Councillors. They presented on their work from 2024 in addressing school stress and identified what they have been and will continue to work on in 2025 under their topic of "Youth Spaces & Facilities". The presentation was well received and was followed by a generous allocation of questions from Councillors.

As a follow up, staff from the Community Department in Partnership with Foroige, invited all Councillors to a Comhairle na nÓg Members meeting in May. This meeting was held to further delve into questions raised at the Council meeting while also allowing for some informal discussions on how Comhairle na nÓg and Councillors could work together. The meeting was attended by Cllr Jim O'Leary, Cathaoirleach and eight councillors including Cllr Carrie Smyth, Cllr John Hurley, Cllr Justin Moylan, Cllr Lettie McCarthy, Cllr Oisin O'Connor, Cllr Thomas Joseph, Cllr Tom Kivlehan, and Cllr Martha Fanning) Comhairle na nÓg members were blown away by the support given to them by Councillors during the meeting and will endeavour to make such meetings a regular occurrence going forward.



# Housing Directorate

### Affordable Homes, Woodbrook, Shankill

We received 640 applications for 30 3-bed homes at Woodbrook, Shankill. The portal was open from 8-29 April. Applications are currently being processed.

### **Leopardstown Road**

This scheme includes 80 homes in a mixture of duplexes and apartments in 2 blocks, ranging from 3 to 6 storeys. Public Consultation for Part 8 closed 8 April. This scheme was presented to councillors at the May Council Meeting and adopted.

## Proposal for Housing Development, Mount St. Mary's, Dundrum Road.

The proposal is for 129 no. units apartments in 3no. blocks. Consultation opened in March and closed on 1 May, submissions are currently being reviewed and this will be brought to the June Council meeting for Part 8 approval.

### **Blackglen Road**

129 dwellings including a mix of houses and apartments across 7 blocks, ranging from 2 to 5 storeys. Public consultation for Part 8 commenced on 28th March for Blackglen, Sandyford. Consultation closed 14 May, submissions are currently being reviewed and this will be brought to the June Council meeting for Part 8 approval.

### **Retrofit Project at Glasthule Buildings**

Work is progressing on the final phase of our energy retrofit project in Glasthule Buildings. Built in 1909, the development consists of 75 one-bedroom apartments in three separate blocks that are designated as older person's accommodation. In partnership with SSE Airtricity, we have completed retrofit work on 53 of the properties and are on track to complete the remaining properties over the summer months. On completion, properties will have a minimum of a B2 rating with some reaching A3.

Our Cleansing & Beaches team are proud that a Blue Flag status award has been granted for both Killiney and Seapoint beaches. Both beaches are very popular with bathers and beach users throughout the summer, and it is a great achievement to have obtained the award again this year. We strive to maintain our bathing water sampling regime and to keep our scenic beaches litter free for the public to enjoy.

#### **Road Maintenance**

Westminster Road – The contract has been awarded for the resurfacing of Westminster Road, Foxrock and works are expected to start on site within the coming weeks.

Trafalgar Terrace – The contract has been awarded for the refurbishment of the footpaths on Trafalgar Terrace, Seapoint and we are awaiting a start date from our contractor.

Gully Maintenance Programme: Works are about 95% complete on this contract which is addressing approximately 100 legacy flooding locations around the County.

## **Ballyogan Depot EV Infrastructure**

All of the existing EV chargers within the Ballyogan Operations Depot were upgraded to smart chargers this month meaning that the charging of the existing EV fleet will be more efficient and better managed.

#### **Designated Bathing Areas**

# Ferry Terminal

Quarterdeck have secured now BCAR certification for the Ground and 1<sup>st</sup> Floor sections for Phase 1 of the Co-Working Office space at the former Ferry Terminal. This milestone paves the way for the first phase of office occupation to progress and preparation of the internal office space for formal leasing is now underway.

The next milestone will be official launch and opening of the Ground and 1<sup>st</sup> floor Co-Working office spaces, which will become operational in the coming weeks. A suitable date is currently being looked at to schedule an official launch with the Cathoirleach and Chief Executive and Elected Members.

The new website and office space Leasing Portal is now finalised and ready to launch in the coming weeks, to coincide with the certification and availability of leasable office space. Significant progress has been made on the demolition and refurbishment of the Departures & Arrivals Areas & Food Hall area of the Ferry Terminal over the past few weeks, which will include the start of an initial 8 week programme of demolition and removal of old ferry terminal equipment.

A number of tenants have already been secured for the initial Ground floor and 1st floor phases and will take up occupancy as soon as agreements are finalised with Quarterdeck.
