  - (i) the reason or reasons for the proposed modification,
  - (ii) that a copy of the proposed modification, along with any assessment undertaken in accordance with paragraph (b) (ii), may be inspected at a stated place or places and at stated times during a stated period of not less than 4 weeks, and
  - (iii) that written submissions or observations with respect to the proposed modification may be made to the planning authority within the stated period. being a period of not less than 4 weeks, and any such submissions or observations will be taken into consideration before making a decision on the proposed modification, and the copy of the proposed modification shall be made available for inspection accordingly.
