## <u>Chairperson's Report from the Environment & Climate Action SPC 2nd December 2020</u>

Anthony McNamara gave a presentation DLR – Climate Change Action Plan Annual Progress Report.

The Climate Change Action Plan (CCAP) was approved in May 2019.

The four targets in the Plan are as follows:

- A 33% improvement in the Council's energy efficiency by December 2020;
- A 40% reduction in the Council's greenhouse gas emissions by 2030;
- To make Dublin a climate resilient region, by reducing the impacts of future climate change-related events; and
- To actively engage and inform citizens on climate change.

Anthony outlined the positive progress to date and answered SPC Members questions. Robert Burns also answered saying that the Plan is a live document and is evolving.

Cllr. Saul thanked Anthony for the Update.

The Presentation was **NOTED.** 

Government Waste Action Plan for a Circular Economy. Austin Baines gave an update on the Government's Waste Action Plan for a Circular economy. Austin informed members that it is a very extensive plan and it is a commitment in the Programme of Government. There will be an Education and Awareness campaign as part of the Plan. Getting the product design right at the beginning to encourage zero waste is key and will be EU led.
