CREATING AN ENVIRONMENT FOR ECONOMIC GROWTH

Plans and Policies

1. Local Economic & Community Plan (LECP)

Work is underway to progress the implementation of the Local Economic and Community Plan www.dlrcoco.ie. This is a key statutory plan to support and promote economic growth and enhance the quality of life and well-being of our communities in Dún Laoghaire-Rathdown. The LECP was adopted and launched in April 2016.

An Implementation Advisory Group has been established consisting of the Chairpersons and representatives from both structures to support implementation of actions. The Steering Group met on December 9^{th} and concluded that generally good progress has been made since the plan was launched in April 2016.

2. Tourism

A Tourism Working Group has been established to support the development of a Tourism Strategy & Marketing Plan for Dún Laoghaire-Rathdown. Following the conclusion of the public tendering process, consultants have been appointed to develop the Tourism Strategy & Marketing Plan for the County.

A presentation on the process for developing the Tourism Strategy & Marketing Plan was given at the Economic Development and Enterprise SPC on December 7th. The consultation phase of this project is now underway.

Active Land Management

The primary 'performance' indicator available to actively assess the issue of housing supply is the Dublin Housing Supply Coordination Taskforce (DHSCT) data - of which DLR contributes on a quarterly basis. The data utilised within the Household Taskforce is focused to capturing developments with planning permission for 10 or more units across the Dublin Region.

The most significant performance indicators - within DLR- are based on growth rates between Q3 2015 and Q3 2016. This includes:

- **22%** increase on the **number of sites** with planning permission from 60 sites to 73 sites.
- **29%** increase in the **total number of units** with planning permission from 5,631 to 7,274 units.
- 83% increase in active sites from 23 sites to 42 sites.
- 73% increase in the number of units under construction from 1,160 to 2,003.
- **865** completions over **first 10 months** of 2016 which is **above** completion rate for **the entire 12 months in 2015** of 651 units. This equates to a 32% increase in completions over a significantly 2 months shorter time period

This section requires comparison with HTF Q3 2016 data from the other 3 Dublin Local Authorities.

The most salient and positive performance indicators are based on DLR providing:

- **20%** of **units with planning permission** within the Dublin Region.
- 30% of Active Sites within the Dublin Region.
- 31% of units under construction within the Dublin Region.
- 17% of all units currently being processed within planning system the Dublin Region.
- 25% of all housing completions across the Dublin Region (Jan-Oct 2016 based on ESB connections data)

Plans and Policies

1. Arts Policy Consultation

The Arts Development Plan 2016 – 2022 was approved at the November Council meeting. The plan will be published in Jan 2017.

Capital Projects

1. Cabinteely library

Finished.

2. Blackglen Road/Harold's Grange Road Improvement Scheme

The Part 8 for this scheme was approved on the 13th June 2016 by the Elected Members. RPS Consultants are preparing the detailed design and CPO drawings. Target date for publishing CPO is April 2017.

3. Foxrock Village Car Park

Works commenced on site early November 2016 and expected to be finished early February 2017

4. Corbawn Lane - Beach Access

The following tasks are programmed in Q1/2 2017 Landowner Agreements Funding Application to OPW Detailed design and tendering

5. Glenalbyn Pool

Representatives of the Council and Kilmacud Crokes GAA Club have met and agreed that they would work together to address all of the matters regarding the impacts of the pool refurbishment project on the Club's facilities in Glenalbyn in a comprehensive way and that engagement would have to involve consultation with the Club members

6. Cherrywood SDZ – Progress Report.

The current Main Work Streams to realise the delivery of the Cherrywood SDZ include:

- Druid's Glen Road- Part 8 being advanced by dlr Road Projects in respect of Junction "Q" in advance of the overall Q-P3 scheme and it is proposed to go to public display on this shortly
- The Part 8 design preparation for the Bride's Glen to Shankill scheme being advanced by dlr Road Projects;
- The commencement of design scoping for the supporting greenway infrastructure with the SDZ area:
- Funding options for the delivery of the Infrastructure to support the SDZ including LIHAF and Cherrywood Section 48 Development Contribution Scheme;
- Town Centre the Urban Form Development Framework (UFDF) The DAPT's preparation of the Plan is well underway in collaboration with the relevant landowners (ref page 67 of the Cherrywood Planning Scheme). It should be noted that the preparation of the UFDF is a pre requisite to the approval of any planning applications for the Town Centre;
- The Amenity Open Space Guidance Document is in final draft stage and will provide guidance for the design and management of quality communal open spaces; and
- Surface Water Attenuation Strategy technical workshops are on-going with both landowner technical representatives and dlr Water Services to agree a collaborative approach on various aspects of the requirements of the Planning Scheme.

Planning Applications

The following major infrastructural projects have been granted permission, with a contractor appointed - the timeline proposed is for the works to be complete by the end of 2017 with some of the landscaping elements being completed Jan/Feb 2018.

A formal pre-planning request was received on 18^{th} November 2016 in relation to the development of Block F (F1 & 2) and multi storey car park

Stakeholder Engagement

The delivery of the Scheme is complex requiring a number of stakeholders to engage and dlr as Development Agency is actively promoting the implementation of the objectives of the approved Planning Scheme through collaboration and engagement with all relevant stakeholders.

With Government's focus on the housing crisis the Department of Housing, Planning and Local Government has taken specific interest in progressing the Cherrywood Planning Scheme. Meetings with all key stakeholders are on-going and a presentation is to be given on 21st December 2016 to the elected members, with a further presentation to be arranged for those unable to attend in January 2017. The presentation will include a viewing of the 3D timber model built by Hines Real Estate Ireland, which provides a comprehensive overview of the entire development and associated infrastructure provision and a walk-through of the show apartment.

Funding

It is acknowledged that a suite of infrastructure and services are required for the full development of the Planning scheme. As a Planning Scheme, infrastructural facilities and services that benefit the development can be funded by way of a supplementary levy scheme under Section 49 and /or an additional Section 48 levy scheme and /or a supplementary Section 48(2) (c) levy scheme as facilitated by the Planning and Development Acts 2000 – 2010 as amended. At the 14th December 2015 Council meeting, the Council provided for this to be progressed as part of the adoption of the Dun Laoghaire Rathdown County Council Development Contribution Scheme 2016 – 2020.

It is critical that a robust funding stream is established to ensure that infrastructure can be realised. Extensive progress has been made in relation to the funding mechanism required for the delivery of Cherrywood common infrastructure, to include a Cherrywood Section 48 Development Levy Scheme. The common infrastructure elements include for a road network in the order of 10km, storm water infrastructure in the order of 3.8ha and the delivery of 29.7ha of open space − class 1. An informed cost estimate for the delivery of the common infrastructure will be approx. €160,000,000 for construction alone. Discussions are ongoing with the Government's Housing Project Delivery Office and the DHP&LG is the assessment of options to fund the required funding in addition to a proposed Cherrywood Section 48 Development Levy Contribution Scheme. These discussions will inform the Cherrywood Section 48 Development Contributions Scheme to be brought to the Members. It is envisaged that these discussions will conclude shortly to allow a draft Scheme to be brought to Council as soon thereafter.

An application under the Local Infrastructure Housing Activation Fund (LIHAF) in support of infrastructure provision in Cherrywood was made by **dlr** & supported by the landowners in October 2016, with further information, requested by the DHP&LG, submitted on 3rd December 2016. Cherrywood was announced as one of 13 Pathfinder areas across the country and it is envisaged that LIHAF funding could play a key part in reducing the overall burden of infrastructural contributions.

Scheme Amendments

The Planning and Development (Amendment) Act 2015 https://www.oireachtas.ie/documents/bills28/acts/2015/a6315.pdf as recently published provides for streamlining the process for the making of modifications to SDZ planning schemes. The new legislation provides for a new procedure in making an application to An Bord Pleanala.

The DAPT has advanced the preparation of a number of amendments to include for the application of the new Apartment Guidelines 2015 http://www.environ.ie/sites/default/files/publications/files/apartment guidelines 21122015.pdf. Four amendments have been prepared that relate directly to the above apartment guidelines legislation in terms of addressing/clarifying apartment development within the SDZ to ensure consistency with Government policy. A further fifth amendment relates to the development of the Town Centre (retail element). In the preparation of the Urban Form Development Framework (UFDF) the form of the construction project for the Town Centre is crystalling for reasons to do with construction, cost and layout. This requires amendment to the sequencing of development within the Town Centre.

To accelerate delivery of housing on key strategic sites in line with Government policy and acknowledging the large scale of infrastructure of roads and public parks currently underway, a review of the Phasing & Sequencing element of the Scheme is well underway. It is envisaged that proposed changes will make the site more accessible for development in respect of all development, including accelerated residential delivery.

It is envisaged that further amendments will be considered by the DAPT in the coming months.

7. Brennanstown Road Traffic Management Scheme.

The scheme went out on Part 8 Public Consultation on 19th August 2016. The closing date for submissions was 14th October 2016, and a large number of submissions were received. These submissions are currently being reviewed and it is hoped to present the Part 8 Report to the Council for their consideration at the February Council meeting.







Road re-construction and re-surfacing works completed satisfactorily. Footpath restoration works completed satisfactorily.

• Annaville Avenue - Blackrock

Tender formally accepted for road re-construction and re-surfacing works. Works not to be undertaken until "Water Mains Rehabilitation" works are completed.

"Water Mains Rehabilitation" work commenced on site on the 21st November, 2016 and was completed satisfactorily. Having regard to the date of commencement of the water services works, the road re-surfacing and footpath restoration works may need to be postponed until 2017

Allen Park Road & Drive – Stillorgan

Works carried out and completed satisfactorily.

• St. Bridget's Park & Gort na Mona Drive - Cornelscourt

Works carried out and completed satisfactorily.

• Bird Avenue - Clonskeagh (including Traffic Scheme)

Road re-construction and re-surfacing, to include works required by the Traffic & Road Safety Section, carried out and completed satisfactorily. Footpath restoration works also completed satisfactorily.

2. Road Patching Programme

This Programme of work has been commenced in 2016. "Road Patching" is a process where a section, or sections of a road, are re-constructed and/or re-surfaced by Contractors where pot hole filling or temporary repairs are no longer considered to be viable.

The process is beneficial in maintaining roads in a safe condition pending the carrying out of a full re-surfacing job, and extends the lifespan of the current road structure.

The public consultation period on the draft plans for the Eastern River Basin District ended on 3rd December 2016.

Dun Laoghaire Rathdown's observations of the draft FRMPs were adopted by the Council at its meeting of 12th December 2016 and have now been forwarded to the OPW.

The draft Plans will be finalised taking on board the comments received and will then be sent to the Minister for Public Expenditure and Reform for approval. If approved, they will then be sent to the Local Authorities who may adopt them. A national prioritised list of flood risk management measures has not been developed as this can only be finalised when comments submitted during the consultation process have been taken account of.

Comhairle na nÓg

The AGM of the Dún Laoghaire Rathdown Comhairle na nÓg was held in County Hall on Thursday 17th November 2016. Attendance at the AGM was open to all young people in the County, aged from 12 to 17 years. Comhairle na nÓg is the council for young people in Dún Laoghaire Rathdown that gives them a voice on the development of local policies and services and is the recognised structure for participation by young people in decision-making in the local authority.

Consultation with the young people in advance of the AGM resulted in the topic *Mental Health* and *Young People* being selected as the topic for discussion at the AGM and will be the focus of the Comhairle's work in 2017.

The first meeting of Comhairle na nÓg took place on 8th December 2016 with 21 young people in attendance. The next meeting is scheduled to take place on 19th January 2017 at which attendees will be elected to fill various roles on the Comhairle.

Age Friendly Strategy

The DLR Age Friendly Older Persons Support Service, which is one of the goals (8.1) set out in the Age Friendly Strategy, commenced on 1st November 2016. The purpose of the service,

which is being delivered by ALONE with support from this Council, is to assist and support older people in their efforts to access and navigate social, cultural, health and public services.

Work is underway, in conjunction with the DLR Chamber of Commerce, to develop the *Petal Project*, which encourages businesses to make their toilet facilities available to older people without fuss and it is hoped to pilot this initiative early in 2017.

Social Inclusion

The Social Inclusion Programme of Events ran from 7th October to 15th October 2016, with four (4) major events and numerous locally based community events promoting the positive work done by local communities, in collaboration with the Council and partner agencies, to eliminate disadvantage and social exclusion.

Community Awards

The Community Awards Ceremony was held on 13th October 2016 with awards presented across seven (7) categories to representatives of community and voluntary groups. Supporting community engagement, participation, volunteerism and active citizenship is one of the Council's key objectives. A public exhibition of the entries and the Awards Ceremony help to recognise and reward the role that community groups play in developing and improving their communities in partnership with the Council.

Pride of Place 2016

The annual Pride of Place competition, which is an all-island initiative, promotes and celebrates the best in community development and recognises the selfless efforts of people in making their local communities better places in which to live. Dún Laoghaire Rathdown County Council had submitted 2 entries in the 2016 competition, in partnership with the Shanganagh Rathsallagh Clifton Estate Management Forum and Ballyogan Estate Management Forum.

At the IPB Pride of Place Gala Awards Ceremony in November 2016, Ballyogan Estate Management Forum was announced as the runner up in the Urban Neighbourhoods category.

Estate Management Programme

Each year, the Estate Management County Fora, with the support of the Council, makes provision for skip collections in the lead up to Halloween. The purpose of the skip collection programme is to reduce the level of pollution and damage to parks and open spaces from Halloween bonfires. Approximately 200 tons of waste was collected as part of this programme in 2016.

Training for the 12 Estate Management Groups took place on 3rd December 2016 and was delivered through Carmichael House. The training focussed on two key areas:

- Enabling groups to showcase work they have done throughout the year
- Recruiting and retaining volunteers.

The training helps build capacity within the groups and enables a stronger focus on estate management work within local communities in the coming year.

Rural Development Programme

A Rural Taskforce was established in in September 2016 to support the implementation of the Rural Development Programme 2014 – 2020 in the catchment areas of Glencullen and Tibradden.

The Taskforce has a remit to provide a strong voice for rural communities, support the development of rural Dún Laoghaire Rathdown and optimise the impact of the Rural Development Programme. In support of this remit, public Information events were held in Glencullen Community Hall on 15th November 2016 and Larch Hill Scouts Den on 17th November 2016 to publicise the Rural Development Programme and provide information to community groups, individuals and new or existing businesses.

Service Provision

1. CoCo Markets

Three business start-ups traded in Marlay Park Saturday market in quarter 4 2016 as part of the Inspire & Grow initiative with the LEO. These entrepreneurs have undergone the LEO's Kickstart programme and spend 8 weekends plying their goods at the CoCo markets to get exposure to the public and to roadtest their products in a real trading environment.
