7.1 Monitoring & Review

A monitoring programme, with targets, in respect of the potential effects of the implementation of the Plan on the environment is set out below. The purpose of the monitoring programme is to identify at an early stage unforeseen adverse effects and to be able to undertake appropriate remedial action. The relevant targets (and indicators) have been generated from the *Environmental Report*. A report on the outcomes of monitoring will be presented to the Dundrum Area Committee on a yearly basis. The Plan itself will be reviewed in the context of the County Development Plan Review.
