MAY MONTHLY MANAGEMENT REPORT

29 April - 31 May 2021



COVID-19

During May, the further easing of restrictions continued, with many Council services returning to normal.

The public health advice continued to recommend that staff continue to work from home were possible and as such staff continued to work remotely were possible. Access to County Hall by members of the public is by appointment only, for urgent business.

Updates on services affected, by department are detailed below:

Libraries

All dlr Library spaces re-opened to the public on **Monday 10 May**. This is part of a gradual, responsible resumption of onsite library services in line with <u>Government guidelines</u>. Services available during this phase include:

Return and borrowing of items, quick browse visits with restricted numbers in place and a return to usual staffed opening hours with late evenings and Saturday opening.


Printing from home, from a personal device, or from a designated quick-use PC and use of self-service photocopiers resumed while use of Surf box <u>postal printing service</u>, for next day delivery, and the availability of all our online services continued. The national reserves system was also re-instated during this phase as was the national delivery service for inter-county reservations.

However, as per Government guidelines for this phase, we are unable at present to provide any service which involves seating, including general seating or study spaces.

We are unable at this time to provide full access to Internet PCs/laptops, or to programme live indoor events in our spaces.

Book Drop Service

Since the re-opening of library spaces, and the continuing roll-out of the national vaccination programme, the number of calls to the Book Drop Service has continued to decline. Over **1,900** calls have been received since April 2020, with almost **11,500** books delivered to the elderly and most vulnerable members or our community. The end of May saw the final deliveries to homes by our volunteers in Serve the City. Deliveries, where needed, will now continue via the dlr Library driver.





The Community response to Covid-19 is being led and coordinated by **Dún Laoghaire-Rathdown County Council** in collaboration with a wide-range of stakeholders in the Community Response Forum, supported by a wide range of community and volunteer groups.

Community Response to COVID-19:

- Helpline and email address set up and promoted across all communication channels
- Operates 7 days a week from 9 am to 5 pm
- The Community Call Helpline has dealt with 4,453 calls since it commenced on 30 March 2020 and issues range from shopping, pension, medical, loneliness and isolation
- 70 calls were received in May. The majority of the calls relate to requests in relation to the HSE vaccination programme or for library books.
- The Community Response Forum is meeting every six weeks at present to support in coordinating the provision of a multi-agency response to the individuals in the community that are negatively impacted arising from the measures implemented by the Government to stem the spread of Covid 19.

Health & Wellbeing Initiatives:

Against the background of the Covid Restrictions, it was necessary to develop a range of initiatives to support health and wellbeing in our communities. The priority was to encourage communities to keep fit and active, stay connected and support them in looking after their mental health. Initiatives were rolled out across Libraries, Sports and Physical Fitness, Arts, Heritage and Biodiversity. The Council also partnered with Making Connections, that primarily looks after the elderly, in delivering a range of individual initiatives, in the community to help isolated individuals to connect with their neighbours.

Keep Well Campaign 2021

The Keep Well campaign is a national campaign which the government is promoting to help people stay well through the winter months. The Campaign is focused on 5 themes: Staying Connected, Switching Off and Being Creative, Managing your Mood, Keeping Active and Eating Well.

The promotion of the Keep Well Campaign in DLR continues. The 5 themes of the campaign are being promoted on social media. Each week focuses on a different theme with initiatives from the respective theme promoted.

Heritage

Planning Covid-safe heritage events for coming months. Online County Heritage Plan presentations and consultation. DLR Historian in Residence appointed to plan Covid-friendly hybrid events/exhibitions for dlr Decade of Centenaries programme. Filming recommencing in heritage properties.

Municipal Services

All sections are working closely with the Gardaí to assist in social distancing in public areas, including parks, open spaces, beaches, harbours and piers.

<u>Water Services:</u> all essential services continue to be provided, including water supply, drainage services including surface water management and flood management. All essential repairs, operational and maintenance works are continuing, routine and other works have resumed.



<u>Road maintenance:</u> the level of activity is at normal service with the majority of outdoor staff in operation. Essential operations including emergency repairs and upkeep, winter maintenance, responses to Gardaí and traffic accidents continue to be dealt with, and Road Resurfacing & Footpath upgrade programmes are in progress.

The Roads Control continues to grant and manage road opening licenses and permits for essential utility services, including electricity, water, gas and telecommunications as part of the Council's essential services operations implemented as part of COVID-19 restrictions introduced on Friday 8th January 2021.

<u>Cleansing/Street cleaning:</u> all Service are resumed, including litter removal, street sweeping/cleansing and litter bin emptying. Level of activity has increased with all outdoor staff back in operation.

<u>Traffic:</u> During the Covid 19 pandemic, the Council carried out several interventions <u>to</u> improve facilities for pedestrians and cyclists. This included the provision of cycle lane protection at several junctions and routes and the provision of wider footpaths using bollards and cones to facilitate physical distancing in towns and villages. In addition, village improvement schemes were carried out at Blackrock, Dundrum, Glasthule and Dalkey. A number of these schemes ran over into Q2 2021 and a total of €5.6m was spent on these projects up to 2020-year end.

In July, as part of a Stimulus package, the Government announced total package of just over €100m to support sustainable mobility. As part of this, about €9.0 million was allocated to Dun Laoghaire Rathdown County Council for 65 schemes. This funding was used for such interventions as cycle lane protection schemes, improved footpaths and road surfaces, and improved cycle links though parks.

Beaches/Harbours/Piers: All services have resumed.

Local Enterprise Office and Economic Development Unit

The Local Enterprise Office continues to offer grant and training supports to businesses impacted by Covid 19. A webpage has been setup for the specialised <u>LEO Covid supports</u> which contains details of all the government supports for businesses in these difficult times.

The Department of Enterprise, Trade and Employment launched the <u>Small Business Assistance Scheme for COVID</u> (SBASC) in March. The scheme targeted those businesses with operating costs that do not qualify for the COVID Restrictions Support Scheme (CRSS) operated by the Revenue Commissioners. Closing date for applications under this phase of the Scheme was April 21st 2021 and a total of 147 applications were received. This Scheme has now been extended to to include businesses operating from a non-rateable premises such as a home business or yard. This phase of the Scheme will be open for applications shortly.

In addition to helping companies adopt best practices in dealing with crisis, the Local Enterprise Office (LEO) is continuing to provide a full range of training supports, details of which are available here.

Fáilte Ireland has introduced a new <u>Outdoor Dining Scheme</u> which provides funding to individual businesses to introduce or expand their outdoor seating. The grant, which is for a maximum of €4,000, can be used to fund up to seventy-five per cent of the cost of purchases made since April 2020. The Scheme is open for applications until September 30



2021, and replaces the Street Furniture Grant which had been introduced by the Council last year.

The coming months will see the roll-out of a major initiative involving lighting up significant buildings. This is made possible by "Destination Towns" funding from Fáilte Ireland.

Work on *Dún Laoghaire Anseo*, a programme of street art for Dún Laoghaire town, is continuing. The project will be realised from June 22nd to 28th, and it is hoped that this will boost footfall in the town, subject to public health restrictions in place at the time.

Infrastructure and Climate Change:

The Directorate is continuing its work on the following CoVid19 interventions and Active travel programme.

- The Directorate continues to respond to environmental, waste and litter pollution incidents, as needed, and such incidents are recorded and managed as usual through the Civic Hub and the CRM system.
- The Council's waste recycling facilities remain open (at Ballyogan, Eden Park and Shanganagh) with social distancing and other HSE recommended protocols in place and the Council-operated Bring Banks continue to be serviced and made available for use by the public. Activity at these sites during Covid 19 has increased compared to the same months last year.
- Property Management continues to offer a full service.
- The Capital Projects Team continue to progress capital projects through design stages. Some delays are encountered with Covid restrictions on the construction sectors and associated services.
- Further engagement has taken place with representatives of Kilmacud Crokes GAA
 Club since the matter of the future of Glenalbyn Swimming Pool was raised at the May
 Council meeting. It is intended to provide a more detailed update to the members at
 the time of the July Council meeting.

Forward Planning Infrastructure

- The Directorate continue to engage with applicants, their representatives and other state agencies as part of on-line systems to include tele / video conferencing to facilitate workshops and reporting in the assessment of the Cherrywood Planning Scheme.
- Work continues in progressing the project designs and tender documentation of the Cherrywood Urban Regeneration Development Fund (URFD) - Parks, Greenways and Attenuation project, as well as the Cherrywood LIHAF project for the Druid's Glen Road.

Architectural Services

In line with Government guidelines all construction has re-commenced. Conservation and Dangerous Buildings services continued.

Housing

• The Housing Department, as an essential service, continues to operate although with some additional health and safety restrictions, due to Covid-19. Housing services including Homeless, Allocations, HAP and essential Housing Maintenance works are being progressed with additional supports provided as required to the vulnerable including the Traveller Community. Given the limited access to homes, some services



such as standards inspections and minor maintenance calls continue to be suspended. Part V negotiations have continued and applications for Housing Adaptation Grants for Older Persons and People with a Disability continue to be processed.

• Staff continue to engage with home loan borrowers and tenants who have been affected by a loss of or reduced income as a result of the pandemic.

Finance

<u>Rates:</u> The Government announced a waiver of commercial rates for the first 6 months of 2021.

This 6-month waiver has been applied to customers' accounts. Customers have been informed of their revised balances. The Council continues to work in partnership with businesses who are experiencing difficulty paying their rates. Payment plans are entered into which are mutually acceptable to the business and the Council.

<u>Accounts Payable:</u> Accounts payable are continuing to work to ensure suppliers are paid as quickly as possible to assist with their cash flow requirements.

<u>Financial Management:</u> The impact of Covid-19 on the Council's financial position has improved since the receipt of the rates wavier support from the Department. Budgets and cash flow continue to be monitored closely.

<u>Small Business Assistance Scheme For Covid – SBASC:</u> The Department of Enterprise Trade and Employment launched the Small Business Assistance Scheme for COVID (SBASC) on 11th March 2021 which was intended to target those businesses with operating costs that do not qualify for the COVID Restrictions Support Scheme (CRSS) operated by the Revenue Commissioners.

This scheme is now closed for applications. The closing date for applications was 21st April 2021 at 11.59pm.

The Council has won the County Council of the Year Award as awarded by the Public Sector magazine.





Stillorgan Village Movement Framework Plan

Phase 2-Lower Kilmacud Road from 100m east of the junction with Upper Kilmacud Road to the access road into Kilmacud Crokes GAA Club. Landscaping works have been completed.

Phase 3 – Lower Kilmacud Road from Kilmacud Crokes GAA Club to the N11. Design works are ongoing with a new road layout being examined to provide additional public realm benefits.

Road Safety, Cycling and Sustainable Travel

All sports clubs in the County were invited to apply for cycle parking via the online Public Consultation Hub and a press release was issued on May 14^{th} , 2021 to encourage clubs to apply by September 2021.

Traffic Advisory Group (TAG)

There were two TAG meetings held remotely in May 2021

On 26th May, the Area 1 meeting took place. A total of 26 items were discussed. On 25th May, the Area 2 meeting took place. A total of 34 items were discussed.



Bus Connects

The Core Bus Corridor (CBC) schemes are progressing to Final Design stage ahead of planning applications being prepared for submission to An Bord Pleanála with a target date now looking like July/August. CBC Route 15 - Blackrock to Merrion is to be included in the first tranche of planning applications to be submitted. Engagement with the Local Authority on both CBC routes (Bray to City Centre & Blackrock to Merrion) is on-going as final design is being progressed. The engagements focus on junction design, traffic signalling, public realm treatment, landscaping, drainage & public lighting.

Dundrum ABTA - Area Based Transport Assessment

Work on this project is progressing and it is anticipated that the ABTA Stage 1- Baseline Assessment, which will form the basis for the study, will be complete by the end of June.

Dundrum - Bus Interchange Project

Initial discussions have commenced with the NTA on this project which aims to address the need for improvements to bus interchange facilities in Dundrum to cater for the planned service increases under the BusConnects New Dublin Area Bus Network. It is envisaged that a series of meetings/workshops will be held over the coming months to progress this work and a multi-disciplinary group from the Council is in place to assist.

Old Conna ABTA - Area Based Transport Assessment

Work on this project had been put on hold pending further engagement with the NTA regarding the review of the Transport Strategy for the GDA and the transport infrastructural requirements to support new development areas in the southeast of the county. It is now anticipated that this project will recommence by the end of June.

3. Water & Drainage

Drainage and Flood Alleviation

Engineering and Environmental Consultants were appointed in Dec 2019 for Flood Risk Management works on the Deansgrange Stream. This is a 4-to-5-year project. Activities completed to date include additional survey work, CCTV surveys, a Constraints study, Hydrological analysis, and hydraulic modelling. Initial Public Consultation is now complete. Optioneering, environmental surveys and engagement with key stakeholders are underway. A Ground Investigation has commenced at key sites where alleviation measures may be practicable.

Work is now substantially complete on the Deansgrange stream advance contract, namely the Kilbogget Park Flood Storage Structure. The new screen will be taken back under the control of Drainage Operations mid June.

Engineering and Environmental Consultants have also been appointed for Flood Risk Management Works on the Carrickmines/Shanganagh Rivers. This is a 5+ year project. Data gathering is underway. A Flow/Rainfall Survey commenced on site in February and is now complete. Topographical and CCTV surveys are underway. Early damage/benefits assessments are underway to ensure a cost: beneficial scheme is achievable. It is planned to hold an initial public engagement event later in the year.

Drainage Section is working closely with the OPW as they commence the update process of the published flood maps as required by the EU Floods Directive. Hydraulic modelling of the Dundrum Slang Stream is complete. Flood maps have been completed and will be uploaded shortly by the OPW to their website.



The Monkstown environs flood risk mapping project is underway. Initial data gathering work has commenced and a topographical survey is currently being tendered.

- Engagement has recommenced with DLR architects with a view to progressing certain works as part of the 40 Foot accessibility enhancements.
- Annual weeding contract awarded to Redlough Landscapes and works commenced in May
- 40 additional smart bin installations ongoing across the county in line with additional budgetary allocation
- Temporary barrel and 1100L wheelie bins installed at coastal locations to meet challenges of increased demand on the street bin service

7. Dún Laoghaire Harbour

COVID-19 Measures

- Social Distancing reminders have been refreshed at the East and West Piers and the Marina Breakwater.
- Food vendors on the Pier and in the Battery remain open with Social Distancing measures in place.
- Solar bin handles and handrails are being regularly disinfected.

Harbour Activities:

- The Marina has restricted opening with pontoon access only.
- The Yacht Clubs have lifted their boats into the Harbour but remain largely closed due to the level 5 restrictions.
- A number of Survey Vessels have visited the Harbour in the past few weeks in connection with the proposed Wind Farms in Dublin Bay.
- Several European fishing vessels have commenced landing their catch in Dun Laoghaire Harbour for onward transport to Belgium through Rosslare, thus avoiding the UK and the customs issued due to Brexit.

Harbour Safety Patrol Boat

Following a trial over 2 weekends, it is now proposed to provide the Water Safety Patrol boat for the months of June/July and August to promote responsible behaviour and offer safety advice on the water. Mainly aimed at Kayaks and Paddleboarders, this initiative has been universally welcomed throughout the Harbour.

Filming

Filming activity is beginning to increase as the national Covid-19 restrictions reduce, and some firm bookings are now being made.

Drive-in Covid Test Centre

Randox Travel Health Care have opened a temporary drive-in COVID-19 test centre in the HSS compound on a trial basis for 3 months. The tests can be booked on-line for those requiring them for work or essential travel. The centre opened for business on Monday 22^{nd} February. Randox have agreed a further 3-month licence to 22^{nd} August.



Projects:

Berth 2 Fenders

A project to replace the Berth 2 fenders has been given approval to proceed to design / tender stage. RPS Group have been appointed to carry out the design and procurement for this project. This project is live on e-tenders with a view to confirming the actual project cost.

West Pier Survey

Malachy Walshe & Partners have been appointed to carry out a full condition survey of the West Pier and to report on the prioritisation of any repair works deemed necessary. This survey, along with an existing survey of the East Pier will dictate the most urgent infrastructure repairs required on both piers. Marine contractors have removed the marine growth form the seawalls to allow an accurate visual inspection. A dive survey inspection has completed below water level. A visual inspection above the waterline and a sample bore hole investigation in the Roundhead will be conducted in June.

St. Michaels Pier Sheet Pile Wall Survey

Doran Consulting have been appointed to carry out a full condition survey of the metal sheet pile wall that contains the infilled HSS vehicle compound area. This wall has never been surveyed previously, and the survey report will be important in determining the level of corrosion and future maintenance requirements of the wall.

Real Estate Negotiations

- The 1st Floor of Block 2, Harbour Square is vacant and advertised for lease. There has been some interest in recent weeks.
- The DMYC lease was presented to the Elected Members in February and is now awaiting signature to complete.
- Negotiations have been recommenced with the INSS on renewal of their lease, having been delayed by Covid-19

Ferry Terminal

Planning permission was granted for the ferry terminal project on the 7th February 2020. A planning appeal was lodged to An Bord Pleanála. An Bord Pleanála have now granted permission for the development.

A business briefing on the ferry terminal proposal was delivered to the elected members by Hilary Haydon on the 25th of February 2020. This matter will be brought to Area Committees and Full Council in the coming months for disposal pursuant to Section 183 of the Local Government Act 2001.

Dún Laoghaire Harbour and Town Studies

Work is underway on developing the Economic Plans for Dún Laoghaire Harbour and Dún Laoghaire Town. The Stakeholder Engagement Campaign underpins both plans that will generate new ideas for the sustainable regeneration of the Town and the Harbour. The stakeholder engagement in respect of the Harbour Plan was completed on 28th Feb 2021. Indecon consultants are now preparing a draft of the Economic Plan document.

Local Community Development Committee (LCDC)

There was an LCDC meeting held remotely on 19th May. It included a presentation on the work of Crosscare by Conor Hickey, Chief Executive, Crosscare, member of the LCDC.

CEP Grants Scheme 2021

This national grant scheme allocated €142,108 to the DLR area and was launched on the 27th of May with applications to be submitted through the DLR online grants system with a closing date of the 16th of July. This scheme is funded by the Department of Rural and Community Development.

Rural Task Force

A Rural Task Force meeting took place on the 11th May.

Joint Policing Committee

A meeting of the Joint Policing Committee took place on the 26th May on MS Teams. It included a presentation on a study commissioned by DLRCC into the assessment of need for the provision of a Domestic Violence Refuge in DLR. The JPC also approved the setting up of a new Local Policing Forum for the Dundrum and Stillorgan Area.

Age Friendly

A leaflet promoting the Age Friendly programme, Bealtaine and support services in dlr was delivered throughout the County. The leaflet was produced with funding from the Healthy Ireland/Slaintecare Community Resilience Fund and Creative Ireland.

Social Inclusion

DIr Integration Forum, supported by the Social Inclusion Unit, ran two pilot Junior Integration Fora for TY students in Oatlands College.

Africa Day took place on 25 May. A number of virtual events were organised to celebrate the day, with financial assistance provided by the Department of Foreign Affairs.

County Fora and Estate Management Programme

The first meeting of 2021 took place with representatives from each of the 12 estate management areas. Some shared learning was facilitated on the topic of biodiversity.

Annual budget has been transferred to the County Fora to support the continued operation of County Fora, including employment of an administrator to support the function of the programme.

Two benches were funded from the Estate Management budget and installed in Moreen Blackthorn Estate to support the residents with staying connected and in addition to support older people as they re-engage with being active.

Pride of Place Competition

Pride of Place is an annual competition hosted by Co-Operation Ireland. DIr has nominated two groups this year, Holly House under the category of Well-being, and Rosemount Family Resource Centre under the category of Community Resilience.

Community Development

The Community Team are continuing to support community groups and committees across the county as services begin to reopen. Funding from the Community Resilience Fund was allocated to LBS Men's Shed to purchase digital devices to support them with staying connected during restrictions. (See photo attached)



The Council supported the promotion of UCD REFOHCUS Programme and attended focused sessions. The programme aims to engage adults in STEM topics with a particular focus on Covid.

Work with a Youth Focus:

The Council are continuing to offer support to Crosscare as they engage youth at risk across the county. Grounds have been identified in Ballyogan to facilitate the development of a small allotment space.

An Interagency meeting took place in Ballyogan on 25th May attended by The Council, Crosscare, Ballyogan Family Resource Centre, Barnardos, DLR Sports Partnership, TUSLA and An Garda Siochána to ensure a cohesive response when it comes to identifying solutions to engage youth in positive activities.

The Council have continued to act in an advisory role to a similar interagency meeting in the Loughlinstown and Ballybrack area. These meetings have been attended by An Garda Siochána, LAB Project, Crosscare and Holly House with an innovative and solution focused approach.

Comhairle na nOg Steering Committee meeting held on the 25th May attended by Council Rep, DDLETB, Crosscare, PPN and Foroige.

Community Response to Covid 19:

- Helpline and email address set up and being promoted across all communication channels
- Operates 7 days a week from 9 am to 5 pm
- The Community Call Helpline has dealt with over 4,453 calls since it commenced on 30 March 2020 and issues range from shopping, pension, medical, loneliness and isolation.
- 70 calls were received in May. The majority of the calls relate to requests in relation to the HSE vaccination programme or for library books.
- The Community Response Forum is meeting every six weeks at present to support in coordinating the provision of a multi-agency response to the individuals in the community that are negatively impacted arising from the measures implemented by the Government to stem the spread of Covid 19.

Cultural Development

Arts

Municipal Gallery Programme

The exhibition **Tangled** opened on 15 May. It is curated by Michael Fortune who worked in collaboration with staff and participants from the **Southside Travellers Action Group** (STAG) in 2019 and 2020. During this period, Michael introduced the group to the work of several Irish contemporary artists; the selected artists and the themes running through this exhibition reflects his collaboration and engagement with STAG. The exhibition features the work of Ursula Burke, John Byrne, Alice Maher, Breda Mayock, John Power, Dermot Seymour and Michael Fortune. A photocall to mark the opening of the exhibition was attended by Cathaoirleach Cllr. Libraries


All dlr Library spaces re-opened to the public on **Monday 10 May**. This is part of a gradual, responsible resumption of onsite library services in line with <u>Government guidelines</u>. Services available during this phase include:

Return and borrowing of items, quick browse visits with restricted numbers in place and a return to usual staffed opening hours with late evenings and Saturday opening. Printing from home, from a personal device, or from a designated quick-use PC and use of self-service photocopiers resumed while use of Surfbox <u>postal printing service</u>, for next day delivery, and the availability of all our online services continued. The national reserves system was also re-instated during this phase as was the national delivery service for inter-county reservations.

However, as per Government guidelines for this phase, we are unable at present to provide any service which involves seating, including general seating or study spaces. We are unable at this time to provide full access to Internet PCs/laptops, or to programme live indoor events in our spaces.

Book Drop Service

Since the re-opening of library spaces, and the continuing roll-out of the national vaccination programme, the number of calls to the Book Drop Service has continued to decline. Over **1,900** calls have been received since April 2020, with almost **11,500** books delivered to the elderly and most vulnerable members or our community. The end of May saw the final deliveries to homes by our volunteers in Serve the City. Deliveries, where needed, will now continue via the dlr Library driver.

- We ran a course for coaches in Shanganagh during the early part of May. We had 12 local junior coaches, all aged between 14 and 17, complete the second practical module of their coaching course.
- Working with local clubs to ensure all appropriate documentation is in place i.e. safeguarding, Garda vetting etc. and providing online courses to facilitate this.
