#### **Business submitted by the Director of Services**

(i) **Update on Tourism Strategy –** Dave Lawless, Tourism Development Officer provided an update on tourism development in the county.

Dave outlined a number of funding opportunities, including the recently successful application for new facilities for water-based sports at Killiney Beach. An application has also been made under Fáilte Ireland's Urban Animation Investment Scheme for a potential development at Moran Park.

Dave also noted some significant opportunities for tourism in the county, including the centenary of the publication of *Ulysses* in 2022, as well as the <u>Food on the Edge Festival</u>, which will be hosted in Airfield House. John O'Toole, member of the SPC, gave further detail on the festival.

A discussion followed, during which members welcomed the developments in tourism, especially the arrival of the Food on the Edge Festival to the County.

The Chairperson encouraged members to share content on social media to promote tourism in the county, and suggested that a further update on the Festival could be provided at the September meeting.

- **(ii) Supports to Towns and Villages** Ursula O'Connor, Urban Regional Development Officer delivered a presentation on supports provided to towns and villages across the county. She gave an overview of placemaking and mobility initiatives, and also detailed the direct funding available to business organisations.

  A discussion followed, during which members' queries were answered.
- (iii) Review of the Katapult Programme Mariea Mullally, Senior Enterprise Development Officer provided an overview of the Katapult programme which was set up by DLR's Local Enterprise Office and focuses on global, scaleable companies. A discussion followed, and members' queries were answered.
