## **Plans and Policies**

#### 1. Local Economic & Community Plan (LECP)

Work is underway to progress the implementation of the Local Economic and Community Plan <u>www.dlrcoco.ie</u>. This is a key statutory plan to support and promote economic growth and enhance the quality of life and well-being of our communities in Dún Laoghaire-Rathdown.

The LECP Implementation Advisory Group will meet on March 2<sup>nd</sup> to consider the 2016 Annual Report and key actions planned for 2017. The 2016 Annual Report will then be reported to the Economic Development and Enterprise SPC at their March meeting and will then be included in the Annual Report which will be reported to Council in April.

#### 2. Tourism

A Tourism Working Group has been established to support the development of a Tourism Strategy & Marketing Plan for Dún Laoghaire-Rathdown. A number of consultation events and focus group meetings have taken place as part of the process of developing the new Tourism Strategy and Marketing Plan, including a Tourism Stakeholders consultation event took place on Feb 1<sup>st</sup> in DLRCC.

Plans for a new Tourism Information Centre and ancillary services in a Kiosk on the Metals will be displayed on boards outside the next Dun Laoghaire HEPI Meeting on 6<sup>th</sup> February 2017, as an information item, as referred to in the Management Report to January 2017 Council Meeting.

## **Plans and Policies**

## 1. Creative Ireland Programme

A cross DLR Culture team is being established to progress the Government's Creative Ireland Programme within DLR. Local Authorities have a key role to play in terms of community engagement and programming cultural activity. The primary role of the Culture Team will be to develop a Culture and Creativity Plan and drive public participation in creative cultural activity within the County. The work will also be undertaken in consultation with the Community Development, Ageing and Heritage SPC.

#### 4. Roads Control & Reinstatements Office

• On-going works by Contractor to permanently reinstate roads & footpaths as a result of water & drainage operations.

#### • Cherrywood SDZ (Strategic Development Zone)

The Roads Control Unit has been engaged in considerable consultation with Consultants & Contractors regarding the Licencing of works commenced in connection with developments at Cherrywood SDZ. This liaision will continue as work progresses and periodic inspections will be carried out in conjunction with Council's Site Representatives.

#### 5. Road Maintenance & Footpath Works – Direct Labour Workforce

- Routine maintenance works on roads are carried out by direct labour crews in response to complaints i.e pothole repair etc.

## 6. Traffic & Road Safety

#### Public Consultations

- The Commons Road Public Consultation closed 13<sup>th</sup> January 2017. There were 4 submissions The report on submissions was brought to Dún Laoghaire Area committee on the 23<sup>rd</sup> of January and was Noted.
- Review of Cycle Parking Standards for New Developments went out to non statutory public Consultation on the 5th of January 2017. Closing date February 17th, 2017 on Citizen Space. Submissions also to traffic@dlrcoco.ie. See

#### Scheme updates:

- Monkstown Village Road Safety Improvement Scheme: Tender process is completed and are being assessed. Contractor to be appointed in February
- N11/Johnstown Road Junction Improvement scheme Majority of civil works are completed. Final resurfacing is scheduled for March 2017 but may happen in February if temperatures permit.
- Cross Avenue and Environs (Dún Laoghaire) Road Safety Improvement Scheme : This scheme has been separated into two phases. The works on Cross Avenue have been merged with Desmond Avenue and works are underway. The tender for Phase 2 (all of the works outside of Cross Avenue) is completed and a contractor will commence works in February / March 2017
- Wyattville Road Cycle and Pedestrian Improvement Scheme Tender for contractor in progress
- Killiney Road / Ballinclea Road AIP Construction will be completed in early February 2017
- Commons Road Road Safety Improvement Scheme Tender for a contractor to take place in February
- Harold's Glasthule School Safety Improvement Scheme- Bollards and railings have been installed and lining renewed Raised platforms will follow at Easter 2017.
- Variable Message Signage(VMS) Project Construction work on- going on the foundations for 6 VMS signs on N11 and Frascati Road
- Cruagh Wood to Ballyogan Road Greenway Link Consultant to be appointed for design.
- St. Patrick's Park Improvements Scheme, Stepaside: Works completed.
- Dom Marmion Car Park Improvements, Dundrum: Design issued to roads marking contractor, liaising with Parking section to finalise, (line marking) works predominantly weather dependent.
- Car Club-Report on setting up a pilot car clubs brought to Dundrum and Dún Laoghaire Area committee. Parking bays currently being marked.

#### Road Safety

The new Ghost Street, Road Safety video and talk was given to 120 pupils in Woodbrook College on the 13<sup>th</sup> January 2017.

There were 15 items discussed at the Dundrum Area 2 TAG meeting held on the 24<sup>th</sup> January, 2017. There were 42 items discussed at the Dún Laoghaire Area 1 TAG meeting held on the 31<sup>st</sup> of January, 2017.

#### **Deputations**

#### 7. <u>Water Services & Drainage</u>

Dargle View Screen Upgrade works are now complete. The Old Dublin Road Screen upgrade project is now complete.

Detailed design of the Kilbogget Park Flood Storage project is underway. It is planned to progress to Part 8 Consultation in Q2 2017

Glenavon Park Flood Storage Assessment is ongoing. Flow monitors and rain gauges have been installed at the start of January and will remain in place for a minimum of a further 2 months. After that time the results can be analysed and will inform the more detailed assessment.

Cabinteely Park Flood Storage assessment study is ongoing. A draft copy of the assessment report is due in February.

Water Services continues to liaise with the Office of Public Works and provide input into the development of options in the Flood Risk Management Plans (FRMP).

Ardglas Screen upgrade and flood management modelling has been completed. Tenders are being sought for detailed design of the new screen and flood storage area..

Watsons Estate SW remedial works contract Phase I is now complete. Loreto Park minor flood storage area works are complete.

Sandyford Park Flood Storage Feasibility assessment commenced in in January 2017. An initial report is due in May.

Marlay Park Flood Storage Optimisation Study is now complete. The study confirmed that there is potential to store additional large volumes of surface water run-off from upland areas. Further studies will now be undertaken to assess potential impact on ecology and assist with a cost benefit determination.

A study commenceed in January to assess the feasibility of constructing a flood storage pond/wetland in Fernhill Park. This will be a collaborative project with Parks Section.

A study is nearing completion to assess the impact on the Carysfort Maretimo Stream of constructing the Bracken Road extension directly on top of it. If required the Bracken Road scheme design will incorporate an online attenuation tank under the road embankment. This is a collaborative project with the Infrastructure and Climate Change Department.

Watermain Removal from Old Dublin Road Culvert: Ground investigation work is underway to determine location and nature of existing services. Consulting Engineers have been appointed and a design is completed for the new watermain which will be constructed under the existing culvert. Liaison is ongoing with Irish Water. It is planned that this project will go to Tender in Q1 2017.

Tenders have been sought from Engineering Consultancies for a definitive report on coastal protection options for the cliffs at the old landfill North of Bray.

Detailed design is underway for the Corbawn Access Rehabilitation and Coastal Protection Project. Liaison is ongoing with affected landowners. It is planned to seek Tenders in Q3 2017.

Greygates SW Repair work Phase II is underway. This phase is due for completion in Q2 2017.

Johnstown Road Environs Flood Alleviation works Phase I (twin culvert removal) is complete. The Design of Phase II works (New Screen and Channel re-alignment) is complete. Tenders will be sought in February.

#### 9. DLR Events Highlights

The ice rink in the LexIcon Plaza was extended until 22 January. In excess of 11,000 people used the rink over its entire run.

#### 10. Dún Laoghaire Harbour

Following the last Council Meeting a letter issued to the Harbour Company outlining all of the issues highlighted in the due diligence report and stating that the Council's Risk Assessor would now commence work. It also stated that the Council did not intend to sign a further Non-Disclosure Agreement as it would likely result in a delay to the risk assessment. Also the omission of commercially sensitive information – while understandable from DLHC's perspective - would probably result in the production of a report not dissimilar to the due diligence which will not enable an informed decision. The Company has stated that, while they are willing to co-operate, it requires a non-disclosure agreement. A letter has issued to the Harbour Company reiterating the position regarding the NDA and seeking a meeting with officials and the Risk Assessor in a final attempt to resolve the position.

This is part of an ongoing effort to harness the power of the 'collective', in order to ensure that Co. Dublin's unique food heritage benefits from the attention it deserves. There were 43 attendees at this workshop which provided some new insights to the distribution area by showcasing different approaches to food distribution.

A Dún Laoghaire-Rathdown entrepreneur reached the National Final of Ireland's Best Young Entrepreneur Competition (IBYE). Ciara Clancy from Beats Medical in Sandyford has secured a place in the National Final of Ireland's Best Young Entrepreneur (IBYE) competition. The 26 yearold is competing in the Best Established Business category and is one of three who will represent Dublin in the National Final on March 5th. She will be competing against 23 other national finalists, to become Ireland's Best Young Entrepreneur.

#### 12.Community Development and Social Inclusion

#### Age Friendly Strategy Implementation

- Advertisements publicising the piloting of the Dún Laoghaire-Rathdown Older Persons Support Co-ordination Service in collaboration with ALONE and the Age Friendly Alliance, have been published in local newspapers and on the DLRCoCo website.
- Working in partnership with public service providers and community organisations, the support co-ordination service aims to promote independence, choice and well-being for older people living in this County, in line with Action 8.1 of the Age Friendly Strategy (AFS).
- The Garda Older Persons Association, who administers the Personal Pendant Alarm scheme, has had 130 applications approved by Pobal. To date, 126 have been installed by the approved provider, at a small cost to the older person. Significantly, the time taken to process applications has been reduced from 16 to 6 weeks, which was identified as an action in the AFS (Action 9.8).

#### <u>Comhairle na nÓg</u>

The second meeting of Comhairle na nÓg took place on 19th January 2017, where a Chairperson, Vice- Chairperson, Secretary and Public Relations Officer were elected. Meetings are being held during February to agree strategy for development of the Comhairle in 2017 and workplan.

#### Estate Management Programme

Community Development staff have met with the Estate Management County Fora and are also carrying out site visits in each of the 12 Estate Management Areas in conjunction with the local Estate Management Groups. The purpose of the site visits is to review progress to date and identify priorities for 2017. Service Plans have also been submitted and are being examined and will be considered with the relevant Council Departments as well as the Estate Management Groups in the coming weeks.

## **Finance**

Making of Rate 2017 – Advertisement placed in press on 13<sup>th</sup> of January, 2017 of intention of Council to make the rate for the year ending 31/12/2017 not earlier than 14 days from the date of the public notice.

LPT Allocation Payment 2017 – A payment of  $\in 5,595,640$  was received from the DHPC&LG on the 30/1/2017 representing the first instalment (1/6<sup>th</sup>) of the Council's 2017 LPT allocation payments.

Lansdowne Road Agreement – Following discussions between the Government in its capacity as the Public Service employer & the Public Service Committee of ICTU it was agreed to bring forward from the  $1^{st}$  September 2017 to  $1^{st}$  April 2017 the date for payment of the  $\in 1,000$  increase in annualised salaries provided for under the Lansdowne Road Agreement. The increase applies to those on annualised salaries up to  $\in 65,000$ , who are parties to the Lansdowne Road Agreement & who do not stand to benefit from the Labour Court recommendation in respect of the Garda Associations.

The Council's 2017 budget made provision for the payroll cost associated with the application of the increase from the 1<sup>st</sup> September; however the earlier application of the increase from the 1<sup>st</sup> of April will result in additional payroll costs of  $\in$ 398,552 for which no provision was made in the budget. No correspondence has been received from the DHPC&LG to date on any additional funding to Local Authorities to meet this cost

PRSI Class – Elected Members: Circular Letter L.G 02/2017 from DHPC&LG notified Local Authorities of changes to the PRSI Class that apply to representational payments made to Local Authority Elected Members as well as allowances to Cathaoirligh & Leas – Cathaoirligh of Local Authorities & Cathaoirligh of Municipal Districts. Up to 31/12/2016 the PRSI Class that applied to such payments was Class K while with effect from 1/1/2017 the PRSI Class that will apply to such payments is Class S. While the rate of charge of 4% remains unaltered certain social welfare benefits accrue under Class S not available under Class K.

## Overdraft Facility

Overdraft facility of €5.5m in place but not availed of in 2017 to date.
