3. Water & Drainage

Drainage, Flood Alleviation and Coastal Works

- Kilbogget Park Flood Storage: The Part 8 Consultation Process has concluded. A report was brought to the Sept 10th Council Meeting and received approval. It is now planned to agree phasing of project construction with the OPW.
- Glenavon Park Flood Storage/Wetlands Feasibility: The Feasibility Study has been completed and has recommended further detailed flow measurement surveys and analysis. This additional survey/analysis work is now completed. Final report received. Liaison ongoing with the OPW.
- Cabinteely Park Flood Storage Works: Hydraulic modelling work underway. Feasibility report complete. Concept/preliminary design has commenced earlier than planned. Liaison with Parks over embankment design and initial ground investigation is complete and discussions with the OPW have commenced.
- Fernhill Park Flood Storage: Hydraulic modelling work commenced in March 2017. Feasibility report complete. Parks are progressing preliminary design.
- Sandyford Park Flood Storage: Hydraulic modelling work delayed in order to expedite the Bracken Road hydraulic modelling. Feasibility report now complete. Project on hold pending direction from the OPW.
- Priorsland Flood Alleviation Update Report: Report complete. Ongoing liaison and provision of Technical Input to Cherrywood Planning Scheme Development Agency.
- Old Dublin Road Culvert. All drainage works are now complete.

- Dundrum Slang Integrated Catchment Model: Tender evaluation complete and project has been awarded. Project commenced in July 2018. Tendering for the Flow and rainfall survey completed and award letter issued.
- Carysfort Maretimo Integrated Catchment Model (Phase I) Brief preparation is complete. Tendering to commence in 2019.
- Woodbrook Landfill Coastal Protection Scheme. Project approved by Area Councillors to proceed to Part 8 Consultation - final documents awaited from Consultants. Site walkthrough with several Councillors complete. Part 8 consultation process commenced Oct 31st.
- Ballinteer Roundabout Environs Enhanced Flood Storage: Ground Investigation works complete, topographical surveys complete, CCTV surveys to start in December. Following all survey work RPS will complete modelling work and make recommendations.

Draft Flood Risk management Plans (FRMPs)

The Flood Risk management Plans were launched on 3^{rd} May 2018 and these were adapted by the Council at the Council Meeting on the 10^{th} September.

All three Flood Risk Management Plans (FRMPs) in the Dun Laoghaire Rathdown County Council area (Deansgrange/Loughlinstown/Shanganagh, Carysfort- Maretimo and Old Connaught Wilford) have been included in the Ten-Year €1 billion Programme of Investment in Flood Relief Measures with Deansgrange/Loughlinstown/Shanganagh included in the first tranche of €257 million in funding for 50 new flood relief schemes to proceed to detailed design.

The OPW have asked DLR to project manage the scheme and have agreed to fund the necessary in-house project management personnel. The first Steering Group Meeting was held in October 2018. Awaiting final approval letter from the OPW re funding and resourcing.

It is anticipated that the total number of up to 520 locations will be reinstated in 2018. Richard Nolan Civil Engineering Itd. is carrying out the reinstatement works which commenced on August 2018. Ongoing reinstatement works.

Restoration works

Roads Control Unit is involving in carrying out restoration works on roads/footpaths that have deteriorated directly as a result of Utility/Private reinstatements to complete works to the satisfaction of the Council by using 'Long Term Damage' money. The locations planned to be completed in 2018 are:

- 1. Sweetman's Avenue, SIAC Bituminous Products Ltd. to start on 10th November 2018. Fully Completed.
- 2. Cunningham Drive: Contractor Citius Ltd to start on January 2019. Ongoing negotiations with the Developer to finalize a contribution towards road reinstatements associated with the construction of 18no. New residential units as permitted under planning permission D14A/0260.
- 3. Callaghan Lane, Dun Laoghaire: A contract awarded to SIAC Bituminous Products Ltd. with all road works to be commenced early 2019.
- 4. Haigh Terrace, Waiting for the outcome of Architects Department's Tender for the proposed improvement scheme Haigh Terrace.
- 5. Eden Villas, fund contribution to the resurfacing to complete the works to the best standards, GMC Utilities Group Ltd is carrying out the works on behalf of Irish water. Ongoing reinstatement work repairs by GMC at Eden Villas and surrounding areas.

IPB Pride of Place Awards

The annual Pride of Place awards took place on 17th November in Cork City Hall. Dlr had four submissions entered into this year's award. Dun Laoghaire-Rathdown County Estate Management Fora won runners up in the Housing Estate Category.

DIr Community and Volunteer Awards 2018

An exhibition was held in County Hall, with judging for the dlr Community and Volunteer Awards. The awards ceremony will take place on 29th November. The awards ceremony is our way of recognising and celebrating the work of community groups and volunteers in dlr. This year 25 volunteers along with 51 community groups have been recognised for their valuable contributions to their communities.

Dir Comhairle na nÓg

Dir Comhairle na nÓg AGM took place on 15th November in, Stillorgan. Over 100 young people were in attendance representing over 20 secondary level schools within the County. The theme for the 2018 AGM was 'Starting the Conversation'. All those present discussed and gave feedback on the issues affecting young people and made recommendations on what the dir Comhairle could do to address concerns.

DIr Comhairle representatives attended the National Showcase in Croke Park on 22nd November. This event showcases the work of all 31 national Comhairle na nÓg for the previous year.

Local Community Development Committee

CEP Programme

The Dun Laoghaire-Rathdown Local Community Development Committee (LCDC) which includes four elected representatives of the County Council is administering funding from the Department of Rural and Community Development for the Community Enhancement Programme in dlr. Total funding of \leqslant 361,092 is available and a process is underway to allocate the funding to local community groups.

Age Friendly Programme

The 4th National Convention of Older Person's Councils took place on 8th and 9th November 2018 and was hosted by Wicklow County Council and Wicklow Older Person's Council. Over 120 people from across the 31 local authority areas participating in the Age Friendly Cities & Counties Programme attended the event. Dún Laoghaire-Rathdown County Council was represented by members of the dlr Network for Older People.

The Living Well with Dementia Consortium were provided with a demonstration of the recently installed "Magic Table" (Tovertafel) in the LexIcon Library on the 28th of November.

Joint Policing

DLR Joint Policing Committee (JPC) held its annual Public Meeting on the 20th of November at the Talbot Hotel, Stillorgan. DLR JPC is a partnership between Dún Laoghaire-Rathdown County Council, An Garda Síochána and the Community. The membership comprises of senior Garda Officers, elected Councillors and Oireachtas members, and representatives of community & voluntary groups.

Report on the dissolution of the Dun Laoghaire Harbour Company and its transfer to Dun Laoghaire Rathdown County Council

Introduction and Background

Dun Laoghaire Harbour was a state commercial company that was established under the **Harbours Act 1996** and subsequently vested on the 3rd March 1997.

The National Ports Policy was approved by Government and published by the Minister for Transport Tourism and Sport in March 2013. In that Policy, Dun Laoghaire Harbour and others were categorised as Ports of Regional significance. One of the key recommendations from that Policy was the transfer of control of the Ports of Regional Significance to the relevant local authority in this case to Dun Laoghaire Rathdown County Council.

Section 28 of the **Harbours Act 2015** provides for the

- Transfer and dissolution of the Dun Laoghaire Harbour Company
- Provision with respect to staff of the Dun Laoghaire Harbour Company
- Superannuation with respect to staff of the Dun Laoghaire Harbour Company
- Transfer of property, rights and liabilities of the Dun Laoghaire Harbour Company
- Presentation of Final Accounts within six months from date of dissolution to the Minister for Housing Planning and Local Government

In anticipation of the transfer, the Council commissioned a due diligence report on the DHCL produced in November 2016 **LHM Casey McGrath**. A summary of the findings/areas of risk identified by them are as follows:

- Ownership related issues over the title and ownership of the foreshore areas within the harbour confines and St. Michael's Pier
- Possible claw back of Government and EU Grants
- Pension Scheme Deficit
- Possible provision for legal costs in relation to outstanding legal matters including the title and ownership of the foreshore areas.

A further Report on DHCL was commissioned from the **Finance Expert** in February 2018. The risk conclusion highlighted in this Report was, that without any financial support from Central Government, the project net financial risk stands at €33,500.00.

There were three **Special Meetings** on DLHC on the

- 18th May 2015
- 6th March 2018
- 3rd October 2018

Statutory Instrument 391/2018 brought into effect the dissolution without winding up of DHCL and its transfer to Dun Laoghaire Rathdown County Council.

It was very clear to the Council that the financial implications of the dissolution and transfer would present serious challenges to the Council and its finances. Throughout the process up to the date of Statutory Instrument 391/2018 every effort was made to secure funding that would assist in the payment of works that would bring the harbour up to taking in charge standard. No funding was made available.

Comprehensive Review of DHCL and its integration with DLRCC

In anticipation of the challenges, the Council faces, a comprehensive review is now underway on all aspects of the DLHC with the principal objective of fully integrating its operations, administration and processes and aligning them with that of the Council This review is considering the following matters:

- Corporate matters such as minutes of meetings and decisions made by the former Board
- Properties and leases. A complete inventory of all real estate is underway and will be managed by the Council's Property Management
- Plant and equipment
- Contracts, agreements and commitments
- Regulatory matters
- Banking and borrowings

- Financial matters and in this regard the following issues must be reviewed and considered
- Internal and External Audit Reports
- Management Accounts
- Fixed Asset Register
- Fixed Asset valuations
- Accruals analysis
- Cash flow projections
- Analysis of income
- Taxation
- Employees and Employees benefits/Pensions
- Insurances
- Disputes and Litigation
- IT and its integration with that of DLRCC
- Health and Safety issues
- Data Protection

Section 33 - Harbours Act 2015 - Final Accounts

It is prescribed under Section 33 of the Harbours Act 2015I that the Council presents final accounts for the DHCL to the Minister for Housing Planning and Local Government within six months from the date of dissolution. Accounts prepared under this section shall be submitted by the Council for audit and a copy of the accounts as audited together with a copy of the auditor's report shall be presented to the Minister for Housing Planning and Local Government. The Minister shall cause copies of those audited accounts and report to be laid before each House of the Oireachtas. When the Council has fulfilled its obligations under Section 33 of the Harbours Act 2015 the final accounts will be presented to Council.






